- 1 A BILL for an Act to create and enact a new section to chapter 19-03.1 of the North Dakota
- 2 Century Code, relating to the prohibition of retail over-the-counter sale of certain
- 3 nonprescription drugs; to amend and reenact subsection 5 of section 19-03.1-23 of the North
- 4 Dakota Century Code, relating to equivalent offenses; and to provide a penalty.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. A new section to chapter 19-03.1 of the North Dakota Century Code is
7 created and enacted as follows:

## 8 Sale of nonprescription drug containing dextromethorphan or dimenhydrinate 9 Prohibition - Proof of age - Affirmative defense - Penalty.

- 10 A person may not deliver in any over-the-counter sale a drug, material, compound, 1. 11 mixture, preparation, or substance containing any quantity of dextrorotatory isomer 12 of 3-methoxy-n-methylmorphinan and its salts (dextromethorphan), other than its 13 racemic and levorotatory forms, or dimenhydrinate to a person under the age of 14 eighteen years. A person willfully violating this section is guilty of an infraction. 15 2. It is a prima facie case of a violation of this section if the person making the sale 16 did not require and obtain proof of age from the purchaser, unless from the
- purchaser's outward appearance the person making the sale would reasonably
   presume the purchaser to be twenty-five years of age or older. "Proof of age"
- 19 means any document issued by a governmental agency which:
- 20a.Contains a description of the person or a photograph of the person, or both,21and gives the person's date of birth; and
- 22 b. Includes a passport, military identification card, or driver's license.
- 23 <u>3.</u> It is an affirmative defense to a violation of this section if:

1		<u>a.</u>	The person making the sale required and obtained proof of age from the
2			purchaser;
3		<u>b.</u>	The purchaser falsely represented the purchaser's proof of age by use of a
4			false, forged, or altered document;
5		<u>C.</u>	The appearance of the purchaser was such that an ordinary and prudent
6			person would believe the purchaser to be at least eighteen years of age; and
7		<u>d.</u>	The sale was made in good faith and in reliance upon the appearance and
8			representation of proof of age of the purchaser.
9	SEC		<b>2. AMENDMENT.</b> Subsection 5 of section 19-03.1-23 of the North Dakota
10	Century Code is amended and reenacted as follows:		
11	5.	A vio	plation of this chapter or a law of another state or the federal government
