1 A BILL for an Act to create and enact three new subsections to section 19-03.1-01 and two new

2 sections to chapter 19-03.4 of the North Dakota Century Code, relating to the definitions, prima

3 facie proof of intent, and the retail or over-the-counter sale of methamphetamine precursor

4 drugs; to amend and reenact section 19-03.1-01 and subsection 13 of section 19-03.4-01 of the

5 North Dakota Century Code, relating to definitions used in the Uniform Controlled Substance

6 Act and the definition of drug paraphernalia; and to provide a penalty.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

8 **SECTION 1. AMENDMENT.** Section 19-03.1-01 of the North Dakota Century Code is 9 amended and reenacted as follows:

10 **19-03.1-01. Definitions.** As used in this chapter <u>and in chapters 19-03.2 and 19-03.4</u>,
11 unless the context otherwise requires:

- 12 1. "Administer" means to apply a controlled substance, whether by injection,
- inhalation, ingestion, or any other means, directly to the body of a patient orresearch subject by:
- 15 a. A practitioner or, in the practitioner's presence, by the practitioner's authorized
 16 agent; or
- b. The patient or research subject at the direction and in the presence of thepractitioner.
- "Agent" means an authorized person who acts on behalf of or at the direction of a
 manufacturer, distributor, or dispenser. It does not include a common or contract
 carrier, public warehouseman, or employee of the carrier or warehouseman.
- "Anabolic steroids" means any drug or hormonal substance, chemically and
 pharmacologically related to testosterone, other than estrogens, progestins, and
 corticosteroids.

1	4.	"Board" means the state board of pharmacy.			
2	5.	"Bureau" means the drug enforcement administration in the United States			
3		department of justice or its successor agency.			
4	6.	"Controlled substance" means a drug, substance, or immediate precursor in			
5		schedules I through V as set out in this chapter.			
6	7.	"Counterfeit substance" means a controlled substance which, or the container or			
7		labeling of which, without authorization, bears the trademark, trade name, or other			
8		identifying mark, imprint, number or device, or any likeness thereof, of a			
9		manufacturer, distributor, or dispenser other than the person who in fact			
10		manufactured, distributed, or dispensed the substance.			
11	8.	"Deliver" or "delivery" means the actual, constructive, or attempted transfer from			
12		one person to another of a controlled substance whether or not there is an agency			
13		relationship.			
14	9.	"Dispense" means to deliver a controlled substance to an ultimate user or research			
15		subject by or pursuant to the lawful order of a practitioner, including the			
16		prescribing, administering, packaging, labeling, or compounding necessary to			
17		prepare the substance for that delivery.			
18	10.	"Dispenser" means a practitioner who dispenses.			
19	11.	"Distribute" means to deliver other than by administering or dispensing a controlled			
20		substance.			
21	12.	"Distributor" means a person who distributes.			
22	13.	"Drug" means:			
23		a. Substances recognized as drugs in the official United States pharmacopeia,			
24		national formulary, or the official homeopathic pharmacopeia of the United			
25		States, or any supplement to any of them;			
26		b. Substances intended for use in the diagnosis, cure, mitigation, treatment, or			
27		prevention of disease in individuals or animals;			
28		c. Substances, other than food, intended to affect the structure or any function of			
29		the body of individuals or animals; and

1		d. Substances intended for use as a component of any article specified in
2		subdivision a, b, or c. The term does not include devices or their components,
3		parts, or accessories.
4	14.	"Hashish" means the resin extracted from any part of the plant cannabis with or
5		without its adhering plant parts, whether growing or not, and every compound,
6		manufacture, salt, derivative, mixture, or preparation of the resin.
7	15.	"Immediate precursor" means a substance:
8		a. That the board has found to be and by rule designates as being the principal
9		compound commonly used or produced primarily for use in the manufacture
10		of a controlled substance;
11		b. That is an immediate chemical intermediary used or likely to be used in the
12		manufacture of the controlled substance; and
13		c. The control of which is necessary to prevent, curtail, or limit the manufacture
14		of the controlled substance.
15	16.	"Manufacture" means the production, preparation, propagation, compounding,
16		conversion, or processing of a controlled substance, either directly or indirectly by
17		extraction from substances of natural origin, or independently by means of
18		chemical synthesis, or by a combination of extraction and chemical synthesis and
19		includes any packaging or repackaging of the substance or labeling or relabeling of
20		its container. The term does not include the preparation or compounding of a
21		controlled substance by an individual for the individual's own use or the
22		preparation, compounding, packaging, or labeling of a controlled substance:
23		a. By a practitioner as an incident to the practitioner's administering or
24		dispensing of a controlled substance in the course of the practitioner's
25		professional practice; or
26		b. By a practitioner, or by the practitioner's authorized agent under the
27		practitioner's supervision, for the purpose of, or as an incident to, research,
28		teaching, or chemical analysis and not for sale.
29	17.	"Marijuana" means all parts of the plant cannabis whether growing or not; the
30		seeds thereof; the resinous product of the combustion of the plant cannabis; and
31		every compound, manufacture, salt, derivative, mixture, or preparation of the plant

1		or its seeds. The term does not include the mature stalks of the plant, fiber		
2		produced from the stalks, oil or cake made from the seeds of the plant, any other		
3		compound, manufacture, salt, derivative, mixture, or preparation of mature stalks,		
4		fiber, oil, or cake, or the sterilized seed of the plant which is incapable of		
5		germination.		
6	18.	"Narcotic drug" means any of the following, whether produced directly or indirectly		
7		by extraction from substances of vegetable origin, or independently by means of		
8		chemical synthesis, or by a combination of extraction and chemical synthesis:		
9		a. Opium and opiate and any salt, compound, derivative, or preparation of opium		
10		or opiate.		
11		b. Any salt, compound, isomer, derivative, or preparation thereof which is		
12		chemically equivalent or identical with any of the substances referred to in		
13		subdivision a, but not including the isoquinoline alkaloids of opium.		
14		c. Opium poppy and poppy straw.		
15		d. Coca leaves and any salt, compound, derivative, or preparation of coca		
16		leaves, any salt, compound, isomer, derivative, or preparation thereof which is		
17		chemically equivalent or identical with any of these substances, but not		
18		including decocainized coca leaves or extractions of coca leaves which do not		
19		contain cocaine or ecgonine.		
20	19.	"Opiate" means any substance having an addiction-forming or addiction-sustaining		
21		liability similar to morphine or being capable of conversion into a drug having		
22		addiction-forming or addiction-sustaining liability. The term does not include,		
23		unless specifically designated as controlled under section 19-03.1-02, the		
24		dextrorotatory isomer of 3-methoxy-n-methylmorphinan and its salts		

- 25 (dextromethorphan). The term includes its racemic and levorotatory forms.
- 20. "Opium poppy" means the plant of the species papaver somniferum L., except its
 seeds.
- 28 21. "Person" means individual, corporation, limited liability company, government or
 29 governmental subdivision or agency, business trust, estate, trust, partnership or
 30 association, or any other legal entity.

1	22.	"Poppy straw" means all parts, except the seeds, of the opium poppy, after	
2		mowing.	
3	23.	"Practitioner" means:	
4		a. A physician, dentist, veterinarian, pharmacist, scientific investigator, or other	
5		person licensed, registered, or otherwise permitted by the jurisdiction in which	
6		the individual is practicing to distribute, dispense, conduct research with	
7		respect to or to administer a controlled substance in the course of	
8		professional practice or research.	
9		b. A pharmacy, hospital, or other institution licensed, registered, or otherwise	
10		permitted to distribute, dispense, conduct research with respect to or to	
11		administer a controlled substance in the course of professional practice or	
12		research in this state.	
13	24.	"Production" includes the manufacturing, planting, cultivating, growing, or	
14		harvesting of a controlled substance.	
15	25.	"State" when applied to a part of the United States includes any state, district,	
16		commonwealth, territory, insular possession thereof, and any area subject to the	
17		legal authority of the United States of America.	
18	26.	"Ultimate user" means an individual who lawfully possesses a controlled substance	
19		for the individual's own use or for the use of a member of the individual's	
20		household or for administering to an animal owned by the individual or by a	
21		member of the individual's household.	
22	SEC	CTION 2. Three new subsections to section 19-03.1-01 of the North Dakota Century	
23	Code are cr	reated and enacted as follows:	
24		"Methamphetamine precursor drug" means a drug or product containing	
25		ephedrine, pseudoephedrine, phenylpropanolamine, or any of their salts, optical	
26		isomers, or salts of optical isomers;	
77		"Over the counter cole" means a retail cole of a drug or product other these	
27 29		"Over-the-counter sale" means a retail sale of a drug or product other than a	
28		controlled, or imitation controlled, substance;	

1		"Sale" includes barter, exchange, or gift, or offer therefor, and each such	
2	transaction made by a person, whether as principal, proprietor, agent, servant, or		
3		employee;	
4	SEC	CTION 3. AMENDMENT. Subsection 13 of section 19-03.4-01 of the North Dakota	
5	Century Co	de is amended and reenacted as follows:	
6	13.	Ingredients or components to be used or intended or designed to be used in	
7		manufacturing, producing, processing, preparing, testing, or analyzing a controlled	
8		substance, whether or not otherwise lawfully obtained, including anhydrous	
9		ammonia, nonprescription medications, methamphetamine precursor drugs, or	
10		lawfully dispensed controlled substances.	
11	SEC	CTION 4. A new section to chapter 19-03.4 of the North Dakota Century Code is	
12	created and enacted as follows:		
13	Prima facie proof of intent. Possession of more than twenty-four grams of a		
14	methamphe	etamine precursor drug or combination of methamphetamine precursor drugs is	
15	prima facie	evidence of intent to violate sections 19-03.4-03 and 19-03.4-04. This subsection	
16	does not ap	oply to a practitioner as defined in subsection 23 of section 19-03.1-01 or to a	
17	product pos	ssessed in the course of a legitimate and lawful business.	
18	SEC	CTION 5. A new section to chapter 19-03.4 of the North Dakota Century Code is	
19	created and	d enacted as follows:	
20	Ret	ail or over-the-counter sale of methamphetamine precursor drugs - Penalty.	
21	<u>1.</u>	The retail sale of methamphetamine precursor drugs is limited to:	
22		a. Sales in packages containing not more than a total of three grams of one or	
23		more methamphetamine precursor drugs, calculated in terms of ephedrine	
24		base, pseudoephedrine base, and phenylpropanolamine base; and	
25		b. For nonliquid products, sales in blister packs, each blister containing not more	
26		than two dosage units, or when the use of blister packs is technically	
27		infeasible, sales in unit dose packets or pouches.	
28	<u>2.</u>	A person may not deliver in a single over-the-counter sale more than two packages	
29		of a methamphetamine precursor drug or a combination of methamphetamine	
30		precursor drugs.	

1	<u>3.</u>	A person may not deliver in an over-the-counter sale a methamphetamine
2		precursor drug to a person under the age of eighteen years.
3	<u>4.</u>	It is a prima facie case of a violation of subsection 3 if the person making the sale
4		did not require and obtain proof of age from the purchaser, unless from the
5		purchaser's outward appearance the person would reasonably presume the
6		purchaser to be twenty-five years of age or older. "Proof of age" means a
7		document issued by a governmental agency which:
8		a. Contains a description of the person or a photograph of the person, or both,
9		and gives the person's date of birth; and
10		b. Includes a passport, military identification card, or driver's license.
11	<u>5.</u>	It is an affirmative defense to a violation of subsection 3 if:
12		a. The person making the sale required and obtained proof of age from the
13		purchaser;
14		b. The purchaser falsely represented the purchaser's proof of age by use of a
15		false, forged, or altered document;
16		c. The appearance of the purchaser was such that an ordinary and prudent
17		person would believe the purchaser to be at least eighteen years of age; and
18		d. The sale was made in good faith and in reliance upon the appearance and
19		representation of proof of age of the purchaser.
20	<u>6.</u>	This section does not apply to pediatric products labeled pursuant to federal
21		regulation primarily intended for administration to children under twelve years of
22		age according to label instructions or to a product that the state board of pharmacy,
23		upon application of a manufacturer, exempts from this section because the product
24		has been formulated in such a way as to effectively prevent the conversion of the
25		active ingredient into methamphetamine, or its salts or precursors.
26	<u>7.</u>	A person who willfully violates subsection 1 is guilty of a class A misdemeanor. A
27		person who willfully violates subsection 2 or 3 is guilty of an infraction.
28	<u>8.</u>	A person who is the owner, operator, or manager of the retail outlet or who is the
29		supervisor of the employee or agent committing a violation of this section of the
30		outlet where methamphetamine precursor drugs are available for sale is not
31		subject to the penalties of this section if the person:

1	<u>a.</u>	Did not have prior knowledge of, participate in, or direct the employee or
2		agent to commit, the violation of this section; and
3	<u>b.</u>	Documents that the employee or agent, at the time of initial employment and
4		each calendar year thereafter, participated in a training program approved by
5		the attorney general providing the employee or agent with information
6		regarding the state and federal regulations governing the sale, possession,
7		and packaging of such drugs.
8	The	e approval of the training program by the attorney general is not subject to
9	<u>cha</u>	apter 28-32.
