The House convened at 1:00 p.m., with Speaker Wentz presiding.

POINT OF PERSONAL PRIVILEGE

On Sunday, March 2, the Minot State University-Bottineau Lumberjack Hockey Team won the "2003 National Junior College Athletic Association National Hockey Title" during the NJCAA Frozen Four National Tournament that was held in Morrisville, New York.

Minot State University-Bottineau of Bottineau, North Dakota; State University New York-Canton of Canton, NY; Monroe Community College of Rochester, New York; and State University of New York Morrisville of Morrisville, New York played in the national tournament.

MSU-Bottineau traveled three days and 1,650 miles by bus to play in the NJCAA Frozen Four Tournament.

In MSU-Bottineau first game, the Lumberjacks played against Monroe Community College and defeated them 5 to 4 in overtime. Lance Barton from Jamestown, North Dakota, who is ranked fourth in the nation in individual scoring, scored the overtime goal that brought the "Jacks to the national title game on Sunday.

In the title game, MSU-Bottineau faced off against SUNY-Morrisville who were ranked number one in the NJCAA and had a season record of 23-1-2.

Two Lumberjack players, Ryan Friesen and Derek McGregor were named to the All Tournament Team. Rob Hrabec was named the Most Valuable Player of the Tournament. And Bottineau's Head Coach Travis Rybchinski, was named the NJCAA Tournament Coach of the Year.
