Dept. 325 - Department of Human Services

This amendment reduces the amount of assets, other than the value of the individual's primary home, that are not considered for eligibility for the service payments for elderly and disabled (SPED) program from \$25,000 as recommended in the executive budget to \$20,000. This amendment also clarifies that these assets include both liquid and nonliquid assets.

REMARKS OF THE HONORABLE BYRON L. DORGAN, UNITED STATES SENATOR

Thank you all very much for the welcome. It's very nice to be here in this chamber once again. The Lieutenant Governor and I were on an airplane the other day. It is a profound sense of embarrassment for me and, I hope for him, that two North Dakotans were stranded in the snow in Washington, D.C. We are used to snow, but they had a couple of feet of snow and all the airports were closed--all three airports. Neither of us were able to get a plane quite when we expected to, but I am pleased to be here. The Senate is not in session this week, and I am able to be in North Dakota all week.

We face a lot of challenges in this country. I know that you face challenges in this chamber. I just listened to just a bit of this last debate, and I recognized that the process of economizing is trying to match unlimited wants with limited resources. Perhaps never is that more evident and more obvious than in the legislative process where you are trying to figure out how all of this fits.

We in Congress are facing, as the country is facing, some significant foreign policy challenges these days--North Korea, Iraq, Al-Qaida, Osama Bin Laden, terrorism. We also face very significant challenges here at home--a sluggish economy, resumption of a very large federal budget deficit, as far as the eye can see, very large trade deficits. We have an agenda that we must work on even in the midst of all of this--an energy bill, education, health care, farm legislation. All of that is important. But I want to talk to you today first about something that I

think is of utmost importance to us and something that is urgent. It represents a crisis for our state and our region.

I have watched what has been said about our state and written about our state across the country and also in foreign lands. I have seen the state written about in the Los Angeles Times and the New York Times; more recently, a London newspaper. In fact, let me quote from the London newspaper. It makes me angry and I assume that it makes you angry, but that is not the emotion of things today that we should necessarily take from all of this. This is an emotion that ought to stimulate us to do something else. First from a London newspaper in the last couple of weeks--Something remarkable is going on in North Dakota, perhaps the least-known but most troubled state in the Union. A century and a guarter after the white man colonized the place the Europeans are facing an extinction, and the ancient inhabitants may yet reclaim the land. In small and provocative towns and communities all over the state where their great-grandfathers arrived by trains and covered wagons, they are giving up and getting out--Abercrombie, Amidon, and Anamoose, Wishek, Wyndmere, and Zap. Many of these towns have lost 10 percent of their population in each decade since the 1930s, but in the 1990s that often accelerated to 20 percent and above all young people are going with regret or relief because they have no alternative. That is from the London paper. You have read these kinds of things about what is happening, not just in North Dakota but in the heartland of our country. It is North Dakota, Montana, South Dakota, Nebraska, Kansas, Wyoming. A relentless kind of depopulation of the heartland. This is a wonderful place. All of us understand that. That is why we serve here in North Dakota. It's a wonderful place with strong schools, safe streets. It's the best place in America, in my judgment, to raise a family--good neighbors with a lot to offer. But something is happening here. This article and others like it report that something is happening here and we know it. Something is happening here and it's urgent. It's a crisis. And we, above all, need to treat it as such.

I want to talk just for a moment about what the state data center says about our state, the state demographer--they make predictions and friends. They say in the year 1980 in North Dakota we had 652,000 residents. And they say in the year 2020 that we will have 651,000 residents. That means it is about stable in 40 years, 652,000 to 651,000. But they also say that during that 40 years when we have a population that remains almost unchanged, Fargo will increase in population by 60,000 citizens, Bismarck by 20,000 citizens, and Minot and Grand Forks will remain relatively the same. If you take those four cities out of the population base in the year 2020, you have 300,000 citizens left. That means of those 300,000 citizens, which represent 95 percent of the rest of North Dakota, that 300,000 population will be reduced by 80,000 in order to make up for the 80,000 that is gained by Fargo and Bismarck. That means that on an average, the counties in North Dakota will see a 25 to 35 percent change in population in 40 years. My home county is a classic example of that. My home county is Hettinger County. It is slightly larger than the state of Rhode Island. When I left, it had 5,000 citizens. Now it has 2,800 citizens. In the year 2020, it is expected to have 1,800 citizens. That is Hettinger County. In New England, North Dakota, in the western part of Hettinger County, the Lutheran minister says that she officiates at four funerals for every wedding. We are getting older. Some people are not staying. People are not having babies. People are not getting married. We know that this is happening in almost every rural area of our state. The question is, can we do something about it. It is not just us. Every county struggles and works. Our state struggles and works to do something about it. It is not just us. If you draw an eggshape in North Dakota--the middle part of the country--the middle part of America is being relentlessly depopulated a century after we populated it by giving people land. Come here, stay here, and prove the land. Build here, start a farm, we will give you some land we said. There was this great migration to populate the heartland of our country and it worked. A century and a half later it indeed is being depopulated. We can ignore it. We can be like the frog in the pan of water on a stove and wait until it is too late. But we do that at our peril it seems to me.

So the question is what? What do we do? I think that this is a problem not of our making and not just of consequence to us. When we have economic blight in America's cities, our country decided it did not want its cities to fail. Economic blight struggles with decay in America's cities and the country mobilized immediately to create urban renewal and model cities and pumped money and energy into the cities of America. America's cities are doing just fine, thank you, because our country decided it was a national priority to help rebuild and reenergize the economies in America's cities. This country, in my judgment, if it cares about the heartland, and it should, has a similar obligation to help restore economic opportunity in the heartland of this country. I believe that we can create and should create national effort to do that.

Senator Chuck Hagel and I wrote a piece of legislation. I know some of you were with Senator Hagel yesterday. He was here in Bismarck. Senator Hagel and I wrote a piece of legislation called the Homestead Economic Opportunity Act. At the end of the last session, we had 12 cosponsors, Republicans and Democrats. It's a bipartisan piece of legislation, and it's very simple but very bold. It says our population is moving from the heartland, and we want to try to create a magnet to bring it back. We do not have land to give away anymore. But what we can

do is create financial incentives. We say to people if you are living in a country with outmigration, here are incentives -- investment tax credits, venture capital, payment of student college loans, a whole series of opportunities for those who are investors. To those who stay there to work and assume jobs, to those who build businesses there, you say to people, if you stay there, if you come there, if you build there, if you become part of their future in areas that are suffering outmigration, here are substantial, bold incentives for you. That is what we did for America's cities, that is what we ought to do for the heartland of our country. I indicated to you that this is a federal initiative. We had 12 cosponsors. We expect to get 20 cosponsors, Republicans and Democrats. Senator Hagel and I are going to try very hard to get this enacted. It's a big idea. It will not happen next month. Because it is a big idea, it will take some time. But this country has a responsibility and obligation, in my judgment, to address what I think is a crisis in the heartland of our country--relentless, relentless depopulation. Again, we can ignore, but if we ignore it, we will do nothing to change it. I believe it can be altered and can be changed in a way that is beneficial to us, and those that come after us in our great state. It is called the Homestead Economic Opportunity Act. I hope you will pass a resolution supporting it, asking Congress to pass it. Nothing partisan about it - bipartisan.

Let me mention something else that I have been working on. About a year ago, I called a meeting in Fargo and I invited all of the college presidents in North Dakota to come to the meeting and invited the Governor. We had a meeting to talk about an idea that I kicked around for a while to create a research corridor here in North Dakota. One of the things that I have noticed is economic development, new industry, and new jobs congregate around where major research occurs. The largest funder of research on earth is the United States federal government. It puts major research into certain areas of this country. A bulk of the research goes to four states--California, New York, Texas, and Massachusetts. It is not an accident that when major research creates centers of excellence in areas like Harvard or Silicone Valley, that companies and jobs are created there. It has happened all across this country in certain areas where the federal government has created this research opportunity, then attracts like a magnet new industries and new jobs. We have to anchor universities in North Dakota -- North Dakota State University and the University of North Dakota. But those universities have access to opportunities from every other university in the state as well and every other college in the state. And I suggested that we use these anchor universities to create a research corridor that has tentacles to every other college in the state. A good example of that is research money that I got for NDSU dealing with food security which has now created an alliance with Dickinson State University. So we have two colleges with NDSU in the lead, with Dickinson State University benefited, from the capability to do research on food security issues, which by the way, are very important in the advent of the terrorist threat against our country. That is one example. But most of what I have been doing is through my work on defense appropriations and I have been meeting with companies that are doing research, especially defense research that has commercial application-Alien Corporation. I met with the CEO of the Alien Corporation about two and a half years ago and put research money into a piece of legislation in an appropriations bill to do microsensor research that the Defense Department wanted to do with Alien Corporation and they are doing it now in Fargo, North Dakota, at North Dakota State University. That company in California is now thinking of building a manufacturing plant to locate its manufacturing with its research. I met with the head of Tesoro Corporation, the head of Symix Corporation, Signal Corporation, and others. All of which are now doing research at North Dakota State University. Alomerst and Codings, anno technology and micro technology. We are working with technology that has circuit boards the size of a speck of pepper. Take a dime. Inside the dime is written out "DIME". Look at the space inside the little "D" and visualize that you can put 15 to 20 circuit boards inside that tiny space. Yes, each of those specks are circuit boards and they have massive applications for both our Defense Department which has initiated the research and also for commercial application. Why the Gillette Corporation has just ordered 50 million smart tags from the Alien Corporation and they are going to have to manufacture them from someplace and it is going to be our future. These little circuit bags with something called - circuit tags, rather, with something called full-self assembly, will be attached to everything in the future. Every piece of inventory in the Department of Defense will have one on it--a low-frequency identifier. Every can of pop that you get out of a pop machine is going to have one on it. Tell somebody that zaps it with some energy, here is who I am. Here was when I was bottled or here is when I was canned. Here is the pressure I am under. It is the future. It is micro anno technology, and it is here and we are building a center of excellence in North Dakota that I think will result in substantial new jobs and new opportunities. I want to mention to you that it does not increase federal spending one cent. All of this is within the budget line. We establish budget lines by function. But earmarks simply determine where it is spent, not how much is spent. We ought not to be bashful about getting our share of research. We have young men and women at our universities engaged in significant cutting edge research, rather than have them travel to Denver and Minneapolis in order to find the jobs to do the research. I have written about \$100 million in earmarked corporations for that research which I am convinced in the next 3, 5, and 10 years is going to result in a congregation of new companies and new jobs that is going to center around yes, UND and NDSU, but also other colleges that are going to be engaged in tentacles to that research.

We have a great state with a great opportunity, but we face also very great challenges. There is an urgency about what is happening in our country and our state, especially in the heartland. And there is a crisis about what is happening in North Dakota. Of all of the states I have mentioned who suffer from the relentless outmigration, none suffer as much as our state. Our state leads the pack by far and we ignore at our peril. Some want to pretend it does not exist, some want to pretend that it can be business as usual. Some want to be like Aesop's blight on an axle of a chariot observing what dust I do raise. Don't work any more. It just will not work. There has to be a partnership, in my judgment, with the federal government doing bold, aggressive things and with you doing bold, aggressive things. Doing nothing is not an option for this state's future. It just is not. I recognize you have massive challenges. I would not minimize them. You do not have the luxury of the United States Congress. We introduce a piece of legislation, we do not have the foggiest idea whether it is ever going to get a hearing. We do not have any idea whether somebody is going to bring it up at some point. You have no idea whether you will ever get to vote on it. You come here in a very short period of time. You have got to put it all together. You move a massive amount of legislation for a very short period of time. That is a big challenge. I respect that challenge, but I do want to say that as I look, and as Senator Hagel and my colleagues look, at what is happening in the heartland, it is time when we read these articles and it is time for us - all of us - to say that we are going to fight back. This is too good a place to lose. We have too much here not to make sure that we build. We can reclaim the heartland with right public policies, aggressive public policies, full public policies. Temburg once said I see America not in the setting sun of the black night of despair, he said I see America in the crimson light of the rising sun fresh from the burning creative hand of God. We must be positive. I do not mean to talk about our problems and say, we is us, we cannot solve it. Of course we can solve them. There are not Americans better prepared to solve the problem here in the heartland than those of us who live in the heartland. The bold initiatives address a crisis. Thank you very much.

SB 2285: A BILL for an Act to amend and reenact subsection 2 of section 53-06.2-11 of the North Dakota Century Code, relating to the parimutuel tax levied upon wagers.

SEN. GRINDBERG MOVED that SB 2285 be amended as follows, which motion prevailed on a voice vote.

Page 1, line 1, after "A BILL" replace the remainder of the bill with "for an Act to amend and reenact section 53-06.2-11 of the North Dakota Century Code, relating to the parimutuel tax levied upon wagers.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 53-06.2-11 of the North Dakota Century Code is amended and reenacted as follows:

53-06.2-11. Bet payoff formulas - Uses by licensee of funds in excess of expenses - Payment to general fund.

 For each day of a live race meet or a simulcast day in this state on win, place, and show parimutuel pools, the licensee shall deduct up to twenty percent of the total win, place, and show pool. The licensee may retain seventeen percent for expenses. One-half of one percent must be paid to the North Dakota racing commission to be used for the North Dakota purse fund. One-half of one percent must be paid to the North Dakota racing commission to be used for the North Dakota breeders' fund for the respective breed of horses racing at that meet. The remaining On the first five million dollars of total wagering handle in each calendar year, two percent must be paid to the state treasurer to be deposited in the general fund. On the next ninety-five million dollars of total wagering handle in each calendar year, two percent must be paid to the state treasurer to be deposited in the general fund. On the total wager handle in excess of one hundred million dollars in each calendar year, one and one-half percent must be paid to the state treasurer to be deposited in the general fund.

- 2. For each day of a live race meet or a simulcast day in this state for each daily double, quinella, exacta, trifecta, or other wager combining two or more horses for winning payoffs, the licensee shall deduct up to twenty-five percent of each wagering pool. Of this amount, the licensee may retain twenty one percent for expenses. One half Of each wagering dollar, the amounts to be deposited in the general fund and other funds are as follows:
 - a. On the first five million dollars of wagering handle in each calendar year, one-half of one percent must be paid to the commission to be deposited in the purse fund. One-half; one-half of one percent must be paid to the commission to be deposited in the promotion fund-One-half; one-half of one percent must be paid to the commission to be deposited in the breeders' fund. The remaining; and two and one-half percent must be paid to the state treasurer to be deposited in the general fund.
 - b. On the next ninety-five million dollars of wagering handle in each calendar year, one-half of one percent must be paid to the commission to be deposited in the purse fund; one-half of one percent must be paid to the commission to be deposited in the promotion fund; one-half of one percent must be paid to the commission to be deposited in the promotion to be deposited in the breeders' fund; and one percent must be paid to the state treasurer to be deposited in the general fund.
 - c. On wagering handle in excess of one hundred million dollars in each calendar year, one-third of one percent must be paid to the commission to be deposited in the purse fund; one-third of one percent must be paid to the commission to be deposited in the promotion fund; one-third of one percent must be paid to the commission to be deposited in the breeders' fund; and one percent must be paid to the state treasurer to be deposited in the general fund.
- 3. Unclaimed tickets and breakage from each live race meet and simulcast program as defined by the commission and the percentage of the wagering pool to be paid to the racing promotion fund under subsections 1 and 2 must be retained by the commission in a special fund to assist in improving and upgrading racetracks in the state, for the promotion of horse racing within the state, and in developing new racetracks in the state as necessary and approved by the commission. Notwithstanding this section, the commission may, upon approval of the attorney general, receive no more than twenty-five percent of this fund for the purpose of payment of operating expenses of the commission.
- 4. The licensee conducting a live race meet or simulcast program shall retain all other money in the parimutuel pool and pay it to bettors holding winning tickets as provided by rules adopted by the commission.
- 5. A licensee may not use any of the portion deducted for expenses under subsections 1 and 2 for expenses not directly incurred by the licensee in conducting parimutuel racing under the certificate system. After paying qualifying expenses, the licensee shall use the remainder of the amount so withheld only for eligible uses allowed to charitable gambling organizations under subsection 2 of section 53-06.1-11.
- 6. The racing commission shall deposit the moneys received pursuant to subsections 1, 2, and 3 and from the North Dakota horse racing foundation pursuant to subsection 5 of section 53-06.2-05 in three special funds in the state treasury. These funds must be known as the breeders' fund, the purse fund, and the racing promotion fund. Moneys, and any earnings on the moneys, in the breeders' fund, purse fund, and racing promotion fund

are appropriated to the commission on a continuing basis to carry out the purposes of those funds under this chapter and must be administered and disbursed in accordance with rules adopted by the commission."
