- 1 A BILL for an Act to amend and reenact sections 51-05.1-01.1 and 51-05.1-04.1 of the North
- 2 Dakota Century Code, relating to insurance requirements for auctioneers and auction clerks.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. AMENDMENT.** Section 51-05.1-01.1 of the North Dakota Century Code 5 is amended and reenacted as follows:

## 51-05.1-01.1. Auctioneer's <u>or clerk's license</u> - Fees - Bonds Insurance.

- 8 The initial application for an annual auctioneer's or clerk's license must be in 1. 9 writing, verified, and must show the name, residence, and address of the applicant. 10 An application must be filed at least ten days prior to before the first auction sale 11 the applicant is to conduct or clerk. Application for renewal of an annual license 12 must be on forms designated by the commission. The fee for the annual license or 13 renewal is thirty-five dollars and must accompany the application. The name and 14 license number must appear on all advertising of sales conducted by an auctioneer 15 or clerk. Renewals that are not received by January thirty-first must be assessed 16 an additional twenty-five dollar fee.
- 17 2. Before a license is issued to an auctioneer or auction clerk, the applicant must file 18 a corporate surety bond with the commission. This bond must provide annual 19 coverage of not less than five thousand dollars for an auctioneer or ten thousand 20 dollars for an auction clerk, must run to the state of North Dakota, and must be for 21 the benefit of any person injured by the licensee's improper conduct. Bonds may 22 not be canceled on less than sixty days' written notice to the commission. The size 23 of the licensee's bond must be clearly and prominently stated in all contracts with 24 sellers.

1	<u>3.</u>	In lieu of a bond under subsection 2, an auctioneer or auction clerk may deposit
2		with the commission evidence of the existence of public liability insurance policy
3		and an errors and omissions insurance policy covering all activities contemplated
4		under this chapter. Each policy must be with a licensed insurance carrier and be in
5		the amount of at least one hundred thousand dollars per occurrence and five
6		hundred thousand dollars annual aggregate limit. A policy may not be canceled on
7		less than sixty days written notice to the commission.
8	SECTION 2. AMENDMENT. Section 51-05.1-04.1 of the North Dakota Century Code	
9	is amended and reenacted as follows:	
10	51-05.1-04.1. Written contracts. An auctioneer may not sell the property of another at	
11	auction with	nout a prior written contract with the seller which sets forth the terms and conditions
12	upon which the auctioneer will sell the property. A similar contract governing the activities of	
13	the auction clerk is required between the auction clerk and the seller. The licensee must retain	
14	a copy of each contract for at least two years after the auction. This section does not apply to	
15	consignment sales where the value of the seller's property is less than five hundred dollars or to	
16	livestock markets. The contract must contain:	
17	1.	The licensee's name, trade or business name, state license number, business
18		address, and business telephone number.
19	2.	A general description of the property to be sold at auction, any restrictions, and a
20		statement identifying whether or not the licensee is authorized to purchase at the
21		auction.

- A description of the services to be provided and the consideration for the services.
   The description must state which party is responsible for advertising and other
   expenses.
- 25 4. The date or dates when the items will be sold at auction.
- 26 5. A disclosure of the amount of bond that the licensee has on file with the
  27 commission and the commission's address and phone number or the amount of
  28 public liability and errors and omissions coverage and the name of the insurer.
