- 1 A BILL for an Act to amend and reenact section 54-10-14 of the North Dakota Century Code,
- 2 relating to audits of political subdivisions; and to repeal section 54-10-13 of the North Dakota
- 3 Century Code, relating to audits of political subdivisions by the state auditor.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 SECTION 1. AMENDMENT. Section 54-10-14 of the North Dakota Century Code is
- 6 amended and reenacted as follows:
 - 54-10-14. Political subdivisions Audits Fees Alternative audits and reports.
- 8 The state auditor shall audit Each of the following political subdivisions shall submit to an audit

9 once every two years, except as provided in this section or otherwise by law:

- 10 1. Counties.
- 11 2. Cities.

6	The state auditor shall charge the political subdivision an amount equal to the fair value		
7	of the audit and any other services rendered. The political subdivision audited shall pay to the		
8	state treasurer the fees for the audit performed by the state auditor. The state treasurer shall		
9	deposit the fees in the state auditor operating account. The state treasurer shall credit the state		
10	auditor operating account with the amount of interest earnings attributable to the deposits in		
11	that account. Expenses relating to political subdivision audits must be paid from the state		
12	auditor operating account, within the limits of legislative appropriation.		
13	In lieu of conducting an audit every two years, the state auditor may require annual		
14	reports from school districts with less than one hundred enrolled students, cities with less than		

14 ents, cities with less than 15 three hundred population, park districts with less than two hundred thousand dollars of annual 16 receipts, and other political subdivisions subject to this section, or otherwise provided by law, 17 with less than one hundred thousand dollars of annual receipts. The reports must contain the 18 financial information required by the state auditor. The state auditor also may make any 19 additional examination or audit determined necessary in addition to the annual report. When a 20 report is not filed, the state auditor may charge the political subdivision an amount equal to the 21 fair value of the additional examination or audit and any other services rendered. The state 22 auditor may charge a political subdivision a fee not to exceed fifty dollars an hour for the costs 23 of reviewing the annual report.

24 A political subdivision, at the option of its governing body, may must be audited by a 25 certified public accountant or licensed public accountant rather than by the state auditor. The 26 public accountant shall comply with generally accepted government auditing standards for 27 audits of political subdivisions. The report must be in the form and content required by the state 28 auditor. The number of copies of the audit report requested by the state auditor must be filed 29 with the state auditor when the public accountant delivers the audit report to the political 30 subdivision. The state auditor shall review the audit report to determine if the report is in the required form and has the required content, and if the audit meets generally accepted 31

1 government auditing standards. The state auditor also may periodically review the public 2 accountant's workpapers to determine if the audit meets generally accepted government 3 auditing standards. If the report is in the required form and has the required content, and the 4 report and workpapers comply with generally accepted government auditing standards, the 5 state auditor shall accept the audit report. The state auditor may charge the political subdivision a fee of up to fifty dollars an hour, but not to exceed five hundred dollars per review, 6 7 for the related costs of reviewing the audit report and workpapers. 8 A political subdivision may not pay a public accountant for an audit until the state auditor has accepted the audit. However, a political subdivision may make progress payments to the 9 10 public accountant. A political subdivision shall retain twenty percent of any progress payment

11 until the audit report is accepted by the state auditor.

12 The state auditor may require the correction of any irregularities, objectionable

13 accounting procedures, or illegal actions on the part of the governing board, officers, or

14 employees of the political subdivision disclosed by the audit report or workpapers, and failure to

15 make the corrections shall result in audits being resumed by the state auditor until the

16 irregularities, objectionable accounting procedures, or illegal actions are corrected.

17 SECTION 2. REPEAL. Section 54-10-13 of the North Dakota Century Code is

18 repealed.
