## HOUSE BILL NO. 1070

Introduced by

(At the request of the Commission on Uniform State Laws)

1 A BILL for an Act to create and enact a new subsection to section 41-09-29 of the North Dakota  
2 Century Code, relating to perfection of security interests; and to amend and reenact  
3 subdivision e of subsection 1 of section 41-09-02, subdivision vv of subsection 1 of section  
4 41-09-02, and subdivision a of subsection 2 of section 41-09-24 of the North Dakota Century  
5 Code, relating to definitions and the jurisdiction of banks.

### 6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. AMENDMENT.** Subdivision e of subsection 1 of section 41-09-02 of the  
8 North Dakota Century Code is amended and reenacted as follows:

9 e. "Agricultural lien" means an interest, ~~other than a security interest~~, in farm  
10 products:

11 (1) That secures payment or performance of an obligation for:

12 (a) Goods or services furnished in connection with a debtor's farming  
13 operation or in connection with processing, production, or  
14 entrustment of the farm products; or

15 (b) Rent on real property leased by a debtor in connection with the  
16 debtor's farming operation;

17 (2) That is created by statute in favor of a person that:

18 (a) Finished goods or services in connection with processing,  
19 production, or entrustment of the farm product or in the ordinary  
20 course of that person's business furnished goods or services to a  
21 debtor in connection with a debtor's farming operation; or

22 (b) Leased real property to a debtor in connection with the debtor's  
23 farming operation; and

- (3) Of which the effectiveness does not depend on the person's possession  
of the personal property.

**SECTION 2. AMENDMENT.** Subdivision vv of subsection 1 of section 41-09-02 of the  
North Dakota Century Code is amended and reenacted as follows:

- vv. "Health care insurance receivable" means an interest in or claim under a  
policy of insurance which is a right to payment of a monetary obligation for  
health care goods or services provided or to be provided.

**SECTION 3. AMENDMENT.** Subdivision a of subsection 2 of section 41-09-24 of the  
North Dakota Century Code is amended and reenacted as follows:

- a. If an agreement between the bank and ~~the debtor~~ its customer governing the  
deposit account or certificate of deposit expressly provides that a particular  
jurisdiction is the bank's jurisdiction for purposes of this part, this chapter, or  
this title, that jurisdiction is the bank's jurisdiction.

**SECTION 4.** A new subsection to section 41-09-29 of the North Dakota Century Code  
is created and enacted as follows:

- A sale by an individual of an account that is a right to payment of winnings in a  
lottery or other game of chance.
