- 1 A BILL for an Act to adopt the Uniform Athlete Agents Act, relating to the regulation of athlete
- 2 agents; to repeal chapter 9-15 of the North Dakota Century Code, relating to the regulation of
- 3 athlete agents; and to provide a penalty.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. Definitions.** In this Act, unless the context otherwise requires:
 - "Agency contract" means an agreement in which a student-athlete authorizes a
 person to negotiate or solicit on behalf of the student-athlete a professional sports
 services contract or an endorsement contract.
 - 2. "Athlete agent" means an individual who enters an agency contract with a student-athlete or recruits or solicits a student-athlete to enter an agency contract. The term includes an individual who represents to the public that the individual is an athlete agent. The term does not include a spouse, parent, sibling, grandparent, or guardian of the student-athlete or an individual acting solely on behalf of a professional sports team or professional sports organization.
 - 3. "Athletic director" means an individual responsible for administering the overall athletic program of an educational institution or, if an educational institution has separately administered athletic programs for male students and female students, the athletic program for males or the athletic program for females, as appropriate.
 - 4. "Contact" means a communication between an athlete agent and a student-athlete to recruit or solicit the student-athlete to enter an agency contract.
 - 5. "Endorsement contract" means an agreement under which a student-athlete is employed or receives consideration to use on behalf of the other party any value that the student-athlete may have because of publicity, reputation, following, or fame obtained because of athletic ability or performance.

- "Intercollegiate sport" means a sport played at the collegiate level for which
 eligibility requirements for participation by a student-athlete are established by a
 national association for the promotion or regulation of collegiate athletics.
 - 7. "Professional sports services contract" means an agreement under which an individual is employed or agrees to render services as a player on a professional sports team, with a professional sports organization, or as a professional athlete.
 - 8. "Record" means information that is inscribed on a tangle medium or that is stored in an electronic or other medium and is retrievable in perceivable form.
 - 9. "Registration" means registration as an athlete agent under this Act.
 - 10. "Student-athlete" means an individual who engages in, is eligible to engage in, or may be eligible in the future to engage in, any intercollegiate sport. If an individual is permanently ineligible to participate in a particular intercollegiate sport, the individual is not a student-athlete for purposes of that sport.

SECTION 2. Service of process - Subpoenas. By acting as an athlete agent in this state, a nonresident individual appoints the secretary of state as the individual's agent for service of process in any civil action in this state related to the individual's acting as an athlete agent in this state. The secretary of state may issue subpoenas for any material that is relevant to the administration of this Act.

SECTION 3. Athlete agents - Registration Required - Void contracts.

- Except as otherwise provided in subsection 2, an individual may not act as an athlete agent without holding a certificate of registration.
- 2. Before being issued a certificate of registration, an individual may act as an athlete agent for all purposes except signing an agency contract, if a student-athlete or another person acting on behalf of the student-athlete initiates communication with the individual and within seven days after an initial act as an athlete agent, the individual submits an application for registration as an athlete agent.
- 3. An agency contract resulting from conduct in violation of this section is void and the athlete agent shall return any consideration received under the contract.

SECTION 4. Registration as athlete agent.

1. An applicant for registration shall submit an application for registration to the secretary of state in a form prescribed by the secretary of state. The application

21		(2) With respect to a corporation employing the athlete agent, the officers,
22		directors, and any shareholder of the corporation having an interest of
23		five percent or greater.
24	h.	Whether the applicant or any person named under subdivision g has been
25		convicted of a crime that, if committed in this state, would be a crime involving
26		moral turpitude or a felony, and identify the crime.
27	i.	Whether there has been any administrative or judicial determination that the
28		applicant or any person named under subdivision g has made a false,
29		misleading, deceptive, or fraudulent representation.
30	j.	Any instance in which the conduct of the applicant or any person named
31		under subdivision g resulted in the imposition of a sanction, suspension, or

1 declaration of ineligibility to participate in an interscholastic or intercollegiate 2 athletic event on a student-athlete or educational institution. 3 k. Any sanction, suspension, or disciplinary action taken against the applicant or 4 any person named under subdivision g arising out of occupational or 5 professional conduct. 6 I. Whether there has been any denial of an application for, suspension or 7 revocation of, or refusal to renew, the registration or licensure of the applicant 8 or any person named under subdivision q as an athlete agent in any state. 9 An individual who has submitted an application for, and holds a certificate of, 10 registration or licensure as an athlete agent in another state may submit a copy of 11 the application and certificate in lieu of submitting an application in the form 12 prescribed under subsection 1. The secretary of state shall accept the application 13 and the certificate from the other state as an application for registration if the 14 application to the other state: 15 Was submitted in the other state within six months preceding the submission 16 of the application in this state and the applicant certifies that the information 17 contained in the application is current; 18 b. Contains information substantially similar to or more comprehensive than that 19 required in an application submitted in this state; and 20 Was signed by the applicant under penalty of perjury. 21 SECTION 5. Certificate of registration - Issuance or denial - Renewal. 22 1. Except as otherwise provided in subsection 2, the secretary of state shall issue a 23 certificate of registration to an individual who complies with subsection 1 of 24 section 4 of this Act whose application has been accepted under subsection 2 of 25 section 4 of this Act. 26 2. The secretary of state may refuse to issue a certificate of registration if the 27 secretary of state determines that the applicant has engaged in conduct that has a 28 significant adverse effect on the applicant's fitness to act as an athlete agent. In 29 making the determination, the secretary of state may consider whether the 30 applicant has:

1 Been convicted of a crime that, if committed in this state, would be a crime a. 2 involving moral turpitude or a felony; 3 Made a materially false, misleading, deceptive, or fraudulent representation in b. 4 the application or as an athlete agent; 5 Engaged in conduct that would disqualify the applicant from serving in a C. 6 fiduciary capacity; 7 d. Engaged in conduct prohibited by section 13 of this Act; 8 Had a registration or licensure as an athlete agent suspended, revoked, or 9 denied or been refused renewal of registration or licensure as an athlete 10 agent in any state; 11 f. Engaged in conduct the consequence of which was that a sanction, 12 suspension, or declaration of ineligibility to participate in an interscholastic or 13 intercollegiate athletic event was imposed on a student-athlete or educational 14 institution; or Engaged in conduct that significantly adversely reflects on the applicant's 15 g. 16 credibility, honesty, or integrity. 17 3. In making a determination under subsection 2, the secretary of state shall consider 18 how recently the conduct occurred, the nature of the conduct and the context in 19 which it occurred, and any other relevant conduct of the applicant. 20 4. An athlete agent may apply to renew a registration by submitting an application for 21 renewal in a form prescribed by the secretary of state. The application for renewal 22 must be signed by the applicant under penalty of perjury and must contain current 23 information on all matters required in an original registration. 24 5. An individual who has submitted an application for renewal of registration or 25 licensure in another state, in lieu of submitting an application for renewal in the 26 form prescribed under subsection 4, may file a copy of the application for renewal 27 and a valid certificate of registration or licensure from the other state. The 28 secretary of state shall accept the application for renewal from the other state as 29 an application for renewal in this state if the application to the other state:

28	1.	With	nin seventy-two hours after entering an agency contract or before the next

31		cont	tract to the athletic director of the educational institution at which the

1 student-athlete is enrolled or the athlete agent has reasonable grounds to believe 2 the student-athlete intends to enroll. 3 2. Within seventy-two hours after entering an agency contract or before the next 4 athletic event in which the student-athlete may participate, whichever occurs first, 5 the student-athlete shall inform the athletic director of the educational institution at 6 which the student-athlete is enrolled that the student-athlete has entered an 7 agency contract. 8 **SECTION 11. Student-athlete's right to cancel.** A student-athlete may cancel an 9 agency contract by giving notice of the cancellation to the athlete agent in a record within 10 fourteen days after the contract is signed. A student-athlete may not waive the right to cancel 11 an agency contract. If a student-athlete cancels an agency contract, the student-athlete is not 12 required to pay any consideration under the contract or to return any consideration received 13 from the athlete agent to induce the student-athlete to enter into the contract. 14 **SECTION 12.** Required records. 15 An athlete agent shall retain the following records for a period of five years: 16 The name and address of each individual represented by the athlete agent; a. 17 b. Any agency contract entered by the athlete agent; and 18 C. Any direct costs incurred by the athlete agent in the recruitment or solicitation 19 of a student-athlete to enter an agency contract. 20 2. Records required by subsection 1 to be retained are open to inspection by the 21 secretary of state during normal business hours. 22 **SECTION 13. Prohibited conduct.** 23 An athlete agent, with the intent to induce a student-athlete to enter an agency 24 contract, may not: 25 Give any materially false or misleading information or make a materially false 26 promise or representation; 27 b. Furnish anything of value to a student-athlete before the student-athlete 28 enters the agency contract; or 29 Furnish anything of value to any individual other than the student-athlete or C. 30 another registered athlete agent. 31 2. An athlete agent may not intentionally:

1 Initiate contact with a student-athlete unless registered under this Act; a. 2 b. Refuse or fail to retain or permit inspection of the records required to be 3 retained by section 12 of this Act; 4 C. Fail to register when required by section 3 of this Act; 5 d. Provide materially false or misleading information in an application for 6 registration or renewal of registration; 7 Predate or postdate an agency contract; or e. 8 f. Fail to notify a student-athlete before the student-athlete signs or otherwise 9 authenticates an agency contract for a particular sport that the signing or 10 authentication may make the student-athlete ineligible to participate as a 11 student-athlete in that sport. 12 **SECTION 14. Penalty.** An athlete agent who violates section 13 of this Act is guilty of 13 a class A misdemeanor. 14 SECTION 15. Civil remedies. 15 An educational institution has a cause of action against an athlete agent or a 16 former student-athlete for damages caused by a violation of this Act. In an action 17 under this section, the court may award to the prevailing party costs and 18 reasonable attorney's fees. 19 2. Damages of an educational institution under subsection 1 including losses and 20 expense incurred because, as a result of the conduct of an athlete agent or former 21 student-athlete, the educational institution was injured by a violation of this Act or 22 was penalized, disqualified, or suspended from participation in athletics by a 23 national association for the promotion and regulation of athletics, by an athletic 24 conference, or by reasonable self-imposed disciplinary action taken to mitigate 25 sanctions likely to be imposed by such an organization. 26 3. A cause of action under this section does not accrue until the educational 27 institution discovers or by the exercise of reasonable diligence would have 28 discovered the violation by the athlete agent or former student-athlete.

- 3 **SECTION 16.** Administrative penalty. The secretary of state may asses a civil
- 4 penalty against an athlete agent not to exceed twenty-five thousand dollars for a violation of this
- 5 Act.
- 6 **SECTION 17. REPEAL.** Chapter 9-15 of the North Dakota Century Code is repealed.
