1 A BILL for an Act to create and enact a new subsection to section 39-06.1-05 and a new

2 paragraph to subdivision b of subsection 3 of section 39-06.1-10 of the North Dakota Century

3 Code, relating to offenses exempted from administrative proceedings and demerit points; to

4 amend and reenact sections 39-06.1-09 and 39-10-26 of the North Dakota Century Code,

5 relating to yielding to an emergency vehicle; and to provide a penalty.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 7 SECTION 1. A new subsection to section 39-06.1-05 of the North Dakota Century
- 8 Code is created and enacted as follows:

Causing an accident with an authorized emergency vehicle in violation of

SECTION 2. AMENDMENT. Section 39-06.1-09 of the North Dakota Century Code is
amended and reenacted as follows:

13 **39-06.1-09.** Moving violation defined. For the purposes of sections 39-06.1-06 and

14 39-06.1-13, a "moving violation" means a violation of section 39-04-22; subsection 1 of section

15 39-04-37; section 39-04-55; 39-06-01; 39-06-14; 39-06-16; 39-09-04.1; 39-09-09; 39-12-04;

16 39-12-05; 39-12-06; 39-12-09; 39-24-02; or 39-24-09, except subdivisions b and c of

17 subsection 5, or equivalent ordinances; or a violation of the provisions of chapter 39-10,

18 39-10.2, or 39-21, or equivalent ordinances, except subsection 4 of section 39-10-26, sections

19 39-21-44 and 39-21-45.1, and subdivision b of subsection 1 and subsection 2 of section

20 39-21-46, and those sections within those chapters which are specifically listed in subsection 1

21 of section 39-06.1-08.

SECTION 3. A new paragraph to subdivision b of subsection 3 of section 39-06.1-10 of
the North Dakota Century Code is created and enacted as follows:

- 6 SECTION 4. Section 39-10-26 of the North Dakota Century Code is amended and 7 reenacted as follows:

8 39-10-26. Operation of vehicle on approach of authorized emergency vehicle -Penalty.

- 10 1. Upon the immediate approach of an authorized emergency vehicle displaying a 11 visible flashing, revolving, or rotating blue, white, or red light, the driver of every 12 other vehicle shall yield the right of way and shall immediately drive to a position 13 parallel to, and as close as possible to, the right-hand edge or curb of the roadway 14 clear of any intersection and shall stop and remain in that position until the authorized emergency vehicle has passed, except when otherwise directed by a 15 16 police officer.
- 17 2. If an authorized emergency vehicle is parked or stopped at the scene of an 18 emergency and is displaying a flashing, revolving, or rotating blue, white, or red 19 light, approaching traffic shall move to the right-hand edge or curb of the roadway 20 and shall stop, but once having stopped, traffic may proceed past the scene at its 21 own risk when the roadway is clear, except when otherwise directed by a police 22 officer. If an authorized emergency vehicle is otherwise parked or stopped on a 23 multilane highway outside the limits of a city unless the highway is part of the 24 interstate system, and the authorized emergency vehicle is displaying a flashing, 25 revolving, or rotating amber, blue, white, or red light, the driver of an approaching 26 vehicle shall proceed with caution and yield the right of way by moving to a lane 27 that is not adjacent to the authorized emergency vehicle if the move may be made 28 with due regard to safety and traffic conditions or if not, the driver shall proceed 29 with due caution, reduce the speed of the vehicle, and maintain a safe speed for 30 the road conditions.
