- 1 A BILL for an Act to create and enact chapter 50-32 of the North Dakota Century Code, relating
- 2 to licensing of assisted living facilities; to amend and reenact subsection 8 of section 23-09-01,
- 3 and sections, 50-24.5-01 and 50-24.5-02 of the North Dakota Century Code, relating to assisted
- 4 living facilities; to repeal section 50-24.5-02.1 of the North Dakota Century Code, relating to
- 5 registration of assisted living facilities; and provide a penalty.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Subsection 8 of section 23-09-01 of the North Dakota
 Century Code is amended and reenacted as follows:
 - 8. "Lodging establishment" includes every building or structure, or any part thereof, which is kept, used, maintained, or held out to the public as a place where sleeping accommodations are furnished for pay to four or more transient guests. The term does not include a facility providing personal care services directly or through contract services as defined in section 23-09.3-01 or 50-24.5-01 50-32-01.
 - **SECTION 2. AMENDMENT.** Section 50-24.5-01 of the North Dakota Century Code is amended and reenacted as follows:
- 16 **50-24.5-01. Definitions.** In this chapter, unless the context otherwise requires:
 - "Activities of daily living" means bathing, dressing, toileting, transferring, eating, bed mobility, medication management, and personal hygiene.
 - 2. "Aged" means at least sixty-five years of age.
- 20 3. "Assisted living facility" means any building or structure containing a series of living
 21 units operated as one business entity to provide services for five or more
 22 individuals who are aged or disabled adults and who are not related by blood or
 23 marriage to the owner or manager of the entity and which is kept, used,
 24 maintained, advertised, or held out to the public as a place that makes available

1 individualized support services to accommodate an individual's needs and abilities 2 to maintain as much independence as possible. It does not include a facility that is 3 licensed as a basic care facility or a congregate housing facility. 4. <u>2.</u> 4 "Blind" has the same meaning as the term has when used by the social security 5 administration in the supplemental security income program under title XVI of the 6 Social Security Act [42 U.S.C. 1381 et seg.]. 7 5. <u>3.</u> "Congregate housing" means housing shared by two or more individuals not 8 related to each other which is not provided in an institution. 9 "County agency" means the county social service board. 6. 4. 10 "Department" means the department of human services. 7. <u>5.</u> 11 8. 6. "Disabled" has the same meaning as the term has when used by the social 12 security administration in the supplemental security income program under title XVI 13 of the Social Security Act [42 U.S.C. 1381 et seq.]. 14 "Eligible beneficiary" means a resident of this state who: 9. 7. (1) 15 a. Is aged; or 16 (2)Is at least eighteen years of age and is disabled or blind; 17 Has applied for and is eligible to receive benefits under title XIX of the Social b. 18 Security Act [42 U.S.C. 1396 et seq.], provided that an individual who was 19 eligible to receive benefits under title XVI of the Social Security Act [42 U.S.C. 20 1381 et seg.] and who was receiving benefits under title XVI before 21 January 1, 1995, is not ineligible because that individual is not eligible to 22 receive benefits under title XIX; 23 Based on a functional assessment, is not severely impaired in any of the C. 24 activities of daily living of toileting, transferring to or from a bed or chair, or 25 eating and: 26 (1) Has health, welfare, or safety needs, including a need for supervision or 27 a structured environment, which require care in a licensed adult family 28 foster care home or an assisted living facility; or 29 (2) Is impaired in three of the following four instrumental activities of daily 30 living: preparing meals, doing housework, taking medicine, and doing 31 laundry; and

1 d. Is determined to be eligible pursuant to rules adopted by the department. 2 10. "Individualized support services" means services designed to provide assistance to 3 adults who may have physical or cognitive impairments and who require at least a 4 moderate level of assistance with one or more activities of daily living. 5 11. <u>8.</u> "Institution" means an establishment that makes available some treatment or 6 services beyond food or shelter to five or more individuals who are not related to 7 the proprietor. 8 12. "Instrumental activities of daily living" means activities to support independent 9 living including housekeeping, shopping, laundry, transportation, and meal 10 preparation. 11 13. <u>9.</u> "Living independently" includes living in congregate housing. The term does not 12 include living in an institution. 13 14. "Living unit" means a portion of an assisted living facility occupied as the living 14 quarters of an individual who has entered into a lease agreement with the assisted 15 living facility. 16 15. 10. "Proprietor" means an individual responsible for day-to-day administration and 17 management of a facility. 18 16. <u>11.</u> "Qualified service provider" means a county agency or independent contractor who 19 agrees to meet standards for services and operations established by the 20 department. 21 17. "Related by blood or marriage to the owner or manager" means an individual who 22 is a spouse or former spouse of the owner or manager or is a parent, stepparent, 23 grandparent, stepgrandparent, child, stepchild, grandchild, stepgrandchild, brother, 24 sister, half-brother, half-sister, stepbrother, or stepsister of the owner or manager 25 or the owner or manager's spouse or former spouse. 26 18. 12. "Related to the proprietor" means an individual who is a proprietor's spouse or 27 former spouse, or a parent, stepparent, grandparent, stepgrandparent, child, 28 stepchild, grandchild, stepgrandchild, brother, sister, half-brother, half-sister, 29 stepbrother, or stepsister of a proprietor or proprietor's spouse or former spouse.

- 1 49. 13. "Remedial care" means services that produce the maximum reduction of an eligible
 2 beneficiary's physical or mental disability and the restoration of an eligible
 3 beneficiary to the beneficiary's best possible functional level.
 4 20. "Tenant" means an adult individual who has entered into a lease agreement with
 5 an assisted living facility.
 - 21. 14. "Would be eligible to receive the cash benefits except for income" refers to an individual whose countable income, less the cost of necessary remedial care that may be provided under this chapter, does not exceed an amount equal to the cash benefit under title XVI of the Social Security Act [42 U.S.C. 1381 et seq.] which the individual would receive if the individual had no income, plus sixty dollars.
 - **SECTION 3. AMENDMENT.** Section 50-24.5-02 of the North Dakota Century Code is amended and reenacted as follows:

13 **50-24.5-02. Powers and duties of the department.** The department shall:

- Administer aid to vulnerable aged, blind, and disabled persons and supervise and direct county agencies in the administration of aid to vulnerable aged, blind, and disabled persons.
- Supplement, within the limits of legislative appropriation, the income of an eligible beneficiary receiving necessary adult family foster care services to the extent that the eligible beneficiary lacks income sufficient to meet the cost of that care provided at rates determined by the department.
- 3. Supplement, within the limits of legislative appropriation, the income of an eligible beneficiary receiving necessary basic care services to the extent that the eligible beneficiary lacks income sufficient to meet the cost of that care, provided at rates determined by the department.
- 4. Pay qualified service providers at rates determined by the department, within the limits of legislative appropriation, for the provision of the following services provided to an eligible beneficiary to the extent that the eligible beneficiary lacks income sufficient to meet the cost of these services:
- a. Homemaker services;
- 30 b. Chore services;
- 31 c. Respite care;

1 d. Home health aide services: 2 e. Case management; 3 f. Family home care; 4 g. Personal attendant care; 5 h. Adult family foster care; 6 i. Adaptive assessment; and 7 į. Other services the department determines to be essential and appropriate to 8 sustain an individual in the individual's home and community and to delay or 9 prevent institutional care. 10 5. Establish, maintain, and ensure the enforcement of standards for congregate 11 housing as may be appropriate to the needs of the residents of congregate housing 12 who are receiving services under this chapter. The standards must govern matters 13 such as admission policy, safety, sanitation, and protection of civil rights. 14 Establish an individualized care rate for each eligible beneficiary receiving adult 6. 15 family foster care services or assisted living services. 16 7. Issue payment to basic facilities and adult family foster care facilities for services 17 provided to an eligible beneficiary. 18 8. Take action and give directions necessary to implement this chapter. 19 9. Establish a method to receive complaints related to assisted living facilities and to 20 forward the complaints to the appropriate agency for investigation. 21 **SECTION 4.** Chapter 50-32 of the North Dakota Century Code is created and enacted 22 as follows: 23 **50-32-01. Definitions.** In this chapter, unless the context otherwise requires: 24 "Assisted living facility" means a building or structure containing a series of living 25 units operated as one entity to provide services for five or more individuals who are 26 not related by blood, marriage, or guardianship to the owner or manager of the 27 entity and which is kept, used, maintained, advertised, or held out to the public as a 28 place that provides or coordinates individualized support services to accommodate 29 the individual's needs and abilities to maintain as much independence as possible. 30 An assisted living facility does not include a facility that is a congregate housing

facility, licensed as a basic care facility, or licensed under chapter. 23-16.

- 1 2. "Department" means the department of human services
- 3. "Entity" means an individual, institution, organization, limited liability company, or
 corporation, whether or not organized for profit.
 - 4. "Individualized support services" means services provided to individuals who may require assistance with the activities of daily living of bathing, dressing, toileting, transferring, eating, medication management, and personal hygiene.
 - 5. "Living unit" means a portion of an assisted living facility occupied as the living quarters of an individual who has entered into a lease agreement with the assisted living facility.
 - 6. "Related by blood or marriage to the owner or manager" means an individual who is a spouse or former spouse of the owner or manager or is a parent, stepparent, grandparent, stepgrandparent, child, stepchild, grandchild, stepgrandchild, brother, sister, half-brother, half-sister, stepbrother, or stepsister of the owner or manager or the owner or manager's spouse or former spouse.

50-32-02. Licensing of assisted living facilities - Penalty.

- 1. An entity may not keep, operate, conduct, manage, or maintain an assisted living facility or use the term "assisted living" in its advertising unless it is licensed by the department.
- 2. An assisted living facility shall pay to the department an annual license fee of seventy-five dollars for each facility. License fees collected under this section must be deposited in the department's operating fund in the state treasury. An expenditure from the fund is subject to appropriation by the legislative assembly.
- 3. An assisted living facility shall apply annually to the department for a license. After the fifty-ninth day following the notification of noncompliance with annual licensing, the department may assess a fine of up to fifty dollars per day against an entity that provides assisted living services or uses the term assisted living in its marketing without a license approved by the department. Fines collected under this section must be deposited in the department's operating fund in the state treasury. An expenditure from the fund is subject to appropriation by the legislative assembly.
- 4. Religious orders providing individualized support services to vowed members residing in the order's retirement housing are not subject to this chapter.

9	For purposes of this section, health services means services provided to an individual for the	
10	purpose of preventing disease and promoting, maintaining, or restoring health or minimizing the	
11	effects of illness or disability.

13	repealed.
