1 A BILL for an Act to provide an appropriation for defraying the expenses of the information 2 technology department, the judicial branch, and the legislative council; to authorize the 3 industrial commission to issue and sell evidences of indebtedness for connectND; to provide for 4 the purchase of information technology equipment and software; to provide for the transfer of 5 state agency information technology employees; to provide for reports to the budget section; to 6 provide for a legislative council study; to create and enact a new section to chapter 54-10, a 7 new section to chapter 54-35, two new sections to chapter 54-59, and a new subsection to 8 section 54-59-05 of the North Dakota Century Code, relating to information technology 9 responsibilities of the state auditor, information technology committee responsibilities, 10 information technology services, and information technology department powers and duties; to 11 amend and reenact sections 54-59-02, 54-59-05, and 54-59-09 of the North Dakota Century 12 Code, relating to responsibilities of the information technology department and information 13 technology standards; to repeal section 54-59-13 of the North Dakota Century Code, relating to 14 information technology reviews; to provide an effective date; and to declare an emergency.

### 15 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

16 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the 17 funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from other income, to the 18 19 information technology department for the purpose of defraying the expenses of the information 20 technology department, for the biennium beginning July 1, 2003, and ending June 30, 2005, as 21 follows: ~ ~ . **\*\***

13 SECTION 2. ESTIMATED INCOME - SPECIAL FUNDS TRANSFERS. The estimated 14 income line item in section 1 of this Act includes \$862,059 from the special funds of various 15 state agencies resulting from information technology reductions, for the biennium beginning 16 July 1, 2003, and ending June 30, 2005. Notwithstanding any other provisions of law, the office 17 of management and budget shall transfer to the information technology department the 18 following amounts available from the special funds of the agencies listed, for the biennium 19 beginning July 1, 2003, and ending June 30, 2005. 20 AGENCY AMOUNT 21 \$11,108 State department of health

SECTION 3. APPROPRIATION AUTHORITY - REDUCTIONS. The office of management and budget shall reduce the special funds appropriation authority for the aeronautics commission, the department of financial institutions, the insurance commissioner, and the seed department, for the biennium beginning July 1, 2003, and ending June 30, 2005, by the amounts listed in section 2 of this Act relating to information technology reductions. The amounts will be available in the special funds for transfer as provided in section 2 of this Act.

# 17 SECTION 4. BOND ISSUANCE AUTHORIZATION - PURPOSES - APPROPRIATION.

18 The industrial commission, acting as the North Dakota building authority, shall arrange through 19 the issuance of evidences of indebtedness under chapter 54-17.2 from the effective date of this 20 Act and ending June 30, 2005, for the funding in an amount not to exceed \$20,000,000 to be 21 loaned to the information technology department for the purchase or lease of computer 22 hardware and software and for the costs of the implementation services for the enterprise 23 resource planning system commonly known as the connectND project. ConnectND is declared 24 to be in the public interest and is, for the purpose of this Act, a project as that term is defined in 25 chapter 54-17.2. The amount of the evidences of indebtedness may be reduced by any 26 moneys made available from the higher education institutions. The proceeds of the evidences 27 of indebtedness and other available funds, as appropriated in section 1 of this Act, may be used 28 for connectND project costs, debt service repayment, and refunding of connectND interim 29 borrowings. The industrial commission shall issue evidences of indebtedness under this 30 section with the condition that repayment on the evidences of indebtedness need not begin until 31 July 1, 2005. For purposes of this Act, loan or debt service repayments are equivalent to lease

1 rental payments as that term is used in chapter 54-17.2. ConnectND student fee revenues and

2 other available funds are appropriated to the North Dakota university system for the North

3 Dakota university system's share of the connectND project costs, debt service repayment,

4 refunding of connectND interim borrowings, and other costs incidental to connectND

5 implementation.

6 The authority of the industrial commission to issue evidences of indebtedness under this 7 section ends June 30, 2005, but the industrial commission may continue to exercise all other 8 powers granted to it under chapter 54-17.2 and this Act and comply with any covenants entered 9 into before that date.

The limitation provided in section 54-17.2-23 does not apply to repayments allocable to
the evidences of indebtedness issued for the connectND project.

## SECTION 5. EVIDENCES OF INDEBTEDNESS ISSUANCE REPAYMENT

13 **RESPONSIBILITY.** Debt service on the evidences of indebtedness issued under section 4 of 14 this Act must be available from charges made and collected by the information technology 15 department from users of the system with twenty-nine percent of the debt service being the 16 responsibility of state agencies and seventy-one percent of the debt service being the 17 responsibility of higher education.

18 SECTION 6. APPROPRIATION. There is appropriated out of any moneys in the 19 general fund in the state treasury, not otherwise appropriated, the sum of \$45,999, or so much 20 of the sum as may be necessary, to the judicial branch for the purpose of defraying costs 21 associated with information technology, for the biennium beginning July 1, 2003, and ending 22 June 30, 2005.

23 SECTION 7. PURCHASE OF INFORMATION TECHNOLOGY EQUIPMENT AND 24 SOFTWARE - REPORTS TO THE INFORMATION TECHNOLOGY COMMITTEE. After 25 receiving input from executive branch state agencies, departments, and institutions, the 26 information technology department shall establish information technology equipment and 27 software product specifications and shall provide the product specifications to the office of 28 management and budget to be used for procuring equipment and software as provided for in 29 chapter 54-44.4. The office of management and budget, after receiving advice from the 30 information technology department, shall establish policies and guidelines for the purchase of 31 information technology equipment and software and related accountability reporting. All

1 executive branch state agencies, departments, and institutions, excluding institutions under 2 control of the state board of higher education, shall comply with the policies and guidelines 3 unless exempted by the office of management and budget. The office of management and 4 budget, in conjunction with the information technology department, shall aggregate information 5 technology equipment and software purchases and administer contracts to achieve the most 6 cost-effective results for the state. The information technology department shall provide 7 periodic reports to the information technology committee regarding budgeted and actual 8 information technology equipment and software purchases and estimated savings by funding 9 source.

10 SECTION 8. TRANSFER OF APPROPRIATION AUTHORITY BETWEEN LINE

ITEMS. Notwithstanding section 54-16-04, the director of the office of management and budget and the state treasurer shall make transfers of funds between line items for state agencies, departments, and institutions as may be requested to accommodate information technology funding reductions made by the fifty-eighth legislative assembly. The office of management and budget shall report to the budget section regularly on transfers made pursuant to this section.

SECTION 9. TRANSFERS. Notwithstanding section 54-16-04, the director of the office
of management and budget shall make transfers of funds between line items of appropriations
in section 1 of this Act for the information technology department as may be requested by the
chief information officer.

# 21SECTION 10. TRANSFER OF STATE AGENCY INFORMATION TECHNOLOGY22EMPLOYEE POSITIONS - CONSOLIDATION OF INFORMATION TECHNOLOGY

FUNCTIONS. On November 1, 2003, the following number of authorized full-time equivalent employee positions relating to information technology services, including electronic mail, file and print server administration, data base administration, storage, and application server and hosting services must be reduced and transferred from the named agencies to the information technology department, except as otherwise provided under this section or unless exempted by the chief information officer:

After consultation with the information technology department, each affected agency shall identify the specific positions for reduction and transfer. An agency may retain any of the identified positions providing that funding for the position is available from internal savings of the agency. The agency shall conduct any reduction-in-force analysis that may be required. Each agency shall limit its consideration to information technology related positions and shall identify for reduction and transfer those positions most closely associated with services assumed centrally by the information technology department.

21 The information technology department shall determine the number of full-time 22 equivalent positions necessary to provide the related information technology functions to state 23 agencies. The department is authorized to employ the number of necessary employees and 24 require all persons interested in filling the employee positions to apply with the department. In 25 filling the employee positions, the department shall give preference to current state employees 26 working in information technology. The department may make arrangements with the agency 27 from which an employee was transferred to transfer any leave accrued by that employee. 28 In furtherance of the consolidation of information technology functions under this 29 section, the supreme court and the attorney general shall continue to collaborate with the 30 information technology department to implement the criminal justice information sharing

31 program.

## 1 SECTION 11. INFORMATION TECHNOLOGY FUNCTION CONSOLIDATION -

2 ACCUMULATED SAVINGS - TRANSFER TO THE GENERAL FUND. The office of

3 management and budget and the information technology department shall achieve efficiencies 4 during the biennium beginning July 1, 2003, and ending June 30, 2005, relating to the required 5 consolidation of information technology functions, including electronic mail, file and print server administration, data base administration, storage, and application server and hosting services. 6 7 Notwithstanding the provisions of section 10 of this Act, the office of management and budget in 8 conjunction with the information technology department, may exercise full discretion in 9 achieving efficiencies and cost-savings expected from the proposed consolidation of 10 information technology services, including any such modifications deemed advisable. The 11 office of management and budget and the information technology department through 12 efficiencies resulting from this consolidation shall achieve accumulated net savings totaling 13 \$1,400,000 for the 2003-05 biennium. The director of the office of management and budget 14 shall transfer the savings accumulated as a result of these efficiencies in the amount of 15 \$1,400,000 to the general fund by June 30, 2005.

SECTION 12. INFORMATION TECHNOLOGY SERVICE - REPORTS TO THE 16 17 **INFORMATION TECHNOLOGY COMMITTEE AND THE BUDGET SECTION.** The information 18 technology department shall document information relating to the delivery of the consolidated 19 services to agencies, including service dependability, agency complaints, and information 20 technology department responsiveness, and shall report that information and the status of the 21 accumulated savings to the information technology committee and the budget section as 22 requested. Any agency receiving consolidated services may provide information to the 23 information technology committee with respect to service availability, service dependability, 24 complaints of the agency or of persons receiving services from the agency or the department. 25 department responsiveness, and any additional costs incurred by the agency as a result of the 26 consolidated services.

SECTION 13. INFORMATION TECHNOLOGY LEGISLATIVE COUNCIL STUDY APPROPRIATION - REPORTS TO THE BUDGET SECTION. There is appropriated out of any
 moneys in the general fund in the state treasury, not otherwise appropriated, the sum of
 \$350,000, or so much of the sum as may be necessary, to the legislative council for the
 biennium beginning July 1, 2003, and ending June 30, 2005, for the purpose of contracting with

3 Required use of electronic mail, file and print server administration, data base 4 administration, and application server and hosting services. Each state agency and 5 institution, excluding the legislative and judicial branches, the institutions under the control of 6 the state board of higher education, the public employees retirement system, the retirement and 7 investment office, the attorney general, and any entity exempted by the office of management 8 and budget after advisement by the information technology department, shall obtain electronic 9 mail, file and print server administration, data base administration, storage, and application 10 server and hosting services through a delivery system established by the office of management 11 and budget in conjunction with the information technology department. The office of 12 management and budget, after receiving advice from the information technology department, 13 shall establish policies and guidelines for the delivery of services, including the transition from 14 existing systems to centralized systems, with consideration given to the creation of efficiencies 15 and cost-savings. 16 SECTION 17. AMENDMENT. Section 54-59-02 of the North Dakota Century Code is 17 amended and reenacted as follows: 18 54-59-02. Information technology department - Responsibility - Public policy.

19 The information technology department is established with the responsibility for all wide area 20 network services planning, selection, and implementation for all state agencies, including 21 institutions under the control of the board of higher education, counties, cities, and school 22 districts in this state. With respect to a county, city, or school district, wide area network 23 services are those services necessary to transmit voice, data, or video outside the county, city, 24 or school district. In exercising its powers and duties, the department is responsible for 25 computer support services, host software development, statewide communications services, 26 standards for providing information to other state agencies and the public through the internet, 27 technology planning, process redesign, and quality assurance. The department may not 28 exercise its powers and duties in a manner that competes or otherwise interferes with the 29 provision of telecommunications services to private, charitable, or nonprofit entities by privately

30 or cooperatively owned telecommunications companies.

- SECTION 18. A new subsection to section 54-59-05 of the North Dakota Century Code
   is created and enacted as follows:
- 3 May provide wide area network services to a state agency, city, county, school 4 district, or other political subdivision of this state. The information technology 5 department may not provide wide area network service to any private, charitable, 6 or nonprofit entity except the information technology department may continue to 7 provide the wide area network service the department provided to the private, 8 charitable, and nonprofit entities receiving services from the department on 9 January 1, 2003. The department shall file with the state auditor before 10 September 1, 2003, a description of the wide area network service the department 11 provided to each private, charitable, and nonprofit entity receiving services from the 12 department on January 1, 2003. 13 SECTION 19. AMENDMENT. Section 54-59-05 of the North Dakota Century Code is 14 amended and reenacted as follows: 15 54-59-05. Powers and duties of department. The department: 16 Shall provide, supervise, and regulate information technology of all executive 1. 17 branch state entities, excluding the institutions under the control of the board of 18 higher education. 19 2. Shall provide network services in a way that ensures the network requirements of a 20 single entity do not adversely affect the functionality of the whole network, 21 facilitates open communications with the citizens of the state, minimizes the state's 22 investment in human resources, accommodates an ever-increasing amount of 23 traffic, supports rapid detection and resolution of problems, protects the network 24 infrastructure from damage and security breaches, provides for the aggregation of 25 data, voice, video, and multimedia into a statewide transport mechanism or 26 backbone, and provides for the network support for the entity to carry out its 27 mission. 28 May review and approve additional network services that are not provided by the 3. 29 department. 30 4. May purchase, finance the purchase, or lease equipment or software or replace, 31 including by trade or resale, equipment or software as may be necessary to carry

1 out this chapter. An agreement to finance the purchase of software, equipment, or 2 implementation services may not exceed a period of three years. The department 3 shall submit any intended financing proposal for the purchase of software, 4 equipment, or implementation services under this subsection, which is in excess of 5 one million dollars, to the budget section of the legislative council before executing 6 a financing agreement. If the budget section does not approve the execution of a 7 financing agreement, the department may not proceed with the proposed financing 8 arrangement. The department may finance the purchase of software, equipment, 9 or implementation services only to the extent the purchase amount does not 10 exceed the amount appropriated to the department during that biennium for 11 equipment.

12 <u>5.</u> Each executive branch agency or institution, except excluding the institutions 13 under the control of the board of higher education, shall submit to the department, 14 in accordance with guidelines established by the department, a written request for 15 the lease, purchase, or other contractual acquisition of information technology. 16 The department shall review requests for conformance with the requesting entity's 17 information technology plan and compliance with statewide policies and standards. 18 If the request is not in conformance or compliance, the department may disapprove 19 the request or require justification for the departure from the plan or statewide 20 policy or standard.

- 5. <u>6.</u> Shall provide information technology, including assistance and advisory service, to
   the executive, legislative, and judicial branches. If the department is unable to
   fulfill a request for service from the legislative or judicial branch, the information
   technology may be procured by the legislative or judicial branch within the limits of
   legislative appropriations.
- 6. <u>7.</u> May Shall request information on or review information technology, applications,
   system development projects, and application development projects of executive
   branch agencies.
- 29 7. 8. Shall study emerging technology and evaluate its impact on the state's system of
   30 information technology.

9 SECTION 20. AMENDMENT. Section 54-59-09 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 54-59-09. Information technology standards. Based on information from state 12 agencies and institutions, the department shall develop statewide information technology 13 policies, standards, and guidelines. The policies, standards, and guidelines must recognize the 14 uniqueness of certain agencies and state which agencies are included or exempted from the 15 policies, standards, and guidelines. The policies, standards, and guidelines must be approved 16 by the state information technology advisory committee. Unless an exemption is granted by the 17 department chief information officer, each executive branch state agency and institution, 18 excluding the institutions under the control of the board of higher education with respect to 19 academic and research uses of information technology, shall comply with the policies and 20 standards developed by the department. Unless an exemption is granted by the department 21 chief information officer, each entity receiving wide area network services provided by the 22 department shall comply with the policies and standards developed by the department with 23 respect to access to or use of wide area network services. 24 SECTION 21. REPEAL. Section 54-59-13 of the North Dakota Century Code is

25 repealed.

SECTION 22. EFFECTIVE DATE. This Act becomes effective on July 1, 2003.
 SECTION 23. EMERGENCY. The enterprise resource planning system line item in
 section 1 of this Act and all of sections 4, 5, and 13 of this Act are declared to be an emergency
 measure.
