- 1 A BILL for an Act to provide an appropriation for state employee compensation increases; to
- 2 provide for retroactive application; and to declare an emergency.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION - STATE EMPLOYEE COMPENSATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated and from special funds derived from federal funds or other income as indicated to the agencies and institutions of state government for the period beginning with the effective date of this Act and ending June 30, 2005. The purpose of the appropriation is to provide compensation adjustments to employees of the various agencies and institutions in accordance with sections 2 and 3 of this Act.

23 SECTION 2. LEGISLATIVE INTENT - 2004 STATE EMPLOYEE COMPENSATION

- 24 ADJUSTMENTS GUIDELINES RETROACTIVE APPLICATION. It is the intent of the
- 25 fifty-ninth legislative assembly that fiscal year 2004 compensation adjustments for permanent
- 26 employees are to be an increase of one percent effective retroactively to the month of January
- 27 2004.
- An employee must have been employed by the agency on January 1, 2004, and on the effective date of this Act in order to be eligible for the increase.
- 30 An employee whose documented performance levels do not meet standards is not 31 eligible for the increase.

1	A probationary employee on the retroactive effective date is not entitled to the increase.
2	However, a probationary employee may be given all or a portion of the increase upon
3	completion of probation, at the discretion of the appointing authority.
4	During the biennium, no salary increase other than those authorized by this Act may be
5	given to an employee whose salary exceeds or would exceed the salary range maximum.
6	SECTION 3. LEGISLATIVE INTENT - 2005 STATE EMPLOYEE COMPENSATION
7	ADJUSTMENTS - GUIDELINES - RETROACTIVE APPLICATION. It is the intent of the
8	fifty-ninth legislative assembly that fiscal year 2005 compensation adjustments for permanent
9	employees are to be an increase of two percent effective retroactively to the month of January
10	2005.
11	An employee must have been employed by the agency on January 1, 2005, and on the
12	effective date of this Act in order to be eligible for the increase.
13	An employee whose documented performance levels do not meet standards is not
14	eligible for the increase.
15	A probationary employee on the retroactive effective date is not entitled to the increase.
16	However, a probationary employee may be given all or a portion of the increase upon
17	completion of probation, at the discretion of the appointing authority.
18	During the biennium, no salary increase other than those authorized by this Act may be
19	given to an employee whose salary exceeds or would exceed the salary range maximum.
20	SECTION 4. EMERGENCY. This Act is declared to be an emergency measure.
