Introduced by

1 A BILL for an Act to create and enact chapter 57-39.7 of the North Dakota Century Code,  
2 relating to a lodging gross receipts tax; to amend and reenact subsection 2 of section  
3 11-09.1-05, subsection 16 of section 40-05.1-06, section 57-39.2-01, subdivision h of  
4 subsection 1 of section 57-39.2-02.1, subdivision d of subsection 2 of section 57-39.2-04.1,  
5 subsection 8 of section 57-39.4-16, section 57-40.2-01, subsection 2 of section 57-40.2-02.1,  
6 section 57-40.2-04, and section 57-40.2-04.1 of the North Dakota Century Code, relating to  
7 sales and use tax amendments to conform with the provisions of the Streamline Sales Tax Act;  
8 to repeal subsection 33 of section 57-39.2-04 and sections 57-39.2-03.8 and 57-40.2-03.2 of  
9 the North Dakota Century Code, relating to eliminations of provisions in conflict with the  
10 Streamline Sales Tax Act; and to provide an effective date and an expiration date.

11 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

12 **SECTION 1. AMENDMENT.** Subsection 2 of section 11-09.1-05 of the North Dakota  
13 Century Code as effective after December 31, 2005, is amended and reenacted as follows:

14 2. Control its finances and fiscal affairs; appropriate money for its purposes, and  
15 make payments of its debts and expenses; subject to the limitations of this section  
16 levy and collect property taxes, sales and use taxes, motor vehicle fuels and  
17 special fuels taxes, motor vehicle registration fees, and special assessments for  
18 benefits conferred, for its public and proprietary functions, activities, operations,  
19 undertakings, and improvements; contract debts, borrow money, issue bonds,  
20 warrants, and other evidences of indebtedness; establish charges for any county or  
21 other services to the extent authorized by state law, and establish debt and mill  
22 levy limitations; provided, that all property in order to be subject to the assessment  
23 provisions of this subsection must be assessed in a uniform manner as prescribed  
24 by the state board of equalization and the state supervisor of assessments. A

1 charter or ordinance or act of a governing body of a home rule county may not  
2 supersede any state law that determines what property or acts are subject to, or  
3 exempt from, ad valorem taxes. A charter or ordinance or act of the governing  
4 body of a home rule county may not supersede section 11-11-55.1 relating to the  
5 sixty percent petition requirement for improvements and of section 40-22-18  
6 relating to the barring proceeding for improvement projects. After December 31,  
7 2005, sales and use taxes levied under this chapter:

- 8 a. Must conform in all respects with regard to the taxable or exempt status of  
9 items under chapters 57-39.2 and 57-40.2 and may not be imposed at  
10 multiple rates with the exception of sales of electricity, piped natural or  
11 artificial gas, or other heating fuels delivered by the seller or the retail sale or  
12 transfer of motor vehicles, aircraft, watercraft, modular homes, manufactured  
13 homes, or mobile homes.
- 14 b. May not be newly imposed or changed except to be effective on the first day  
15 of a calendar quarterly period after a minimum of ninety days notice to the tax  
16 commissioner or, for purchases from printed catalogs, on the first day of a  
17 calendar quarter after a minimum of one hundred twenty days notice to the  
18 seller.
- 19 c. May not be limited to apply to less than the full value of the transaction or item  
20 as determined for state sales and use tax purposes.
- 21 d. Must be subject to collection by the tax commissioner under an agreement  
22 under section 57-01-02.1.

23 **SECTION 2. AMENDMENT.** Subsection 16 of section 40-05.1-06 of the North Dakota  
24 Century Code as effective after December 31, 2005, is amended and reenacted as follows:

- 25 16. To impose registration fees on motor vehicles, or sales and use taxes in addition to  
26 any other taxes imposed by law. After December 31, 2005, sales and use taxes  
27 levied under this chapter:
  - 28 a. Must conform in all respects with regard to the taxable or exempt status of
  - 29 items under chapters 57-39.2 and 57-40.2 and may not be imposed at
  - 30 multiple rates with the exception of sales of electricity, piped natural or
  - 31 artificial gas, or other heating fuels delivered by the seller or the retail sale or

transfer of motor vehicles, aircraft, watercraft, modular homes, manufactured homes, or mobile homes.

- b. May not be newly imposed or changed except to be effective on the first day of a calendar quarterly period after a minimum of ninety days notice to the tax commissioner or, for purchases from printed catalogs, on the first day of a calendar quarter after a minimum of one hundred twenty days notice to the seller.
- c. May not be limited to apply to less than the full value of the transaction or item as determined for state sales and use tax purposes.
- d. Must be subject to collection by the tax commissioner under an agreement under section 57-01-02.1.

It is the intention of this chapter to grant and confirm to the people of all cities coming within its provisions the full right of self-government in both local and city matters within the powers enumerated herein. The statutes of the state of North Dakota, so far as applicable, shall continue to apply to home rule cities, except insofar as superseded by the charters of such cities or by ordinance passed pursuant to such charters. After December 31, 2005, any portion of a charter or any portion of an ordinance passed pursuant to a charter that does not conform to the requirements of subsection 16 is valid to the extent that it does not conform. The invalidity of a portion of a charter or ordinance because it does not conform to subsection 16 shall not affect the validity of any other portion of such charter or ordinance. Any local sales taxes on farm machinery, farm irrigation equipment and farm machinery repair parts used exclusively for agricultural purposes or any local sales taxes on alcoholic beverages that were in effect before December 31, 2005, shall become a gross receipts tax after December 31, 2005. Any gross receipts tax must conform in all respects with regard to the taxable or exempt status of items under chapter 57-39.4 and 57-39.6.

**SECTION 3. AMENDMENT.** Section 57-39.2-01 of the North Dakota Century Code is amended and reenacted as follows:

**57-39.2-01. (Effective through December 31, 2005) Definitions.** The following words, terms, and phrases, when used in this chapter, have the meaning ascribed to them in this section, unless the context clearly indicates a different meaning:

1. "Business" includes any activity engaged in by any person or caused to be engaged in by the person with the object of gain, benefit or advantage, either direct or indirect.
2. "Commissioner" means the tax commissioner of the state of North Dakota.
3. "Gross receipts" means the total amount of sales of retailers, valued in money, whether received in money or otherwise. Provided, discounts for any purposes allowed and taken on sales are not included, nor is the sale price of property returned by customers when the full sale price is refunded either in cash or by credit. Provided, further, when tangible personal property is taken in trade or in a series of trades as a credit or part payment of a retail sale taxable under this chapter, if the tangible personal property traded in will be subject to the sales tax imposed by this chapter when sold, will be subject to the motor vehicle excise tax imposed by chapter 57-40.3, or if the tangible personal property traded in is used farm machinery or used irrigation equipment, the credit or trade-in value allowed by the retailer are not gross receipts. Provided, further, on all sales of retailers, valued in money, when the sales are made under a conditional sales contract, or under other forms of sale wherein the payment of the principal sum is to be extended over a period longer than sixty days from the date of sale that only the portion of the sale amount shall be accounted for, for the purpose of imposition of tax imposed by this chapter, as has actually been received in cash by the retailer during each quarterly period as defined herein. When a farm machine is purchased as a replacement for machinery which was stolen or totally destroyed, a credit or trade-in credit is allowed in an amount equal to the compensation received for the loss from an insurance company. The purchaser shall provide the seller with a notarized statement from the insurance company verifying that the original farm machine is a total loss and indicating the amount of compensation. The notarized statement must be retained by the seller to verify the amount of credit or trade-in credit allowed. "Gross receipts" also means, with respect to the leasing or renting of tangible personal property, the amount of consideration, valued in money, whether received in money or otherwise, received from the leasing or renting of only tangible personal property the transfer of title to which has not been

1           subjected to a retail sales tax in this state. For the purpose of this chapter, gross  
2           receipts shall also include the total amount of sales of every clerk, auctioneer,  
3           agent, or factor selling tangible personal property owned by any other retailer.

4           4. "Local governmental unit" means incorporated cities, counties, school districts, and  
5           townships.

6           5. "Person" includes any individual, firm, partnership, joint venture, association,  
7           corporation, limited liability company, estate, business trust, receiver, or any other  
8           group or combination acting as a unit and the plural as well as the singular number.

9           6. "Relief agency" means the state, any county, city and county, city or district  
10          thereof, or an agency engaged in actual relief work.

11          7. "Retail sale" or "sale at retail" means the sale, including the leasing or renting, to a  
12          consumer or to any person for any purpose, other than for processing or for resale,  
13          of tangible personal property; the sale of steam, gas, and communication service to  
14          retail consumers or users; the sale of vulcanizing, recapping, and retreading  
15          services for tires; the furnishing of bingo cards; the ordering, selecting, or aiding a  
16          customer to select any goods, wares, or merchandise from any price list or catalog,  
17          which the customer might order, or be ordered for such customer to be shipped  
18          directly to such customer; the sale or furnishing of hotel, motel, or tourist court  
19          accommodations, tickets, or admissions to any place of amusement, athletic event,  
20          or place of entertainment including the playing of any machine for amusement or  
21          entertainment in response to the use of a coin; and the sales of magazines and  
22          other periodicals. By the term "processing" is meant any tangible personal  
23          property including containers which it is intended, by means of fabrication,  
24          compounding, manufacturing, producing, or germination shall become an integral  
25          or an ingredient or component part of other tangible personal property intended to  
26          be sold ultimately at retail. The sale of an item of tangible personal property for the  
27          purpose of incorporating it in or attaching it to real property must be considered as  
28          a sale of tangible personal property for a purpose other than for processing; the  
29          delivery of possession within the state of North Dakota of tangible personal  
30          property by a wholesaler or distributor to an out-of-state retailer who does not hold  
31          a North Dakota retail sales tax permit or to a person who by contract incorporates

1 such tangible personal property into, or attaches it to, real property situated in  
2 another state may not be considered a taxable sale if such delivery of possession  
3 would not be treated as a taxable sale in that state. As used in this subsection, the  
4 word "consumer" includes any hospital, infirmary, sanatorium, nursing home, home  
5 for the aged, or similar institution that furnishes services to any patient or occupant.  
6 The sale of an item of tangible personal property to a purchaser who rents or  
7 leases it to a person under a finance leasing agreement over the term of which the  
8 property will be substantially consumed must be considered a retail sale if the  
9 purchaser elects to treat it as such by paying or causing the transferor to pay the  
10 sales tax thereon to the commissioner on or before the last day on which payments  
11 may be made without penalty as provided in section 57-39.2-12.

- 12 8. "Retailer" includes every person engaged in the business of leasing or renting  
13 hotel, motel, or tourist court accommodations, and every person engaged in the  
14 business of selling tangible goods, wares, or merchandise at retail, or furnishing of  
15 steam, gas, and communication services, or tickets or admissions to places of  
16 amusement, entertainment, and athletic events including the playing of any  
17 machine for amusement or entertainment in response to the use of a coin, or  
18 magazines, or other periodicals; any organization licensed by the attorney general  
19 to conduct bingo games pursuant to section 53-06.1-03; and includes any person  
20 as herein defined who by contract or otherwise agrees to furnish for a  
21 consideration a totally or partially finished product consisting in whole or in part of  
22 tangible personal property subject to the sales tax herein provided, and all items of  
23 tangible personal property entering into the performance of such contract as a  
24 component part of the product agreed to be furnished under said contract shall be  
25 subject to the sales tax herein provided and the sales tax thereon shall be collected  
26 by the contractor from the person for whom the contract has been performed in  
27 addition to the contract price agreed upon, and shall be remitted to the state in the  
28 manner provided in this chapter; and shall include the state or any municipality  
29 furnishing steam, gas, or communication service to members of the public in its  
30 proprietary capacity. For the purpose of this chapter, retailer shall also include  
31 every clerk, auctioneer, agent, or factor selling tangible personal property owned

by any other retailer. A retailer also includes every person who engages in regular or systematic solicitation of a consumer market in this state by the distribution of catalogs, periodicals, advertising flyers, or other advertising, or by means of print, radio or television media, by mail, telegraphy, telephone, computer data base, cable, optic, microwave, or other communication system.

9. "Sale" means any transfer of title or possession, exchange or barter, conditional or otherwise, in any manner or by any means whatever, for a consideration, and includes the furnishing or service of steam, gas, or communication, the furnishing of bingo cards, the furnishing of hotel, motel, or tourist court accommodations, the furnishing of tickets or admissions to any place of amusement, athletic event, or place of entertainment including the playing of any machine for amusement or entertainment in response to the use of a coin, and sales of magazines and other periodicals. Provided, the words "magazines and other periodicals" as used in this subsection do not include newspapers nor magazines or periodicals that are furnished free by a nonprofit corporation or organization to its members or because of payment by its members of membership fees or dues.

**(Effective after December 31, 2005) Definitions.** The following words, terms, and phrases, when used in this chapter, have the meaning ascribed to them in this section, unless the context clearly indicates a different meaning:

1. "Business" includes any activity engaged in by any person or caused to be engaged in by the person with the object of gain, benefit or advantage, either direct or indirect.
2. "Certified service provider" means an agent certified under the agreement adopted under chapter 57-39.4 to perform all of the seller's sales and use tax functions, other than the seller's obligation to remit taxes on its own purchases.
3. "Commissioner" means the tax commissioner of the state of North Dakota.
4. "Delivery charges" means charges by the seller for preparation and delivery to a location designated by the purchaser of personal property or services. For purposes of this subsection, "preparation and delivery" includes transportation, shipping, postage, handling, crating, and packing. If shipment includes exempt

property and taxable property, the seller should allocate the delivery charge by using:

- a. A percentage based on the total sales price of the taxable property compared to the total sales price of all property in the shipment; or
- b. A percentage based on the total weight of the taxable property compared to the total weight of all property in the shipment.

The seller must tax the percentage of the delivery charge allocated to the taxable property but does not have to tax the percentage allocated to the exempt property.

5. "Direct mail" means printed material delivered or distributed by United States mail or other delivery service to a mass audience or to addresses on a mailing list provided by the purchaser or at the direction of the purchaser when the cost of the items are not billed directly to the recipients. "Direct mail" includes tangible personal property supplied directly or indirectly by the purchaser to the direct mail seller for inclusion in the package containing the printed material. "Direct mail" does not include multiple items of printed material delivered to a single address.

6. "Drug" means a compound, substance, or preparation and any component of a compound, substance, or preparation, other than food and food ingredients, dietary supplements, or alcoholic beverages:

- a. Recognized in the official United States pharmacopoeia, official homeopathic pharmacopoeia of the United States, or official national formulary, or any supplement of any of these publications;
- b. Intended for use in the diagnosis, cure, mitigation, treatment, or prevention of disease; or
- c. Intended to affect the structure or any function of the body.

- ~~6-~~ 7. "Farm machinery" means all vehicular implements and attachment units, designed and sold for direct use in planting, cultivating, or harvesting farm products or used in connection with the production of agricultural produce or products, livestock, or poultry on farms, which are operated, drawn, or propelled by motor or animal power. "Farm machinery" does not include vehicular implements operated wholly by hand or a motor vehicle required to be registered under chapter 57-40.3. "Farm machinery" does not include machinery that may be used for other than agricultural



purposes, including tires, farm machinery repair parts, tools, shop equipment, grain bins, feed bunks, fencing materials, and other farm supplies and equipment. For purposes of this subsection, "attachment unit" means any part or combination of parts having an independent function, other than farm machinery repair parts, which when attached or affixed to farm machinery is used exclusively for agricultural purposes.

~~7.~~ 8. "Farm machinery repair parts" means repair or replacement parts for farm machinery that have a specific or generic part number assigned by the manufacturer of the farm machinery. "Farm machinery repair parts" do not include tires, fluid, gas, grease, lubricant, wax, or paint.

~~8.~~ 9. a. "Gross receipts" means the measure subject to sales tax and means the total amount of consideration, including cash, credit, property, and services, for which personal property or services are sold, leased, or rented, valued in money, whether received in money or otherwise, without any deduction for the following:

- (1) The seller's cost of the property sold;
- (2) The cost of materials used, labor or service costs, interest, losses, all costs of transportation to the seller, all taxes imposed on the seller, and any other expense of the seller;
- (3) Charges by the seller for any services necessary to complete the sale, other than delivery and installation charges;
- (4) Delivery charges;
- (5) The value of exempt personal property given to the purchaser when taxable and exempt personal property have been bundled together and sold by the seller as a single product or piece of merchandise; and
- (6) Credit for any trade-in, as determined by state law.

b. "Gross receipts" also includes the total amount of sales of every clerk, auctioneer, agent, or factor selling tangible personal property owned by any other retailer.

c. "Gross receipts" does not include:

- (1) Discounts, including cash, term, or coupons that are not reimbursed by a third party, which are allowed by a seller and taken by a purchaser on a sale;
- (2) Interest, financing, and carrying charges from credit extended on the sale of personal property or services, if the amount is separately stated on the invoice, bill of sale, or similar document given to the purchaser;
- (3) Any taxes legally imposed directly on the consumer that are separately stated on the invoice, bill of sale, or similar documents given to the purchaser; and
- (4) The sale price of property returned by a customer when the full sale price is refunded either in cash or credit. When tangible personal property is taken in trade or in a series of trades as a credit or part payment of a retail sale taxable under this chapter, if the tangible personal property traded in will be subject to tax imposed by chapter 57-39.5 or 57-40.3 or if the tangible personal property traded in is used farm machinery or used irrigation equipment, the credit or trade-in value allowed by the retailer is not included in gross receipts of the retailer.

- ~~9.~~ 10. "Lease or rental" means any transfer of possession or control of tangible personal property for a fixed or indeterminate term for consideration. A lease or rental may include future options to purchase or extend. "Lease or rental" does not include:
- a. A transfer of possession or control of property under a security agreement or deferred payment plan, which requires the transfer upon completion of the required payments;
  - b. A transfer of possession or control of property under an agreement that requires the transfer of title upon completion of required payments and payment of an option price that does not exceed the greater of one hundred dollars or one percent of the total required payments; or
  - c. Providing tangible personal property with an operator for a fixed or indeterminate period of time. A condition of this exclusion is that the operator is necessary for the equipment to perform as designed. For the purpose of

1                   this subdivision, an operator must do more than maintain, inspect, or set up  
2                   the tangible personal property.

3                   This definition will be applied only prospectively from the date of adoption and will  
4                   have no retroactive impact on existing leases or rentals.

~~48.~~ 19. "Tangible personal property" means personal property that can be seen, weighed, measured, felt, or touched or that is in any other manner perceptible to the senses. "Tangible personal property" includes electricity, gas, steam, and prewritten computer software.

**SECTION 4. AMENDMENT.** Subdivision h of subsection 1 of section 57-39.2-02.1 of the North Dakota Century Code as effective after December 31, 2005, is amended and reenacted as follows:

h. Sale, lease, or rental of computer ~~software~~ and prewritten computer software, including prewritten computer software delivered electronically or by load and leave. For purposes of this subdivision:

- (1) "Computer" means an electronic device that accepts information in digital or similar form and manipulates it for a result based on a sequence of instructions.
- (2) "Computer software" means a set of coded instructions designed to cause a computer or automatic data processing equipment to perform a task.
- (3) "Delivered electronically" means delivered from the seller to the purchaser by means other than tangible storage media.
- (4) "Electronic" means relating to technology having electrical, digital, magnetic, wireless, optical, electromagnetic, or similar capabilities.
- (5) "Load and leave" means delivery to the purchaser by use of a tangible storage media when the tangible storage media is not physically transferred to the purchaser.
- (6) "Prewritten computer software" means computer software, including prewritten upgrades, which is not designed and developed by the author or other creator to the specifications of a specific purchaser. The combining of two or more "prewritten computer software" programs or prewritten portions thereof does not cause the combination to be other than "prewritten computer software". "Prewritten computer software" includes software designed and developed by the author or other creator to the specifications of a specific purchaser when it is sold to a person other than the purchaser. If a person modifies or enhances "computer software" of which the person is not the author or creator, the person is deemed to be the author or creator only of such person's modifications or enhancements. "Prewritten computer software" or a prewritten portion thereof that is modified or enhanced to any degree, if such modification or enhancement is designed and developed to the specifications of a specific purchaser, remains "prewritten computer

software". However, if there is a reasonable, separately stated charge or an invoice or other statement of the price given to the purchaser for such modification or enhancement, such modification or enhancement shall not constitute "prewritten computer software".

18 a. Alcoholic beverages or mixed drinks made from alcoholic beverages.  
19 2. b. Candy or chewing gum.  
20 3. Carbonated beverages.  
21 4. Beverages commonly referred to as soft drinks containing less than seventy  
22 percent fruit juice.  
23 5. Powdered drink mixes.  
24 6. Medicines and preparations in liquid, powdered, granular, tablet, capsule, lozenge,  
25 or pill form sold as dietary supplements or adjuncts.  
26 7. Coffee and coffee substitutes.  
27 8. Tea.  
28 9. Cocoa or cocoa products.  
29 c. Dietary supplements.  
30 d. Prepared Food.  
31 e. Soft drinks containing less than fifty percent fruit juice.

f. Tobacco.

2. For purposes of this section:

a. "Alcoholic beverages" means beverages that are suitable for human consumption and contain one-half of one percent or more of alcohol by volume.

b. "Candy" means a preparation of sugar, honey, or other natural or artificial sweeteners in combination with chocolate, fruits, nuts, or other ingredients or flavoring in the form of bars, drops, or pieces. Candy does not include any preparation containing flour and that does not require refrigeration.

c. "Dietary supplement" means any product, other than tobacco, intended to supplement the diet which contains one or more of the following dietary ingredients: a vitamin; a mineral; a herb or other botanical; an amino acid; a dietary substance for use by humans to supplement the diet by increasing the total dietary intake; an oral concentrate, metabolite, constitute, extract, or combination of any dietary ingredients described in this sentence and which is intended for ingestion in tablet, capsule, powder, soft gel cap, or liquid form, or if not represented for use as a sole items of a meal or of a diet; and is required to be labeled as a dietary supplement, identifiable by the supplemental facts box found on the label and as required pursuant to 21 CFR section 101.36.

d. "Prepared food" means:

(1) Food sold in a heated state or heated by the seller;

(2) Two or more food ingredients mixed or combined by the seller for sale as a single items; or

(3) Food sold with eating utensils provided by the seller, including plates, knives, forks, spoons, glasses, cups, napkins, or straws. A plate does not include a container or packaging used to transport the food.

e. "Prepared food" does not mean:

(1) Food that is only cut, repackaged, or pasteurized by the seller.

(2) Eggs, fish, meat, poultry, and foods containing these raw animal foods requiring cooking by the consumer as recommended by the food and

3                    (3)   If sold without eating utensils provided by the seller:

4                    (a)   Food sold by a seller whose proper primary North American

8                    item.

9                    (c)   Bakery items, including bread, rolls, buns, biscuits, bagels,

12                  f.   "Soft drinks" means nonalcoholic beverages that contain natural or artificial

14                  milk products, soy, rice, or similar milk substitutes, or greater than fifty percent  
15                  of vegetable or fruit juice by volume.

16                  g.   "Tobacco" means cigarettes, cigars, chewing or pipe tobacco, or any other  
17                  item that contains tobacco.

18                  **SECTION 12. REPEAL.** Section 57-39.2-03.8, subsection 33 of section 57-39.2-04,  
19                  and section 57-40.2-03.2 of the North Dakota Century Code are repealed.

20                  **SECTION 13. EFFECTIVE DATE - EXPIRATION DATE.** This Act is effective for  
21                  taxable events occurring after December 31, 2005. Section 7 of this Act is effective for taxable  
22                  events occurring through December 31, 2007, and is thereafter ineffective.
