1 A BILL for an Act to create and enact sections 57-39.2-03.9, 57-39.5-05 and 57-39.6-05 and
2 chapter 57-39.7 of the North Dakota Century Code, relating to application of sales taxes to
3 tobacco products, use taxes and credits for storage, use, or consumption in this state of farm
4 machinery or alcoholic beverages, and a lodging gross receipts tax; to amend and reenact
5 subsection 2 of section 11-09.1-05, sections 40-05.1-06, 57-01-02.1, and 57-39.2-01,
6 subdivision h of subsection 1 of section 57-39.2-02.1, subdivision d of subsection 2 of section
7 57-39.2-04.1, subsection 8 of section 57-39.4-16, section 57-40.2-01, subsection 2 of section
8 57-40.2-02.1, and sections 57-40.2-04 and 57-40.2-04.1 of the North Dakota Century Code,
9 relating to sales and use tax amendments to conform with the provisions of the Streamlined
10 Sales Tax Act; to repeal section 57-39.2-03.8, subsection 33 of section 57-39.2-04, and section
11 57-40.2-03.2 of the North Dakota Century Code, relating to elimination of provisions in conflict
12 with the Streamlined Sales Tax Act; to provide an effective date; and to provide an expiration
13 date.

14 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

15 **SECTION 1. AMENDMENT.** Subsection 2 of section 11-09.1-05 of the North Dakota
16 Century Code as effective after December 31, 2005, is amended and reenacted as follows:

17 2. Control its finances and fiscal affairs; appropriate money for its purposes, and
18 make payments of its debts and expenses; subject to the limitations of this section
19 levy and collect property taxes, sales and use taxes, farm machinery gross
20 receipts taxes, alcoholic beverage gross receipts taxes, motor vehicle fuels and
21 special fuels taxes, motor vehicle registration fees, and special assessments for
22 benefits conferred, for its public and proprietary functions, activities, operations,
23 undertakings, and improvements; contract debts, borrow money, issue bonds,
24 warrants, and other evidences of indebtedness; establish charges for any county or

other services to the extent authorized by state law, and establish debt and mill levy limitations; provided, that all property in order to be subject to the assessment provisions of this subsection must be assessed in a uniform manner as prescribed by the state board of equalization and the state supervisor of assessments. A charter or ordinance or act of a governing body of a home rule county may not supersede any state law that determines what property or acts are subject to, or exempt from, ad valorem taxes. A charter or ordinance or act of the governing body of a home rule county may not supersede section 11-11-55.1 relating to the sixty percent petition requirement for improvements and of section 40-22-18 relating to the barring proceeding for improvement projects. After December 31, 2005, sales and use taxes, farm machinery gross receipts taxes, and alcoholic beverage gross receipts taxes levied under this chapter:

- a. Must conform in all respects with regard to the taxable or exempt status of items under chapters 57-39.2, 57-39.5, 57-39.6, and 57-40.2 and may not be imposed at multiple rates with the exception of sales of electricity, piped natural or artificial gas, or other heating fuels delivered by the seller or the retail sale or transfer of motor vehicles, aircraft, watercraft, modular homes, manufactured homes, or mobile homes.
- b. May not be newly imposed or changed except to be effective on the first day of a calendar quarterly period after a minimum of ninety days notice to the tax commissioner or, for purchases from printed catalogs, on the first day of a calendar quarter after a minimum of one hundred twenty days notice to the seller.
- c. May not be limited to apply to less than the full value of the transaction or item as determined for state sales and use tax, farm machinery gross receipts tax, or alcoholic beverage gross receipts tax purposes.
- d. Must be subject to collection by the tax commissioner under an agreement under section 57-01-02.1.

After December 31, 2005, any portion of a charter or any portion of an ordinance or act of a governing body of a home rule county passed pursuant to a charter which does not conform to the requirements of this subsection is invalid to the extent that

1 it does not conform. The invalidity of a portion of a charter or ordinance or act of a
2 governing body of a home rule county because it does not conform to this
3 subsection does not affect the validity of any other portion of the charter or
4 ordinance or act of a governing body of a home rule county. Any taxes imposed
5 under this chapter on farm machinery, farm irrigation equipment, and farm
6 machinery repair parts used exclusively for agricultural purposes, or on alcoholic
7 beverages, which were in effect on December 31, 2005, become gross receipts
8 taxes after December 31, 2005.

9 **SECTION 2. AMENDMENT.** Section 40-05.1-06 of the North Dakota Century Code as
10 effective after December 31, 2005, is amended and reenacted as follows:

11 **40-05.1-06 (Effective after December 31, 2005) Powers.** From and after the filing
12 with the secretary of state of a charter framed and approved in reasonable conformity with the
13 provisions of this chapter, such city, and the citizens thereof, shall, if included in the charter and
14 implemented through ordinances, have the following powers set out in this chapter:

- 15 1. To acquire, hold, operate, and dispose of property within or without the corporate
16 limits, and exercise the right of eminent domain for such purposes.
- 17 2. To control its finances and fiscal affairs; to appropriate money for its purposes, and
18 make payment of its debts and expenses; to levy and collect taxes, excises, fees,
19 charges, and special assessments for benefits conferred, for its public and
20 proprietary functions, activities, operations, undertakings, and improvements; to
21 contract debts, borrow money, issue bonds, warrants, and other evidences of
22 indebtedness; to establish charges for any city or other services, and to establish
23 debt and mill levy limitations, provided that all real and personal property in order to
24 be subject to the assessment provisions of this subsection shall be assessed in a
25 uniform manner as prescribed by the state board of equalization and the state
26 supervisor of assessments. The authority to levy taxes under this subsection does
27 not include authority to impose income taxes.
- 28 3. To fix the fees, number, terms, conditions, duration, and manner of issuing and
29 revoking licenses in the exercise of its governmental police powers.
- 30 4. To provide for city officers, agencies, and employees, their selection, terms,
31 powers, duties, qualifications, and compensation. To provide for change,

- 1 selection, or creation of its form and structure of government including its
- 2 governing body, executive officer, and city officers.
- 3 5. To provide for city courts, their jurisdiction and powers over ordinance violations,
- 4 duties, administration, and the selection, qualifications, and compensation of their
- 5 officers; however, the right of appeal from judgment of such courts shall not be in
- 6 any way affected.
- 7 6. To provide for all matters pertaining to city elections, except as to qualifications of
- 8 electors.
- 9 7. To provide for the adoption, amendment, and repeal of ordinances, resolutions,
- 10 and regulations to carry out its governmental and proprietary powers and to
- 11 provide for public health, safety, morals, and welfare, and penalties for a violation
- 12 thereof.
- 13 8. To lay out or vacate streets, alleys, and public grounds, and to provide for the use,
- 14 operation, and regulation thereof.
- 15 9. To define offenses against private persons and property and the public health,
- 16 safety, morals, and welfare, and provide penalties for violations thereof.
- 17 10. To engage in any utility, business, or enterprise permitted by the constitution or not
- 18 prohibited by statute or to grant and regulate franchises therefor to a private
- 19 person, firm, corporation, or limited liability company.
- 20 11. To provide for zoning, planning, and subdivision of public or private property within
- 21 the city limits; to provide for such zoning, planning, and subdivision of public or
- 22 private property outside the city limits as may be permitted by state law.
- 23 12. To levy and collect franchise and license taxes for revenue purposes.
- 24 13. To exercise in the conduct of its affairs all powers usually exercised by a
- 25 corporation.
- 26 14. To fix the boundary limits of said city and the annexation and deannexation of
- 27 territory adjacent to said city except that such power shall be subject to, and shall
- 28 conform with the state law made and provided.
- 29 15. To contract with and receive grants from any other governmental entity or agency,
- 30 with respect to any local, state, or federal program, project, or works.

1 16. To impose registration fees on motor vehicles, farm machinery gross receipts
2 taxes, alcoholic beverage gross receipts taxes, or sales and use taxes in addition
3 to any other taxes imposed by law. After December 31, 2005, sales and use taxes
4 and gross receipts taxes levied under this chapter:

- 5 a. Must conform in all respects with regard to the taxable or exempt status of
6 items under chapters 57-39.2 and 57-40.2 and may not be imposed at
7 multiple rates with the exception of sales of electricity, piped natural or
8 artificial gas, or other heating fuels delivered by the seller or the retail sale or
9 transfer of motor vehicles, aircraft, watercraft, modular homes, manufactured
10 homes, or mobile homes.
- 11 b. May not be newly imposed or changed except to be effective on the first day
12 of a calendar quarterly period after a minimum of ninety days notice to the tax
13 commissioner or, for purchases from printed catalogs, on the first day of a
14 calendar quarter after a minimum of one hundred twenty days notice to the
15 seller.
- 16 c. May not be limited to apply to less than the full value of the transaction or item
17 as determined for state sales and use tax purposes.
- 18 d. Must be subject to collection by the tax commissioner under an agreement
19 under section 57-01-02.1.

20 It is the intention of this chapter to grant and confirm to the people of all cities coming
21 within its provisions the full right of self-government in both local and city matters within the
22 powers enumerated herein. The statutes of the state of North Dakota, so far as applicable,
23 shall continue to apply to home rule cities, except insofar as superseded by the charters of such
24 cities or by ordinance passed pursuant to such charters.

25 After December 31, 2005, any portion of a charter or any portion of an ordinance
26 passed pursuant to a charter which does not conform to the requirements of subsection 16 is
27 invalid to the extent that it does not conform. The invalidity of a portion of a charter or
28 ordinance because it does not conform to subsection 16 does not affect the validity of any other
29 portion of the charter or ordinance. Any taxes imposed under this chapter on farm machinery,
30 farm irrigation equipment, and farm machinery repair parts used exclusively for agricultural

1 purposes, or on alcoholic beverages, which were in effect on December 31, 2005, become
2 gross receipts taxes after December 31, 2005.

3 **SECTION 3. AMENDMENT.** Section 57-01-02.1 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **57-01-02.1. (Effective through December 31, 2005) Tax collection agreements with**
6 **home rule cities or counties.**

- 7 1. The governing body of any incorporated city that has adopted the home rule
8 provisions of chapter 40-05.1, or of any county which has adopted the home rule
9 provisions of chapter 11-09.1, and the tax commissioner are hereby authorized and
10 empowered to enter into contractual agreements whereby the tax commissioner
11 has authority to collect any sales or use taxes assessed by such incorporated city
12 or county.
- 13 2. It is the duty of the tax commissioner to deposit with the state treasurer all money
14 collected under this section and to accompany each remittance with a certificate
15 showing the city or county for which it was collected. The state treasurer, monthly,
16 shall pay to the auditors of the several cities or counties the money to which they
17 are entitled under this section.
- 18 3. The agreements entered into under this section may also provide for an agreed
19 amount to be allowed the tax commissioner for services rendered in connection
20 with such collections. Any sums collected for services rendered must be paid to
21 the state treasurer for deposit in the general fund.

22 **(Effective after December 31, 2005) Tax collection agreements with home rule**
23 **cities or counties - Limitations on city or county authority.**

- 24 1. The governing body of any incorporated city that has adopted the home rule
25 provisions of chapter 40-05.1 or of any county which has adopted the home rule
26 provisions of chapter 11-09.1 must enter a contract with the tax commissioner
27 giving the tax commissioner authority to collect any sales ~~or~~, use, or gross receipts
28 taxes assessed by such incorporated city or county.
- 29 2. The tax commissioner shall deposit with the state treasurer all money collected
30 under a contract under this section and accompany each remittance with a
31 certificate showing the city or county for which it was collected. The state

1 treasurer, monthly, shall pay to the auditors of cities or counties the money to
2 which cities or counties are entitled under a contract under this section.

3 3. Contracts under this section shall provide for an agreed amount to be allowed the
4 tax commissioner for services. Any sums collected for services rendered must be
5 paid to the state treasurer for deposit in the general fund.

6 4. A person required to collect and remit sales or use taxes may not be required to
7 register with, file returns with, or remit funds to anyone other than the tax
8 commissioner or the tax commissioner's authorized agent. A city or county may
9 not conduct an independent sales or use tax audit of a seller registered under the
10 agreement adopted under chapter 57-39.4.

11 5. A retailer shall collect city and county sales, use, and gross receipts taxes without
12 regard to any cap or threshold on purchases provided by city or county ordinance,
13 resolution, or charter and a taxpayer is eligible for refund from the tax
14 commissioner of the difference between the amount of city and county sales, use,
15 or gross receipts taxes paid and the amount that would have been due by
16 application of a cap or threshold provided by city or county ordinance, resolution, or
17 charter.

18 **SECTION 4. AMENDMENT.** Section 57-39.2-01 of the North Dakota Century Code as
19 effective after December 31, 2005, is amended and reenacted as follows:

20 **57-39.2-01. (Effective after December 31, 2005) Definitions.** The following words,
21 terms, and phrases, when used in this chapter, have the meaning ascribed to them in this
22 section, unless the context clearly indicates a different meaning:

- 23 1. "Business" includes any activity engaged in by any person or caused to be
24 engaged in by the person with the object of gain, benefit or advantage, either direct
25 or indirect.
- 26 2. "Certified service provider" means an agent certified under the agreement adopted
27 under chapter 57-39.4 to perform all of the seller's sales and use tax functions,
28 other than the seller's obligation to remit taxes on its own purchases.
- 29 3. "Commissioner" means the tax commissioner of the state of North Dakota.
- 30 4. "Delivery charges" means charges by the seller for preparation and delivery to a
31 location designated by the purchaser of personal property or services. For

purposes of this subsection, "preparation and delivery" includes transportation, shipping, postage, handling, crating, and packing. If shipment includes exempt property and taxable property, the seller should allocate the delivery charge by using a percentage based on:

- a. The total sales price of the taxable property compared to the total sales price of all property in the shipment; or
- b. The total weight of the taxable property compared to the total weight of all property in the shipment.

The seller must tax the percentage of the delivery charge allocated to the taxable property but does not have to tax the percentage allocated to the exempt property.

5. "Direct mail" means printed material delivered or distributed by United States mail or other delivery service to a mass audience or to addresses on a mailing list provided by the purchaser or at the direction of the purchaser when the cost of the items are not billed directly to the recipients. "Direct mail" includes tangible personal property supplied directly or indirectly by the purchaser to the direct mail seller for inclusion in the package containing the printed material. "Direct mail" does not include multiple items of printed material delivered to a single address.

6. "Drug" means a compound, substance, or preparation and any component of a compound, substance, or preparation, other than food and food ingredients, dietary supplements, or alcoholic beverages:

- a. Recognized in the official United States pharmacopoeia, official homeopathic pharmacopoeia of the United States, or official national formulary, or any supplement of any of these publications;
- b. Intended for use in the diagnosis, cure, mitigation, treatment, or prevention of disease; or
- c. Intended to affect the structure or any function of the body.

- ~~6.~~ 7. "Farm machinery" means all vehicular implements and attachment units, designed and sold for direct use in planting, cultivating, or harvesting farm products or used in connection with the production of agricultural produce or products, livestock, or poultry on farms, which are operated, drawn, or propelled by motor or animal power. "Farm machinery" does not include vehicular implements operated wholly

by hand or a motor vehicle required to be registered under chapter 57-40.3. "Farm machinery" does not include machinery that may be used for other than agricultural purposes, including tires, farm machinery repair parts, tools, shop equipment, grain bins, feed bunks, fencing materials, and other farm supplies and equipment. For purposes of this subsection, "attachment unit" means any part or combination of parts having an independent function, other than farm machinery repair parts, which when attached or affixed to farm machinery is used exclusively for agricultural purposes.

~~7.~~ 8. "Farm machinery repair parts" means repair or replacement parts for farm machinery that have a specific or generic part number assigned by the manufacturer of the farm machinery. "Farm machinery repair parts" do not include tires, fluid, gas, grease, lubricant, wax, or paint.

~~8.~~ 9. a. "Gross receipts" means the measure subject to sales tax and means the total amount of consideration, including cash, credit, property, and services, for which personal property or services are sold, leased, or rented, valued in money, whether received in money or otherwise, without any deduction for the following:

- (1) The seller's cost of the property sold;
- (2) The cost of materials used, labor or service costs, interest, losses, all costs of transportation to the seller, all taxes imposed on the seller, and any other expense of the seller;
- (3) Charges by the seller for any services necessary to complete the sale, other than delivery and installation charges;
- (4) Delivery charges;
- (5) The value of exempt personal property given to the purchaser when taxable and exempt personal property have been bundled together and sold by the seller as a single product or piece of merchandise; and
- (6) Credit for any trade-in, as determined by state law.

b. "Gross receipts" also includes the total amount of sales of every clerk, auctioneer, agent, or factor selling tangible personal property owned by any other retailer.

c. "Gross receipts" does not include:

- (1) Discounts, including cash, term, or coupons that are not reimbursed by a third party, which are allowed by a seller and taken by a purchaser on a sale;
- (2) Interest, financing, and carrying charges from credit extended on the sale of personal property or services, if the amount is separately stated on the invoice, bill of sale, or similar document given to the purchaser;
- (3) Any taxes legally imposed directly on the consumer that are separately stated on the invoice, bill of sale, or similar documents given to the purchaser; and
- (4) The sale price of property returned by a customer when the full sale price is refunded either in cash or credit. When tangible personal property is taken in trade or in a series of trades as a credit or part payment of a retail sale taxable under this chapter, if the tangible personal property traded in will be subject to tax imposed by chapter 57-39.5 or 57-40.3 or if the tangible personal property traded in is used farm machinery or used irrigation equipment, the credit or trade-in value allowed by the retailer is not included in gross receipts of the retailer.

~~9.~~ 10. "Lease or rental" means any transfer of possession or control of tangible personal property for a fixed or indeterminate term for consideration. A lease or rental may include future options to purchase or extend. "Lease or rental" does not include:

- a. A transfer of possession or control of property under a security agreement or deferred payment plan, which requires the transfer upon completion of the required payments;
- b. A transfer of possession or control of property under an agreement that requires the transfer of title upon completion of required payments and payment of an option price that does not exceed the greater of one hundred dollars or one percent of the total required payments; or
- c. Providing tangible personal property with an operator for a fixed or indeterminate period of time. A condition of this exclusion is that the operator is necessary for the equipment to perform as designed. For the purpose of

1 this subdivision, an operator must do more than maintain, inspect, or set up
2 the tangible personal property.

3 This definition will be applied only prospectively from the date of adoption and will
4 have no retroactive impact on existing leases or rentals.

5 ~~40.~~ 11. "Local governmental unit" means incorporated cities, counties, school districts, and
6 townships.

7 ~~44.~~ 12. "Person" includes any individual, firm, partnership, joint venture, association,
8 corporation, limited liability company, estate, business trust, receiver, or any other
9 group or combination acting as a unit and the plural as well as the singular number.

10 ~~42.~~ 13. "Prescription" means an order, formula, or recipe issued in any form of oral,
11 written, electronic, or other means of transmission by a person authorized by the
12 laws of this state to prescribe drugs.

13 ~~43.~~ 14. "Relief agency" means the state, any county, city and county, city or district
14 thereof, or an agency engaged in actual relief work.

15 ~~44.~~ 15. "Retail sale" or "sale at retail" means any sale, lease, or rental for any purpose
16 other than for resale, sublease, or subrental. "Retail sale" or "sale at retail"
17 includes the sale, including the leasing or renting, to a consumer or to any person
18 for any purpose, other than for processing or for resale, of tangible personal
19 property; the sale of steam, gas, and communication service to retail consumers or
20 users; the sale of vulcanizing, recapping, and retreading services for tires; the
21 furnishing of bingo cards; the ordering, selecting, or aiding a customer to select any
22 goods, wares, or merchandise from any price list or catalog, which the customer
23 might order, or be ordered for such customer to be shipped directly to such
24 customer; the sale or furnishing of hotel, motel, or tourist court accommodations,
25 tickets, or admissions to any place of amusement, athletic event, or place of
26 entertainment, including the playing of any machine for amusement or
27 entertainment in response to the use of a coin; and the sales of magazines and
28 other periodicals. By the term "processing" is meant any tangible personal
29 property including containers which it is intended, by means of fabrication,
30 compounding, manufacturing, producing, or germination shall become an integral
31 or an ingredient or component part of other tangible personal property intended to

be sold ultimately at retail. The sale of an item of tangible personal property for the purpose of incorporating it in or attaching it to real property must be considered as a sale of tangible personal property for a purpose other than for processing; the delivery of possession within the state of North Dakota of tangible personal property by a wholesaler or distributor to an out-of-state retailer who does not hold a North Dakota retail sales tax permit or to a person who by contract incorporates such tangible personal property into, or attaches it to, real property situated in another state may not be considered a taxable sale if such delivery of possession would not be treated as a taxable sale in that state. As used in this subsection, the word "consumer" includes any hospital, infirmary, sanatorium, nursing home, home for the aged, or similar institution that furnishes services to any patient or occupant. The sale of an item of tangible personal property to a person under a finance leasing agreement over the term of which the property will be substantially consumed must be considered a retail sale if the purchaser elects to treat it as such by paying or causing the transferor to pay the sales tax thereon to the commissioner on or before the last day on which payments may be made without penalty as provided in section 57-39.2-12.

~~45.~~ 16. "Retailer" or "seller" includes every person engaged in the business of leasing or renting hotel, motel, or tourist court accommodations, and every person engaged in the business of selling tangible goods, wares, or merchandise at retail, or furnishing of steam, gas, and communication services, or tickets or admissions to places of amusement, entertainment, and athletic events, including the playing of any machine for amusement or entertainment in response to the use of a coin, or magazines, or other periodicals; any organization licensed by the attorney general to conduct bingo games pursuant to section 53-06.1-03; and includes any person as herein defined who by contract or otherwise agrees to furnish for a consideration a totally or partially finished product consisting in whole or in part of tangible personal property subject to the sales tax herein provided, and all items of tangible personal property entering into the performance of such contract as a component part of the product agreed to be furnished under said contract shall be subject to the sales tax herein provided and the sales tax thereon shall be collected

by the contractor from the person for whom the contract has been performed in addition to the contract price agreed upon, and shall be remitted to the state in the manner provided in this chapter; and shall include the state or any municipality furnishing steam, gas, or communication service to members of the public in its proprietary capacity. For the purpose of this chapter, retailer shall also include every clerk, auctioneer, agent, or factor selling tangible personal property owned by any other retailer. A retailer also includes every person who engages in regular or systematic solicitation of a consumer market in this state by the distribution of catalogs, periodicals, advertising flyers, or other advertising, or by means of print, radio or television media, by mail, telegraphy, telephone, computer data base, cable, optic, microwave, or other communication system.

~~46.~~ 17. "Sale" means any transfer of title or possession, exchange or barter, conditional or otherwise, in any manner or by any means whatever, for a consideration, and includes the furnishing or service of steam, gas, or communication, the furnishing of bingo cards, the furnishing of hotel, motel, or tourist court accommodations, the furnishing of tickets or admissions to any place of amusement, athletic event, or place of entertainment, including the playing of any machine for amusement or entertainment in response to the use of a coin, and sales of magazines and other periodicals. Provided, the words "magazines and other periodicals" as used in this subsection do not include newspapers nor magazines or periodicals that are furnished free by a nonprofit corporation or organization to its members or because of payment by its members of membership fees or dues.

~~47.~~ 18. "Sales tax" means the tax levied under section 57-39.2-02.1 or a conforming tax imposed under home rule authority by a city or county.

~~48.~~ 19. "Tangible personal property" means personal property that can be seen, weighed, measured, felt, or touched or that is in any other manner perceptible to the senses. "Tangible personal property" includes electricity, water, gas, steam, and prewritten computer software.

SECTION 5. AMENDMENT. Subdivision h of subsection 1 of section 57-39.2-02.1 of the North Dakota Century Code as effective after December 31, 2005, is amended and reenacted as follows:

h. Sale, lease, or rental of a computer ~~software~~ and prewritten computer software, including prewritten computer software delivered electronically or by load and leave. For purposes of this subdivision:

- (1) "Computer" means an electronic device that accepts information in digital or similar form and manipulates it for a result based on a sequence of instructions.
- (2) "Computer software" means a set of coded instructions designed to cause a computer or automatic data processing equipment to perform a task.
- (3) "Delivered electronically" means delivered from the seller to the purchaser by means other than tangible storage media.
- (4) "Electronic" means relating to technology having electrical, digital, magnetic, wireless, optical, electromagnetic, or similar capabilities.
- (5) "Load and leave" means delivery to the purchaser by use of a tangible storage media when the tangible storage media is not physically transferred to the purchaser.
- (6) "Prewritten computer software" means computer software, including prewritten upgrades, which is not designed and developed by the author or other creator to the specifications of a specific purchaser. The combining of two or more "prewritten computer software" programs or prewritten portions thereof does not cause the combination to be other than "prewritten computer software". "Prewritten computer software" includes software designed and developed by the author or other creator to the specifications of a specific purchaser when it is sold to a person other than the purchaser. If a person modifies or enhances "computer software" of which the person is not the author or creator, the person is deemed to be the author or creator only of such person's modifications or enhancements. "Prewritten computer software" or a prewritten portion thereof that is modified or enhanced to any degree, if such modification or enhancement is designed and developed to the specifications of a specific purchaser, remains "prewritten computer

software". However, if there is a reasonable, separately stated charge or an invoice or other statement of the price given to the purchaser for such modification or enhancement, such modification or enhancement shall not constitute "prewritten computer software".

SECTION 6. Section 57-39.2-03.9 of the North Dakota Century Code is created and enacted as follows:

57-39.2-03.9. (Effective January 1, 2006) Sales tax on tobacco products.

Notwithstanding any other provision of law, the sales taxes imposed by this chapter apply to the gross receipts of retailers from all sales at retail of cigarettes, cigars, and other tobacco products. For purposes of this section, "gross receipts" from the sale of cigarettes, cigars and other tobacco products includes any other taxes imposed on such merchandise or its use or on the retail or other sale of such merchandise.

SECTION 7. AMENDMENT. Subdivision d of subsection 2 of section 57-39.2-04.1 of the North Dakota Century Code as effective after December 31, 2005, is amended and reenacted as follows:

d. "Prepared food" means:

- (1) Food sold in a heated state or heated by the seller;
- (2) Two or more food ingredients mixed or combined by the seller for sale as a single item; or
- (3) Food sold with eating utensils provided by the seller, including plates, knives, forks, spoons, glasses, cups, napkins, or straws. A plate does not include a container or packaging used to transport the food.

SECTION 8. AMENDMENT. Subsection 8 of section 57-39.4-16 of the North Dakota Century Code as effective after December 31, 2005, is amended and reenacted as follows:

SECTION 9. Section 57-39.5-05 of the North Dakota Century Code is created and enacted as follows:

It also includes every person who engages in regular or systematic solicitation of sales of tangible personal property in this state by the distribution of catalogs, periodicals, advertising flyers, or other advertising, by means of print, radio or television media, or by mail, telegraphy, telephone, computer data base, cable, optic, microwave, or other communication system for the purpose of effecting retail sales of tangible personal property.

3 **SECTION 16. REPEAL.** Section 57-39.2-03.8, subsection 33 of section 57-39.2-04,
4 and section 57-40.2-03.2 of the North Dakota Century Code are repealed.

5 **SECTION 17. EFFECTIVE DATE - EXPIRATION DATE.** Section 11 of this Act is
6 effective for taxable events occurring from January 1, 2006, through June 30, 2007, and is
7 thereafter ineffective. The remainder of this Act is effective for taxable events occurring after
8 December 31, 2005.
