- 1 A BILL for an Act to amend and reenact sections 5-01-08 and 5-02-06 of the North Dakota
- 2 Century Code, relating to an underage person in a licensed alcohol establishment.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. AMENDMENT.** Section 5-01-08 of the North Dakota Century Code is 5 amended and reenacted as follows:
- 5-01-08. Persons under twenty-one years of age prohibited from manufacturing,
 purchasing, consuming, or possessing alcoholic beverages or entering licensed
 premises Penalty Exceptions Referrals to addiction facilities Jurisdiction.
- 9 <u>1.</u> Except as permitted in this section and section 5-02-06, a person under twenty-one
 years of age may not manufacture or attempt to manufacture, purchase or attempt
 to purchase, consume or have recently consumed other than during a religious
 service, be under the influence of, be in possession of, or furnish money to any
 person for the purchase of an alcoholic beverage, or.
- <u>A person under twenty-one years of age may not</u> enter any licensed premises
 where alcoholic beverages are being sold or displayed, except a:
- 16 <u>a.</u> <u>A</u> restaurant when <u>if</u> accompanied by a parent or legal guardian, or in;
- 17 <u>b.</u> <u>In accordance with section 5-02-06, or if</u>;
- 18 <u>c.</u> If the person is an independent contractor engaged in contract work;
- 19<u>d.</u>If the person is a law enforcement officer or other public official who enters the20premises in the performance of official duty; or if
- <u>e.</u> If the person enters the premises for training, education, or research purposes
 under the supervision of a person twenty-one or more years of age with prior
 notification of the local licensing authority.
- 24 <u>3.</u> A violation of this section is a class B misdemeanor.

- 1 <u>4.</u> The court may, under this section, may refer the person to an outpatient addiction 2 facility licensed by the state department of human services for evaluation and 3 appropriate counseling or treatment.
- 4 <u>5.</u> The offense of consumption occurs in the county of consumption or the county 5 where the offender is arrested.

6 SECTION 2. AMENDMENT. Section 5-02-06 of the North Dakota Century Code is
7 amended and reenacted as follows:

5-02-06. Prohibitions as to for persons under twenty-one years of age - Penalty 9 Exceptions.

- <u>1.</u> Except as permitted in this section, any licensee who dispenses alcoholic
 beverages to a person under twenty-one years of age, or who permits such a
 person to remain on the licensed premises while alcoholic beverages are being
 sold or displayed, is guilty of a class A misdemeanor, subject to sections 5-01-08,
 5-01-08.1, and 5-01-08.2. Any
- 15 A person under twenty-one years of age may remain in a restaurant where 2. 16 alcoholic beverages are being sold if the restaurant is separated from the room in 17 which alcoholic beverages are opened or mixed and gross sales of food are at 18 least equal to gross sales of alcoholic beverages which are consumed in the dining 19 area, or if the person is employed by the restaurant as a food waiter, food waitress, 20 busboy, or busgirl under the direct supervision of a person twenty-one or more 21 years of age and is not engaged in the sale, dispensing, delivery, or consumption 22 of alcoholic beverages.
- <u>3.</u> A person <u>under twenty-one years of age</u> may enter and remain on the licensed
 premises if the person is <u>an independent contractor engaged in contract work; if</u>
 <u>the person is</u> a law enforcement officer or other public official who enters the
 premises in the performance of official duty; or if the person enters the licensed
 premises for training, education, or research purposes under the supervision of a
 person twenty-one or more years of age with prior notification of the local licensing
 authority.

- <u>4.</u> Any person under twenty-one years of age may remain in an area of a site where
 beer, wine, or sparkling wine is sold in accordance with the conditions of an event
 permit issued pursuant to section 5-02-01.1.
- 45.Any person who is nineteen years of age or older but under twenty-one years of5age may be employed by the <u>a</u> restaurant <u>as provided in subsection 2</u> to serve and6collect money for alcoholic beverages, if the person is under the direct supervision7of a person twenty-one or more years of age, but may not be engaged in mixing,8dispensing, or consuming alcoholic beverages.
- 9 <u>6.</u> Any establishment where alcoholic beverages are sold may employ persons from 10 eighteen to twenty-one years of age to work in the capacity of musicians under the 11 direct supervision of a person twenty-one or more years of age.
