## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1. AMENDMENT.** Section 39-03.1-11.3 of the North Dakota Century Code 6 is amended and reenacted as follows:

7 **39-03.1-11.3.** Supplemental retiree benefit payment. If the board determines that 8 the fund has obtained a total return on investments of eleven and two tenths nine and 9 sixteen-hundredths percent or higher for the fiscal year ending June 30, <del>2005</del> 2007, or June 30, 10 2006 2008, and that the fund has the necessary margin to pay for the benefit, the board shall 11 authorize a payment to each retiree receiving benefit payments under this chapter as of the 12 date of the fiscal yearend in the amount of fifty percent of the retiree's then current monthly 13 benefit payment. The payment must be made the January following the fiscal yearend an 14 additional payment equal to seventy-five percent of the January retirement allowance following 15 the fiscal yearend to each eligible retiree in pay status as of that January, including joint and survivor and term certain beneficiaries, under this chapter. The board may only make one 16 17 payment under this section. 18 SECTION 2. AMENDMENT. Section 54-52-17.11 of the North Dakota Century Code is 19 amended and reenacted as follows: 20 54-52-17.11. Judges postretirement adjustments. A supreme or district court judge 21 or that person's beneficiary who, on December 31, 2001 2007, is receiving retirement benefits 22 under subdivision b of subsection 4 of section 54-52-17, is entitled to receive an increase in 23 benefits equal to two percent of the individual's present benefits with the increase payable 24 beginning January 1, 2002 2008. A supreme or district court judge or that person's beneficiary

1 who, on December 31, 2002 2008, is receiving retirement benefits under subdivision b of 2 subsection 4 of section 54-52-17, is entitled to receive an increase in benefits equal to two 3 percent of the individual's present benefits with the increase payable beginning January 1, 2003 4 2009. The increases allowed by this section may only be given if the public employees 5 retirement board determines there is actuarial margin sufficient to pay the increases. 6 SECTION 3. AMENDMENT. Section 54-52-17.13 of the North Dakota Century Code is 7 amended and reenacted as follows: 8 54-52-17.13. Supplemental retiree benefit payment. If the board determines that the 9 fund has obtained a total return on investments of eleven and two-tenths nine and 10 sixteen-hundredths percent or higher for the fiscal year ending June 30, 2005 2007, or June 30, 11 2006 2008, and that the fund has the necessary margin to pay for the benefit, the board shall 12 authorize a payment to each retiree receiving benefit payments under this chapter as of the 13 date of the fiscal yearend in the amount of fifty percent of the retiree's then current monthly 14 benefit payment. The payment must be made the January following the fiscal yearend an 15 additional payment equal to seventy-five percent of the January retirement allowance following 16 the fiscal yearend to each eligible retiree in pay status as of that January, excluding judicial 17 retirees and beneficiaries, but including joint and survivor and term certain beneficiaries, under 18 this chapter. The board may only make one payment to each retiree under this section.
