A BILL for an Act to amend and reenact section 57-20-07.1 of the North Dakota Century Code,
relating to information that must be included with annual property tax statements; and to provide

3 an effective date.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1. AMENDMENT.** Section 57-20-07.1 of the North Dakota Century Code is 6 amended and reenacted as follows:

7 57-20-07.1. County treasurer to mail real estate property tax statement -8 **Information to accompany property tax statement.** On or before December twenty-sixth of 9 each year, the county treasurer shall mail a real estate property tax statement to the owner of 10 each parcel of taxable real property at the owner's last-known address. The statement must be 11 provided in a manner that allows the taxpayer to retain a printed record of the obligation for 12 payment of taxes and special assessments as provided in the statement. If a parcel of real 13 property is owned by more than one individual, the county treasurer shall send only one statement to one of the owners of that property. Additional copies of the tax statement will be 14 15 sent to the other owners upon their request and the furnishing of their names and addresses to 16 the county treasurer. Such The tax statements statement must include a dollar valuation of the 17 true and full value as defined by law of the property and the total mill levy applicable for the immediately preceding taxable year and for the taxable year to which the tax statement applies. 18 19 The property tax statement must include, or be accompanied by, information showing for each 20 taxing district levying taxes against the property and for the consolidated levy by all taxing 21 districts levying property taxes against the property: 22 Taxes levied in dollars against the property in the immediately preceding taxable 1.

7	Failure of an owner to receive a statement will not relieve that owner of liability, nor extend the	
8	discount privilege past the February fifteenth deadline.	
9	SE	CTION 2. EFFECTIVE DATE. This Act is effective for taxable years beginning after
10	December 31, 2006.
