- 1 A BILL for an Act to create and enact chapter 43-56 of the North Dakota Century Code, relating
- 2 to creation of the allied health professions board; to provide an appropriation; and to provide a
- 3 penalty.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** Chapter 43-56 of the North Dakota Century Code is created and enacted
- 6 as follows:

- **43-56-01. Definitions.** In this chapter, unless the context otherwise requires:
- 8 <u>1.</u> "Allied health professions" means those clinical health care professions distinct
 9 from the medical profession and nursing profession.
- 10 <u>2.</u> <u>"Board" means the allied health professions board.</u>
- 11 <u>3.</u> <u>"Licensee" means an allied health professional licensed by the board.</u>
- 12 <u>43-56-02. Allied health professions board Membership.</u>
- 13 The allied health professions board consists of the members appointed by the 1. 14 governor. Except for the initial board members and the initial board members 15 representing a newly board-regulated allied health profession, the regular term of 16 office of each member of the board is three years, beginning on July first and ending on June thirtieth. The term of office of the initial board members and of the 17 18 initial board members representing a newly board-regulated allied health 19 profession may be for two, three, or four years in order to initiate a pattern of 20 staggered terms. Upon the expiration of a member's regular term, the board 21 member shall continue to serve until a successor is appointed and qualifies for 22 office. The governor shall fill all vacancies by appointment within thirty days of the 23 end of the regular term or within thirty days after receiving notification of the 24 unscheduled vacancy. In the case of a vacancy before the expiration of a term, the

1		appointment must be for the remainder of the term. A board member may serve
2		no more that two consecutive regular terms. The appointment of a board member
3		automatically terminates when the member ceases to meet the qualifications of
4		appointment. An individual appointed to board membership qualifies by taking the
5		oath required of civil officers.
6	<u>2.</u>	The governor may remove a board member for good cause after giving that
7		member a written statement of the reason for removal and after that member has
8		had an opportunity for a hearing.
9	<u>3.</u>	A board member may not participate in any matter before the board in which that
10		member has a pecuniary interest, personal bias, or other similar conflict of interest.
11	<u>43-</u>	56-03. Board membership - Appointment.
12	<u>1.</u>	The allied health professions board consists of members appointed by the
13		governor. The governor shall appoint board members to represent the allied health
14		professions as follows:
15		a. At least three and no more than five members who represent the general
16		public and who do not have any direct affiliation with the practice of an allied
17		health profession.
18		b. For each allied health profession regulated by the board, three members who
19		are licensed members of that profession or in the case of a newly regulated
20		profession without currently licensed members three members who will be
21		licensed members of that profession.
22	<u>2.</u>	Each member of the board must be a resident of this state.
23	<u>43-</u>	56-04. Board powers and duties.
24	<u>1.</u>	The allied health professions are allies in the health care team, working together to
25		make the health care system function.
26	<u>2.</u>	The board shall regulate the practice of each of the allied health professions the
27		board has been directed to regulate, including the issuances of licenses and the
28		regulation of licensees.
29	<u>3.</u>	Annually, the board shall select a president, a vice president, and any other officers
30		from among its members. The president shall preside at meetings of the board

1		and the vice president shall preside at meetings of the board in the president's
2		absence.
3	<u>4.</u>	The board shall meet at least once a year. Additional meetings may be held at the
4		discretion of the president, upon written request of any of the members or upon the
5		written request of the governor.
6	<u>5.</u>	The board may appoint or employ individuals as appropriate to assist the board.
7	<u>6.</u>	The board shall notify the governor of any unscheduled vacancy in the board
8		membership.
9	<u>7.</u>	The board shall deposit and disburse all fees and moneys collected by the board in
10		accordance with section 54-44-12.
11	<u>8.</u>	The board may adopt a seal.
12	<u>9.</u>	The board may adopt rules to administer this chapter.
13	43-	56-05. Petition to the board - Inclusion as an allied health profession.
14	<u>1.</u>	An existing occupational or professional board of this state or agency of this state
15		which regulates the practice of an allied health profession may submit to the allied
16		health professionals board a petition requesting inclusion of that allied health
17		profession as an allied health profession regulated by the allied health professions
18		board. Upon receipt of a petition submitted under this subsection, the allied health
19		professions board and the entity submitting the petition shall work together to
20		prepare a bill draft to accomplish this requested inclusion. For the next legislative
21		session following receipt of the petition, the allied health professions board shall
22		request introduction of the bill draft.
23	<u>2.</u>	Representatives of an allied health profession that is not regulated by an existing
24		occupational or professional board of this state or by an agency of this state may
25		submit to the allied health professions board a petition requesting inclusion as an
26		allied health profession regulated by the allied health professions board. Upon
27		receipt of a petition submitted under this subsection, the allied health professions
28		board shall determine whether to prepare and request introduction of a bill draft to
29		accomplish the requested inclusion.

1	43-56-06. Board member - Expenses. Each member of the board serves without
2	compensation but is entitled to reimbursement for expenses as provided by law for state
3	officers.
4	43-56-07. Administrative services - Governor. Until the board is directed to regulate
5	the practice of an allied health profession and collects fees in conjunction with this regulation,
6	the governor shall provide the board with appropriate administrative services as may be
7	requested by the commission.
8	43-56-08. Penalty. Any person that violates this chapter is guilty of a class B
9	misdemeanor.
10	SECTION 2. APPROPRIATION. There is appropriated out of any moneys in the
11	general fund in the state treasury, not otherwise appropriated, the sum of \$4,000, or so much of
12	the sum as may be necessary, to the governor for the purpose of funding the expenses of the
13	allied health professions board, for the biennium beginning July 1, 2007, and ending June 30,
14	2009.
