The Senate convened at 1:00 p.m., with President Dalrymple presiding.

The prayer was offered by Pastor Kris Nyman, Prince of Peace Lutheran Church, Beulah.

The roll was called and all members were present.

A quorum was declared by the President.

## MOTION

**SEN. KLEIN MOVED** that a committee of two be appointed to escort Thomas P. Cadmus, National Commander of the American Legion to the rostrum, which motion prevailed. The President appointed Sens. Thane and Bercier.

## REMARKS OF COMMANDER THOMAS P. CADMUS

President Dalrymple, President Pro Tem Grindberg, Majority Leader Stenehjem, Minority Leader O'Connell, distinguished guests, ladies and gentlemen. As I begin, let me take a moment to introduce members of the American Legion family who are with me today. The Commander of the North Dakota American Legion, Willis Pritchard. The American Legion Service Officer of the North Dakota American Legion, Jim Demero. The National Executive Committeeman for the American Legion of North Dakota, Curtis Twete.

I am honored to stand before you today. On behalf of the 23,000 Legionnaires here in North Dakota and the 2.7 million Legionnaires around the world, I want to thank each of you. The American Legion and the people of North Dakota have enjoyed a special camaraderie in working together to benefit communities around the state - particularly those programs that benefit North Dakota's youth. I don't know how many of you know it, but it was the American Legion that first offered the governor's job to John Hoeven. No, not state governor. Governor of American Legion Boy's State when he was a young high school student. Apparently he liked the opportunity.

Ever since, Governor Hoeven has been a strong supporter of the many programs of the American Legion and veterans of North Dakota. We are grateful to him for recording a public service announcement promoting the American Legion Boy's State program to today's students across the state.

However, I am here today to personally thank each of you for your work in supporting veterans throughout the state. Caring for those who have gone in harm's way on our own behalf is the least we can do. Terrorism remains alive and well. Its tentacles have reached out around the world. Bin Laden is still on our most wanted list. His people remain committed to kill as many of us as they can. Thank God there are brave young Americans stepping up to the plate, donning a military uniform, and willing to put all on the line to preserve our way of life, wherever necessary.

And sadly, almost daily, we learn that too many make the ultimate sacrifice for their country. For us. For freedom. For America. We must never forget them. We shall never forget them. But perhaps our most pressing responsibility is to make sure our warriors of today receive the benefits they earned and so richly deserve.

Recently, I visited Walter Reed Army Medical Center in Washington. I talked with young soldiers who had lost limbs in combat in Iraq. I was awestruck as each of them were proud to serve and wished only to return to their battle buddies in Iraq and Afghanistan. Sadly, many will be unable to continue their military careers. They will be discharged to return home. They will look to the Department of Veterans Affairs health care system to take up where the Department of Defense left off. The problem is, VA may not have the funding or resources to welcome them into the system. The current appropriations process is broken and not adequately funding VA medical care.

The American Legion and eight other veterans' organizations believe the answer lies in changing VA health care funding from discretionary to mandatory. We intend to devote all our efforts into working with the 109th Congress to bring this objective to fruition. Guaranteed full

funding for the VA health care system is not about politics - it is a realization that taking care of America's sick and disabled veterans is a continuing cost of national defense.

I urge you to continue to ensure the North Dakota Department of Veterans Affairs will have the funding it needs to be there for those who have served in our armed forces. Since Company A, First Regiment, of the North Dakota National Guard was organized in Bismarck, Dakota Territory, in 1883, North Dakotans have served with honor and distinction here at home and in each of our nation's armed conflicts. I am told that today, over half of North Dakota's National Guard have been activated and are continuing that legacy with courage and commitment. All of them are truly America's heroes. They are making North Dakota proud. They are making their fellow veterans of the American Legion very proud. And all of you are great Americans for your unwavering support of them and their families.

I understand you are considering two bills for North Dakota National Guard veterans of military service in Iraq and Afghanistan. When young soldiers return home, they can really use two things: money and education. In passing bills to authorize a cash bonus as well as a tuition offset for college, you are giving them a terrific tribute and a very tangible expression of appreciation for their service that they will never forget.

The American Legion applauds you for this action. These are important benefits that will be appreciated by the troops and will enable all North Dakotans to show their thanks to these outstanding citizen soldiers. Your support for all the veterans of North Dakota, of years past and present, has been a hallmark of this body. You have staunchly provided for North Dakota's veterans' cemeteries, a last tribute to their commitment to service. It is sincerely appreciated by those left behind to honor their memories.

Lastly, as you know, SJR 4, the flag protection amendment, was regrettably never brought to the floor of the United States Senate in the closing hours of the 108th Congress. I just wanted to let you know the American Legion will be back with the 109th Congress to finally get the measure passed into law. Why? Because it's the right thing to do. North Dakota was one of the first states to pass a "Memorializing Resolution" supporting an amendment to the U.S. Constitution to restore to Congress the right to protect the U.S. Flag from physical acts of desecration.

I am aware that you are ready to act once again when the U.S. House and U.S. Senate pass it in the 109th Congress and send it here for ratification. It is my belief that once the proposal finally gets to the states, it will become the quickest amendment ever ratified, and rightfully so.

And finally, if any of you are wartime veterans, I just happen to have American Legion application forms in my pocket. We'd love to have you join us. I thank you for all that you do for North Dakota, its veterans and their families. May God bless you as you continue the work of the people during this 59th legislative assembly.

Beef marketing program - Establishment. The agriculture commissioner shall establish a source-verified and process-verified beef marketing program in consultation with the state board of animal health, the North Dakota stockmen's association, the North Dakota state university beef systems center of excellence, and the United States department of agriculture.

**SECTION 2. AMENDMENT.** Section 4-14.1-03.1 of the North Dakota Century Code is amended and reenacted as follows:

**4-14.1-03.1. Agricultural products utilization commission - Authority.**

1. The North Dakota agricultural products utilization commission may apply for, accept, and expend any appropriation, grant, gift, or service made available from public or private sources consistent with the purpose of this chapter.
2. The commission may administer grant programs consistent with the purpose of this chapter including:
  - a. A basic and applied research grant program;
  - b. A utilization and marketing grant program;
  - c. A cooperative marketing grant program;
  - d. A nature-based tourism grant program;
  - e. A technical assistance grant program for value-added businesses;
  - f. A farm diversification grant program;
  - g. An agricultural prototype development grant program; and
  - h. A North American marketing grant program.
3. ~~The As a condition of the grant, the commission may require, by contract, repayment of a grant, in whole or in part, that the recipient repay some or all of the grant if the grant recipient does not fulfill the conditions under which the grant was awarded of the grant. Repayment may be monetary or may be of any other type or method determined by the commission to be in the public interest.~~

**SECTION 3.** A new section to chapter 6-09 of the North Dakota Century Code is created and enacted as follows:

Livestock loan guarantee program - Establishment - Rules.

1. The Bank of North Dakota shall establish and administer a livestock loan guarantee program that is designed to expand livestock feeding in this state.
2. Under the program, the Bank may guarantee a loan made by a bank, a credit union, a savings and loan association, or any other lending institution in this state to the owner of a commercial feedlot that backgrounds or feeds cattle to harvest-ready weight. In the event of a default, the Bank shall pay to the lender the amount agreed upon, provided that the amount may not exceed eighty-five percent of the principal due the lender at the time the claim is approved.
3. The Bank shall adopt rules governing additional terms, conditions, and procedures necessary to meet the requirements of this section. The rules must include an administrative fee payable to the Bank and must provide that equity requirements may not exceed fifteen percent.

**SECTION 4. AMENDMENT.** Subsection 1 of section 57-38.6-01 of the North Dakota Century Code is amended and reenacted as follows:

1. "Agricultural commodity processing facility" means a facility that through processing involving the employment of knowledge and labor an agricultural operation that adds value to an agricultural commodity capable of being raised in this state and includes dairy operations, livestock feedlot operations, and swine feeding and finishing operations.

**SECTION 5.** A new section to chapter 57-39.2 of the North Dakota Century Code is created and enacted as follows:

Sales tax exemption - Production livestock facility construction.

1. Gross receipts from the sale of machinery, equipment, and structural materials incorporated into a new or expanding production livestock facility during or at the time of the facility's construction are exempt from taxes

under this chapter for the period beginning after June 30, 2005, and ending as of July 1, 2009.

2. The owner of the production livestock facility may apply to the commissioner for a refund of any taxes paid by a contractor, subcontractor, or builder if those taxes are claimable as an exemption under this section. The application for a refund must be made at the time and in the manner directed by the commissioner.
3. If the production livestock facility is not operational as a production livestock facility within five years from the date of the earliest refund to the facility's owner under this section, the owner of the facility is liable for the repayment of all exemptions granted to the owner under this section.
4. For purposes of this section, "livestock" means beef and dairy cattle, hogs, poultry, and sheep and "production livestock facility" does not include grain bins or other storage structures incidental to livestock production.

**SECTION 6.** A new section to chapter 57-39.5 of the North Dakota Century Code is created and enacted as follows:

Gross receipts tax exemption - Production livestock facility construction - Farm machinery and equipment. Gross receipts from the sale of farm machinery and equipment incorporated into a new or expanding production livestock facility at the time of the facility's construction and used exclusively in the production livestock facility are exempt from taxes under this chapter for the period beginning after June 30, 2005, and ending as of July 1, 2009. For purposes of this section, "livestock" means beef and dairy cattle, hogs, poultry, and sheep.

**SECTION 7. REPORT TO COMMITTEES.** Between the first and tenth legislative days of the regular session of the sixtieth legislative assembly as selected by the legislative council, the agriculture commissioner, the Bank of North Dakota, and the North Dakota stockmen's association shall provide a joint report regarding the livestock loan guarantee program to the standing agriculture committee of each house of the legislative assembly.

**SECTION 8. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$100,000, or so much of the sum as may be necessary, to the agriculture commissioner for the purpose of administering the beef marketing program, for the biennium beginning July 1, 2005, and ending June 30, 2007.

**SECTION 9. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$100,000, or so much of the sum as may be necessary, to the agriculture commissioner for the purpose of administering the farmers' market development and promotion program, for the biennium beginning July 1, 2005, and ending June 30, 2007.

**SECTION 10. EXPIRATION DATE.** Section 3 of this Act is effective through June 30, 2009, and after that date is ineffective."
