Bismarck, January 27, 2005

POINT OF PERSONAL PRIVILEGE

REP. GLASSHEIM: Mr. Speaker: I rise on a point of personal privilege.

On this the 60th anniversary of the liberation in southern Poland of Auschwitz concentration camp, on January 27, 1945, I rise to remember those who died in the Holocaust. Over a 12 year period the government of Germany organized its people to hate and murder six million Jews as well as Poles, Soviet prisoners, Gypsies, homosexuals and disabled people.

As we remember the holocaust and the words often repeated by Auschwitz survivors..."Never again, Never again," we are ashamed to admit that since 1945 we have looked the other way as new examples of genocide swirled around us in Rwanda, Cambodia, Bosnia, the Darfur region of the Sudan. We know we are often weak, and frightened to help others, but on days like this we must rededicate ourselves to extending our hand to those who are forgotten.

Each person takes away something different when they look the horror of Auschwitz in the face. As I contemplate the 60th anniversary of the liberation of Auschwitz, three thoughts come to mind:

*that government leaders often stimulate hatred for some enemy in order to keep power;

*that we must have trained and skeptical minds, because the highest sounding reasons can be used to justify the worst actions;

*that solidarity with all humans in dire straits may require us to move beyond our immediate comfort zone.

At this time let me recite, in Hebrew, the **mourner's kaddish**, the prayer for the dead, which, despite sorrow and loss, praises and magnifies God:

Yit-gadal v'yit-kadash sh'mey raba, b'alma di v'ra hirutey, vyam-lih mal-hutey b'ha-yey-hon uv'yomey-hon uv'ha-yey d'hol beyt yisrael ba-agala u-vizman kariv, v'imru amen.

Y'hey sh'mey raba m'varah l'alam ul'almei alma-ya.

Yit-barah v'yish-tabah v'yit-pa-ar v'vit-romam v'vit-na-sev v'yit-hadar v'yit-aleh v'yit-halal sh'mey d'kud-sha, b'rih hu, leyla min kol bir-hata v'shi-rata tush-b'hata v'ne-hemata da-amiran b'alma, v'imru amen.

Y'hey sh'lama raba min sh'ma-ya, v'ha-yim aleynu v'al kol yisrael, vimru amen.

Oseh shalom bim-romav, hu ya-aseh shalom aleynu v'al kol yisrael, v'imru amen.

May He who ordains harmony in the universe grant peace to us and to all Israel. And Let us say: Amen.

4. The department shall assign to a provider's request for review someone other than any individual who was involved in the initial denial of the claim. A provider who has requested review may contact the department for an informal conference regarding the review anytime before the department has issued its final decision.

5. The department shall make and issue its final decision within seventy-five days of receipt of the notice of request for review. A provider may appeal the final decision of the department to the district court in the manner provided in section 28-32-42. The judgment of the district court in an appeal from a request for review may be reviewed in the supreme court on appeal by any party in the same manner as provided in section 28-32-49.
6. Upon receipt of notice that the provider has appealed its final decision to the district court, the department shall make a record of all documents, written statements, exhibits and other written information submitted by the provider or the department in connection with the request for review and the department's final decision on review, which constitutes the entire record. Within thirty days after an appeal has been taken to district court as provided in this section, the department shall prepare and file in the office of the clerk of the district court in which the appeal is pending the original and a certified copy of the entire record, and that record must be treated as the record on appeal for purposes of section 28-32-44."

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new section to chapter 49-05 of the North Dakota Century Code is created and enacted as follows:

Advance determination of prudence. A public utility proposing to construct, lease, or make improvements to an energy conversion facility, renewable energy facility, transmission facility, or proposed energy purchase contract from another entity or person for the purpose of ensuring reliable electric service to its customers may file an application with the commission for an advance determination of prudence regarding the proposal. The commission may order that expenses associated with investigating the application made by the public utility for prudence of a resource addition be paid by the public utility in accordance with section 49-02-02.

1. The commission may issue an order approving the prudence of an electric resource addition if:
 - a. The public utility applies for a prudence determination before commencement of construction or purchase of an electric resource addition;
 - b. The public utility files with its application a projection of costs to the date of the anticipated commercial operation of the electric resource addition;
 - c. The commission provides notice and holds a hearing, if appropriate, in accordance with section 49-02-02; and
 - d. The commission determines that the resource addition is reasonable and prudent.
2. The commission order must be rendered no later than seven months after the public utility files its application requesting a prudence determination of an electric resource addition.
3. A resource addition approved by the commission is subject to annual reporting requirements until commercial operation of the resource addition.
4. Before commercial operation of the resource addition, the public utility shall make a general rate case filing with a full cost of service analysis including the resource addition in accordance with section 49-05-05. The commission's order determining prudence of the resource adjustment is binding for ratemaking purposes.
5. If at any time following an initial commission order, the commission, following a subsequent hearing, determines that continuation of a project is no longer prudent or that its prior order should be modified, the public utility may recover in its rates, and in a timely manner consistent with the public utility's financial obligations, the amounts the public utility already has expensed, incurred, or obligated on a project, including interest expense and a return on equity invested in the project up to the time the new order is entered even though the project may never be fully operational or used by the public utility to serve its customers."
