REMARKS OF SENATOR WARNER

Today, April 7th, marks the 200th anniversary of the first letter to be posted from North Dakota. On that day, as today, the weather was warming, the ice on the Missouri was breaking up and the keelboat was preparing to return to St. Louis. Meriwether Lewis wrote one last letter to his mother from a site a few miles north of here.

He wrote: "I must request of you before I conclude this letter, to send my brother John Markes to the college at Williamsburg as soon as it shall be thought that his education has been sufficiently advanced to fit him for that school for you may rest assured that as you regard his future prosperity you had better make any sacrifice of his property than suffer his education to be neglected or remain incomplete."

We, here in this place as Lewis in his, have education on our minds. In the coming days we will make fundamental decisions that will determine if a new generation of our brightest and best will become teachers or leave for greener fields. We will decide if our colleges and universities educate well-rounded individuals capable of advancing the human condition in a liberal democracy or become trade schools for white collar workers.

We, here in our time as Lewis in his, face and uncertain future. The boat that would take us back to where we were has left and we have no choice but to go forward into an unknowable future, armed with courage, curiosity and intelligence. We, like Lewis, will carry with us the best scientific knowledge and instruments of our day. We will see wonders we could not have imagined and face dangers that could destroy us. Along the way, we will learn to rely on people who are strange to us, with a different color skin, different customs and cultures. From each other we will learn not merely to survive but to grow and prosper.

Mr. President, Members of the Senate: The weather is warming, the ice is breaking up and we are restless to be on our way. But before we go, let us here, in our time, remember the importance of education. Let us here, in our time, embark on our own Voyage of Discovery.

This amendment also:

- Provides that any unspent general fund appropriation relating to the \$5 million appropriated for the payment of adjusted compensation to veterans be transferred to the Veterans' Cemetery trust fund during the 2007-09 biennium, as provided by the House. The Senate provided that any unspent general fund appropriation relating to the adjusted compensation be retained by the Adjutant General for continuing bonus needs.
- Adds a section appropriating \$4 million of federal funds to the Adjutant General for the remainder of the 2003-05 biennium for completing construction projects at federally supported facilities and roads. The Senate added a section appropriating \$3 million of federal funds to the Adjutant General for the remainder of the 2003-05 biennium.

REPORT OF CONFERENCE COMMITTEE

HB 1290: Your conference committee (Sens. Syverson, Trenbeath, Nelson and Reps. Bernstein, Maragos, Onstad) recommends that the **SENATE RECEDE** from the Senate amendments on HJ page 1216, adopt amendments as follows, and place HB 1290 on the Seventh order:

That the Senate recede from its amendments as printed on page 1216 of the House Journal and pages 878 and 879 of the Senate Journal and that House Bill No. 1290 be amended as follows:

Page 1, line 7, replace "a person" with "an individual"

Page 1, line 9, replace "person" with "individual" and remove ", at the individual's own cost,"

Page 1, line 12, after the period insert "The court shall provide notice to the selected provider of the required examination or testing. The provider shall notify the court if the individual fails to appear for the examination or testing. The testing must be at the individual's own cost. Submission of an individual to a medical examination or other reasonable random testing as a condition for release is not required if the court makes a specific finding on the record that:

- The individual has not been arrested for a felony offense relating to the use, possession, manufacture, or delivery of methamphetamine;
- The individual will appear as required by the court and will comply with all conditions of release without submission to an examination or testing; and

3. Not imposing examination or testing as a condition of release will pose no danger to the individual or to the community."
