- 1 A BILL for an Act to create and enact three new sections to chapter 15.1-27 of the North Dakota
- 2 Century Code, relating to the calculation of school district transportation payments.

4 SECTION 1. A new section to chapter 15.1-27 of the North Dakota Century Code is

5 created and enacted as follows:

Transportation payments - Determination - First year of biennium.

- During the first year of the 2005-07 biennium, the superintendent of public
 instruction shall:
- 9 a. Determine the amount of state transportation aid that the school district
 10 received during the second year of the 2003-05 biennium; and
- b. Determine the amount of state transportation aid to which the district would be
 entitled, using data envelopment analysis, for transportation services provided
 to students during the second year of the 2003-05 biennium.
- 14 2. If the amount in subdivision b of subsection 1 is greater than the amount in
- subdivision a of subsection 1, the superintendent of public instruction shall forward
 to the school district an amount equal to:
- 17 a. The state transportation aid that the school district received during the second
 18 year of the 2003-05 biennium; plus
- b. One-third of the difference between the amount received under subdivision a
 and the amount to which the district would be entitled, using data
- 21 envelopment analysis, for transportation services provided to students during
