REENGROSSED HOUSE BILL NO. 1110

1 A BILL for an Act to create and enact a new section to chapter 50-06 of the North Dakota

2 Century Code, relating to duties of the department of human services with respect to least

3 restrictive care options; to amend and reenact sections 25-03.2-03.1 and 50-11-02.3 of the

4 North Dakota Century Code, relating to extending the moratorium on expansion of residential

5 treatment center for children bed capacity and residential child care facility or group home bed

6 capacity; to provide an effective date; and to declare an emergency.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

8 **SECTION 1. AMENDMENT.** Section 25-03.2-03.1 of the North Dakota Century Code 9 is amended and reenacted as follows:

10 25-03.2-03.1. (Effective through June 30, 2005 July 31, 2007) Moratorium on 11 expansion of residential treatment center for children bed capacity. Notwithstanding 12 sections 25-03.2-03 and 25-03.2-08, unless a needs assessment conducted by the department 13 indicates a need for the licensing of additional bed capacity, the department may not issue a 14 license under this chapter for any additional bed capacity for a residential treatment center for 15 children above the state's gross number of beds licensed as of June 30, 2003. 16 **SECTION 2.** A new section to chapter 50-06 of the North Dakota Century Code is 17 created and enacted as follows: 18 Placement of children - Least restrictive care. The department and county social service boards shall thoroughly explore the option of kinship care when a child is unable to 19

20 return home due to safety concerns. Absent kinship options, the department and county social

21 service boards shall provide permanency options that are in the least restrictive care and near

22 the family's home as required by the federal Adoption and Safe Family Act of 1997 [Pub. L.

23 <u>105-89; 111 Stat. 2115; 42 U.S.C. 671]. Before January 1, 2006, the department of human</u>

24 services shall issue a request for proposal for the provision of residential treatment services to

1 meet the needs of youth with a history of sexual offenses within the state and explore options of

- 2 therapeutic foster care for those youth who would benefit from this service level.
- 3 SECTION 3. AMENDMENT. Section 50-11-02.3 of the North Dakota Century Code is
 4 amended and reenacted as follows:
 - 50-11-02.3. (Effective through June 30, 2005 <u>July 31, 2007</u>) Moratorium on
- 6 expansion of residential child care facility or group home bed capacity. Notwithstanding
- 7 sections 50-11-02 and 50-11-09, unless a needs assessment conducted by the department
- 8 indicates a need for the licensing of additional bed capacity, the department may not issue a
- 9 license under this chapter for any additional bed capacity for a residential child care facility or a
- 10 group home above the state's gross number of beds licensed as of June 30, 2003.
- 11 SECTION 4. EFFECTIVE DATE. This Act becomes effective on July 1, 2005.
- 12 **SECTION 5. EMERGENCY.** This Act is declared to be an emergency measure.
