Rep. Kretschmar: I'm giving this because of all of us who serve in the legislative assembly. Now that four year terms are given to the district chairs and political parties chairman. Under current law each April of an odd number year, the district party reorganizes in each of our legislative districts. Under the provisions of 1255, each district party would now reorganize every four years in the April of the year after that district's legislators are elected. If this bill were law today, next April just the odd number districts would reorganize. This bill, if it follows the normal course, would become law after the 2008 election, when the even number districts elect their legislators. All the legislators would now be elected for four years. It just becomes logical at least that our district organization should be four year terms. That is basically what the bill does and it's up to you people on the committee to determine if you want to do that.

Rep. Karls: Has there been a large outcry from the district chairman to run for four year

Rep. Kretschmar: I have not heard it but I think in our district it would be worth it.

Rep. Karls: Would this be mandatory t hen for all districts? Or would each district have a choice? I'm thinking ahead to maybe a person doesn't want to commit to four years.

Rep. Kretschmar: If the bill was passed as is, it would require each district.

Rep. Haas: Any other questions?

Rep. Potter: To add to what Rep. Karls was asking, if a district elected a chair for a four year term, and that chair chose to step down, there wouldn't be anything saying they couldn't resign?

Rep. Kretschmar: People in those positions can resign or move over whenever they want to.

Most districts would have someone to step in during that term.

Rep. Amerman: Are we talking about the same thing, districts and precincts?

Rep. Kretschmar: It also affects the precinct committee persons. Under the statute it would be locally.

Rep. Haas: Is there additional testimony to HB 1255? If not we will close the hearing on HB 1255.

Rep. Haas: This is the bill about allowing political parties at the local precinct and district level to serve four years terms rather than two year terms. What are your wishes.

Rep. Amerman: I don't stand in opposition so to speak on this, but I do have my concerns. In the last general election was probably the lowest voter turn out that we've had in ND. I know in rural areas it is harder at times to generate interest as far as politics and to keep the citizens fired up. At least every two years we get an opportunity to get together and organize. In the rural areas it is definitely like that. With this you would have to go every four years which would get the citizens another two years to get lulled to sleep. That is my concern.

Rep. Haas: The fact that they serve four year terms would certainly not preclude the district in having more frequent meetings. It would simply mean the reorganization meetings would have to occur every four years.

Rep. Karls: I have the same concerns. I know that it is hard for rural counties to even find a place to hold the meetings. But personally, living in Bismarck, I would have a hard time getting precinct committee people to commit to four years. I have been the district chairman 10 years and I don't see anybody out there that wants my job. Maybe we could make that not mandatory but voluntary, let the people decide. We need flexibility.
