Chairman Herbel opened the hearing on HB 1284.

Rep. Nancy Johnson Introduced bill. Bill says if you are both on a county commission and the city governing board and there is a conflict that arises between both boards, which one do you support?

Al Jaeger, Secretary of State: The introduction of this bill was not directed at any person, city, or county. It merely came out of a discussion with other elected officials from a conflict of interest. (see attached testimony #1) See attached amendment with this. Zoning was some of the overlapping interest because the city stretches out into the county.

Rep. Lee Kaldor In a situation in the city where a county commissioner acted against the wishes of the city or in conflict with what would be their best interest. Wouldn't the election process actually solve that problem? It seems that the electors in the city with have the option to vote for another candidate?

Al Jeager: I don't disagree. When you are in that position and something does come up I understand the only way you can be excused from the vote is that you physically remove yourself from the situation until the vote is taken. Did someone get short changed there?

More concerned about the city county issues.

Rep. Kim Koppelman Is there any where in ND right now dealing with public officials where we have this limitation where some one is serving in one office and also in another office.

Al Jaeger: I am not sure there is? I am sure people are going to say this is a bill looking for a problem to solve. I think it is worth discussion.

Rep. Kim Koppelman People in the legislature holds other offices. On one hand we value the knowledge they bring in county and city government. I can see the county and city government could be a problem and can the election process take care of that. My other question with regard to conflict of interest. We do have provisions in the legislature where we can be excused from voting. Do those not exist in county commissioners?

Al Jaeger: There seems to be some counties where that is an issue. Because I serve on some boards in my position, I asked that question and was told that abstaining was not an option. My understanding is I cannot serve on my boards and abstain.

Rep. Kim Koppelman Do you think it might open a door people would not be able to serve on the legislature or county commissioners at the same time?

Al Jaeger: I don't know.

Rep.Dwight Wrangham I am interested in zoning being a place where there could be some conflicts. The cities like Bismarck actually exercising the zoning four miles outside of their jurisdiction. Do you have more specifics on how it could be affecting the zoning areas?

Al Jaeger: I have no specifics. I would guess at the time that residences of the county aren't too keen about the decisions that are made in the city. If you have the same individual on both boards, are they representing the city or county and the greater good?

Rep. William Kretschmar If this bill became law we would allow them to serve out their terms. Would it be better or different, maybe we should have the people in those positions have 30 days to resign their offices

Al Jaeger: The citizens voted and so that individual should be able to serve out their term.

That is why we extended it through the term.

Rep. Lawrence Klemin: Once this began law, this would be some type of qualification. If we had a county commissioner that wanted to run for the city, if this was law they could not serve both of them. The second sentence says you violate both positions and in light of the amendment you have on here which is going to allow those people affected to serve out their terms, we should not have any situation where this arises so do we really need that sentence.

Al Jaeger: About a half hour ago I looked at the amendment and I think your point is well taken. Rep. Lawrence Klemin did make a good statement. If I am a city commissioner and want to run for county commissioner; than if I am elected I have made a choice. That is to

Discussed need to try to work this out without giving up the need to have people who want to serve in elected capacities.

Rep. Lawrence Klemin I can see a couple of situations in the area of property taxes where we may have a constitutional due process of law issue. For example, in the area of tax equalization where we have a local board of equalization that looks at someone who wants to go to their taxes are correctly assessed on their property; city acts as the local board of equalization and then if they decide against you you can go to the county board of equalization as the next step. When that happens and you see the same person there that turned you down at the city level aren't you have your constitutional right to due process of law violated?

Jerome Gruenberg, Mayor of Burlington, ND and a Ward County Commissioner. I was elected mayor of Burlington in 1988. I have been elected 5 times. I was elected as county commissioner in 1999 and been elected 3 times. I was approached to run for these positions. I did not seek them out. Discussed full disclosure on running for these offices with no problems. I have had a program with the schools in DeLacs trying to get young people to run for offices. This bill is a clear message to these people who are not wanted in these positions. If you have people that want to run for these offices you better be using these. We need to keep getting people involved. As far as the conflict on interest. We have mechanism to take care of that and it is integrity. If a conflict comes up, I excuse myself. How many of you set on several boards. I set on at least a dozen. When will this move forward to the next level of government? The people have elected me eight times. If there is conflict it will be handled at the ballot box. I would appreciate it if this bill would go down; it makes no sense.

Rep. Lawrence Klemin Do you find there are advantages to serving on both boards? **Jerome Grumberg:** That mix does help.

RE: HB 1284 - Serving on both City and County Governing bodies at the same time

First, I want to make it clear for the record that the introduction of this bill was not directed towards any person, city, or county.

Second, some people might even suggest this is a bill in search of a problem to solve. That could be true.

Third, since the voters have voted the same person to a position on each governing body, isn't that their choice to make? That is also true.

Nevertheless, I believe a valid question remains, which is deserving of discussion. That is, is it possible for one person to provide equal and impartial representation to the interests of the citizens who elected him or her to a city position and to the voters who elected that same individual to a county position?

When both governing bodies are making a decision on an issue affecting both political subdivisions, how does that person make his or her decision? Or, stated another way, if a favorable decision on a particular issue would be in the best interests of the entire county but not for the city, which constituency will that person represent?

This situation seems to be unique to the city and county relationship because of overlapping jurisdictional responsibility. For example, among others issues, city and county interests may differ on zoning or waste management issues.

Since the bill was introduced, I learned there are at least three individuals currently serving on both a city and county governing board at the same time. To accommodate those situations, I have attached an amendment to allow them to serve out the respective terms of office.

PROPOSED AMENDMENTS TO HOUSE BILL NO. 1284

- Page 1, line 10, after the period insert "This restriction does not prevent an individual whose terms of office commenced before the effective date of this Act from serving the remainder of those terms."
- Page 1, line 16, after the period insert "This restriction does not prevent an individual whose terms of office commenced before the effective date of this Act from serving the remainder of those terms."

CONCERNING HOUSE BILL 1284

Chairman Herbel and members of the Committee, the North Dakota Association of Counties is here today to oppose House Bill 1284.

First, I would like to acknowledge The Secretary of State and all the work he and his staff have done on behalf of counties especially in the election arena.

The reason for our opposition is two fold. First, this legislation attempts to address an issue that is not an issue. Currently, there are 221 total county commissioners. In a survey done by NDACo recently, only 4 county commissioners are also serving as city board members. Three other counties responded that they have had this dual representation before but not currently. Therefore, this is just not something that has become a critical issue.

Secondly, and more to the heart of the matter, in all of these cases the elected official was just that.....elected. In some of these jurisdictions finding not only qualified candidates but those willing to serve and give back to their communities can be difficult. Why should those who have been legitimately chosen by the people be barred from serving?

The basis of this bill is presumably to keep individuals from being involved in situations where there could be a conflict of interest. However, what this bill does not take into account is that conflicts of interest can arise in any situation and then it becomes the responsibility of that individual to take the appropriate steps to eliminate that conflict.

What happens if they do not? Then the voters can hold them accountable. Legislating simple solutions to conflicts of interests does not solve the issue and may even create a larger issue by barring otherwise well qualified and community minded individuals from giving back to their communities.

For the following reasons I ask that you do not support House Bill 1284.
