Sen. Urlacher called the committee to order and opened the hearing on SCR 4021.

<u>Sen. Cook</u>: prime sponsor of the bill appeared in support stating this resolution simply requires or asks allows for the Legislative interim committee to study the possibility of eliminating ND2.

<u>Donita Wald</u>: Tax Dept. appeared in support stating we are getting fewer and fewer tax payers who are using that form, we are seeing more and more tax credits being placed on that form, one of which is long term care insurance that really made a difference for those using the long form.

Sen. Urlacher: what was the percentage of usage on the long form?

Donita: 2005 it was 2% which was 7190 tax payers.

Sen. Horne: is it accurate then if that isn't specifically addressed in a bill that you only qualify for a tax credit if your using the long form to prepare your taxes?

Donita: that's correct, there is a statute in the short form section 57-38-30.3 which says you do not get any credits or deductions unless they are specifically placed in that section of the law.

Senator Dwight Cook, Dist. 34: This is a bill that requires an interim study on personal income tax forms ND 1 and ND 2. We studied this prior to the 2005 session and we had legislation in 2005 that would eliminate ND2. It failed. I'm hoping with this study that we try it again. Only the difference is that this time we do it in attempt where we judge the feasibility of moving many, not all, of the credits in ND2 over to ND1 and see what type of effect that would have. The time is probably right with all the talk that is going on right now about income tax reform.

Rep Weiler: Could this study also include elimination of income tax.

Cook: Not the way it's written. But it's in your hands now.

Chairman Belter: That can always be requested during the study.
