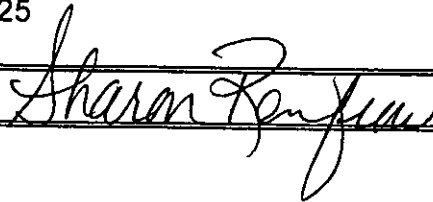

Minutes:

Sen. Urlacher called the committee to order and opened the hearing on SCR 4031.

Sen. Cook: Prime sponsor of the bill appeared in support stating this addresses the number 1 reason why ND property taxes are so high and that's because North Dakotan's have a tremendous appetite for local government. This brings this issue to the table, gets the people involved that are providing these services at that table have a good discussion of them and see if there is in some areas we might efficiencies and ways of lowering people's property taxes.

Sen. Urlacher: the interim committee took a hard look at all the property tax effects.

Sen. Horne: could this mean potentially combining counties for example? What other examples are you thinking of?

Sen. Cook: I look down underneath a lot of services that counties give for example. Maybe there are services that aren't being provided by the right level of government, maybe some services where the State has taken over certain services that used to be provided by the county. All of that reduces property taxes.

Rep. Weiler: co-sponsor appeared in support stating that the resolution speaks for itself, it could an issue with local governments just the same as it is with state governments.

Rep. Kasper: co-sponsor appeared in support stating one of the things that I believe is a problem is the formula, look at line 13 of the resolution where we talk about property taxes have increased faster than the increase in other taxes and inflation. It's my belief that the formula particularly in the residential side both calculate property taxes is wrong and needs to be corrected.

Sen. Tollefson: can you foresee a study of the taxation policy from the stand point that add valorum taxes, all property be taxed on an advalorum basis or some other basis?

Answer: that's a good question and it may also be of something to which you look at the scope of the bill. I think we need to look at all possibilities of where we should be going with out tax policy in the future.

Connie Spryncynatyk: ND League of Cities appeared in support wondering if it was broad enough and had concerns with line 11 with at least regard of cities. Handed out some pie charts. (See attached)

Bill Wocken: City of Bismarck appeared in support stating the City of Bismarck has accomplished a number of consolidations in government services.

Terry Traynor: Assoc. of Counties appeared in support and feels it's a good opportunity to share what counties are doing with the legislature and with other counties.

Sen. Cook: have you seen struggling with getting some counties to combine their jails that could be made easier or removed if we had some minor tweaking to the Century Code?

Answer: I've been involved but don't know if involved closely enough to say if that's a problem. Some the challenges are financial, structural and maybe this could be addressed as well.

Larry Syverson: Mayville farmer, appearing neutral with written testimony. (See attached)

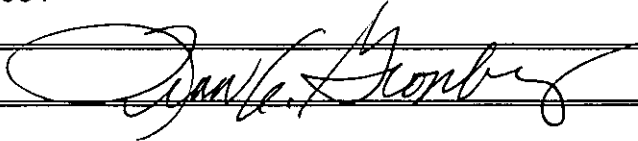

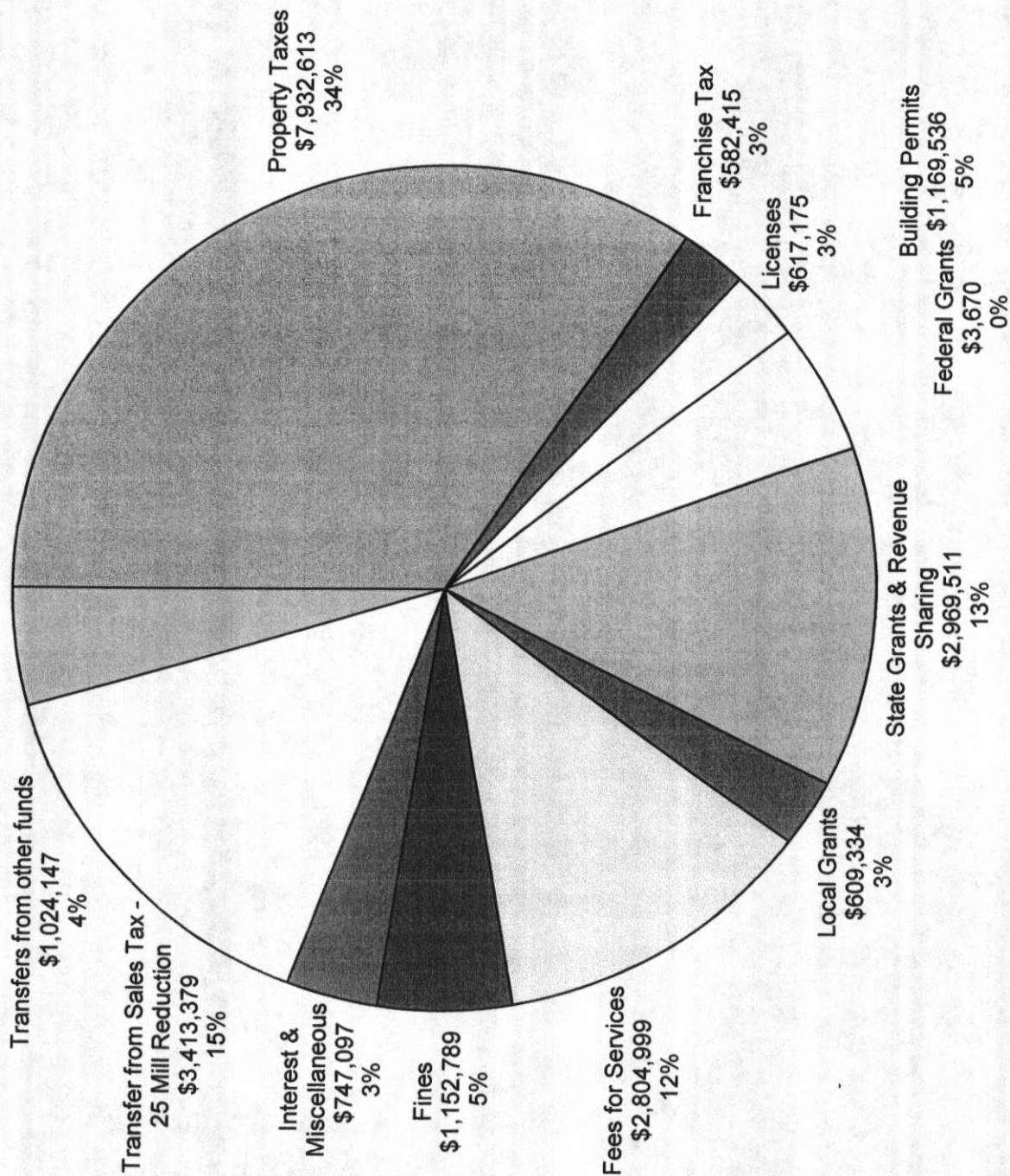

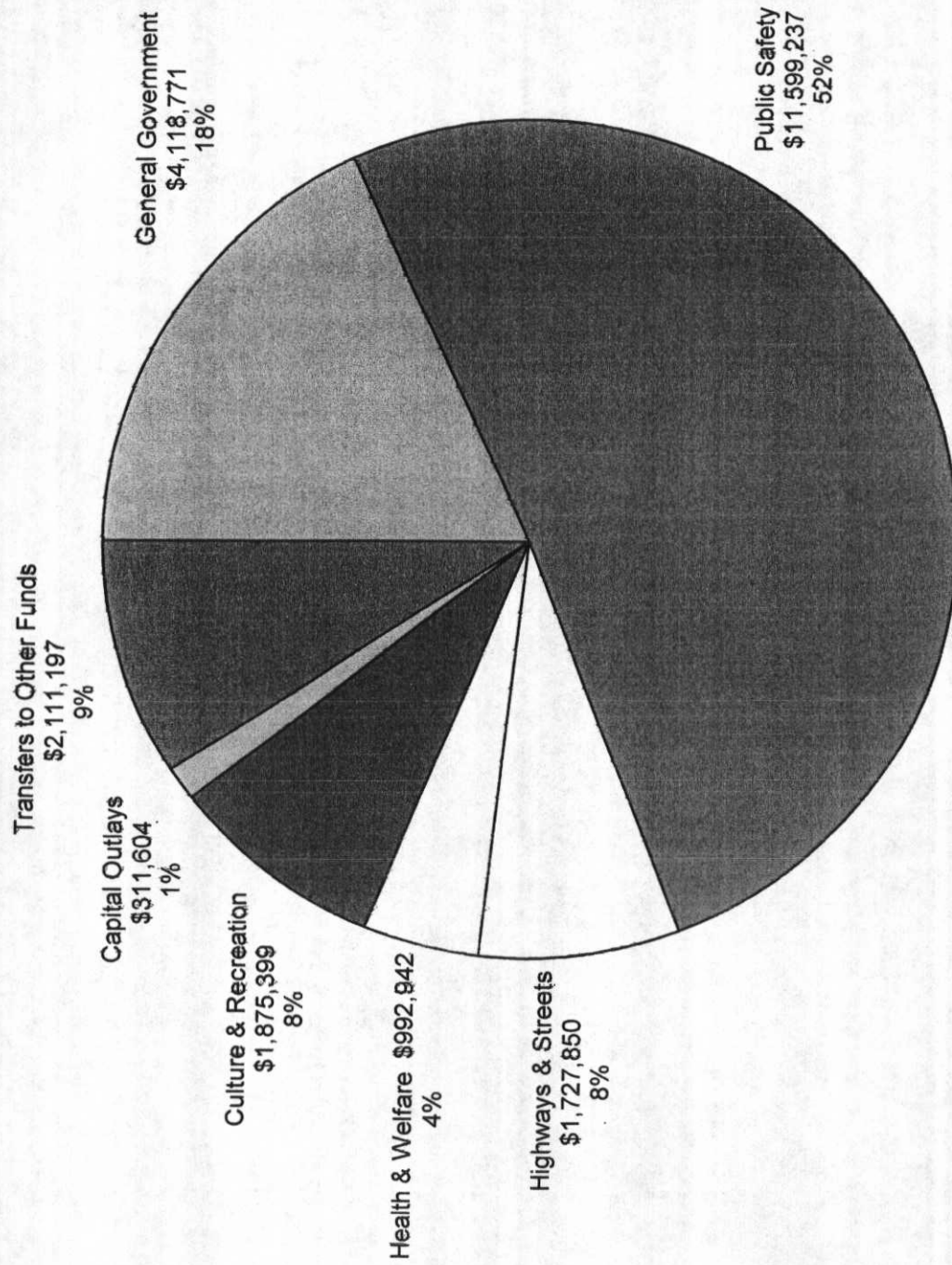

2005 ACTUAL GENERAL FUND REVENUES



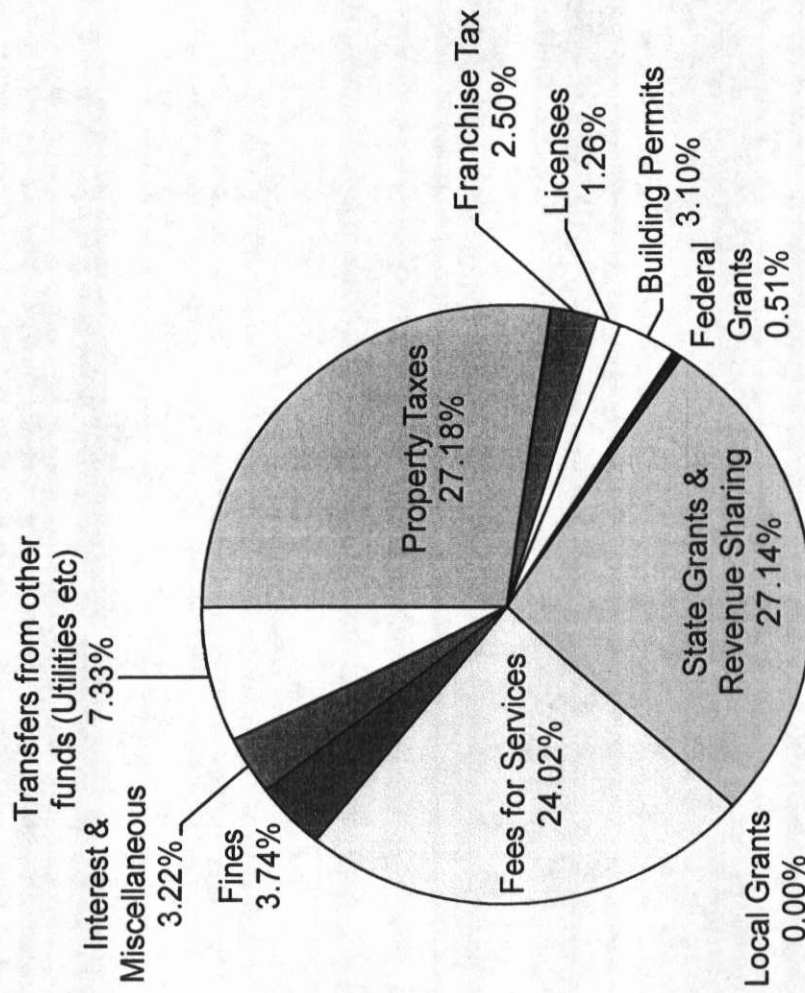
2005 General Fund Revenues total \$23,026,665

GENERAL FUND EXPENDITURES BY FUNCTION - 2005 ACTUALS

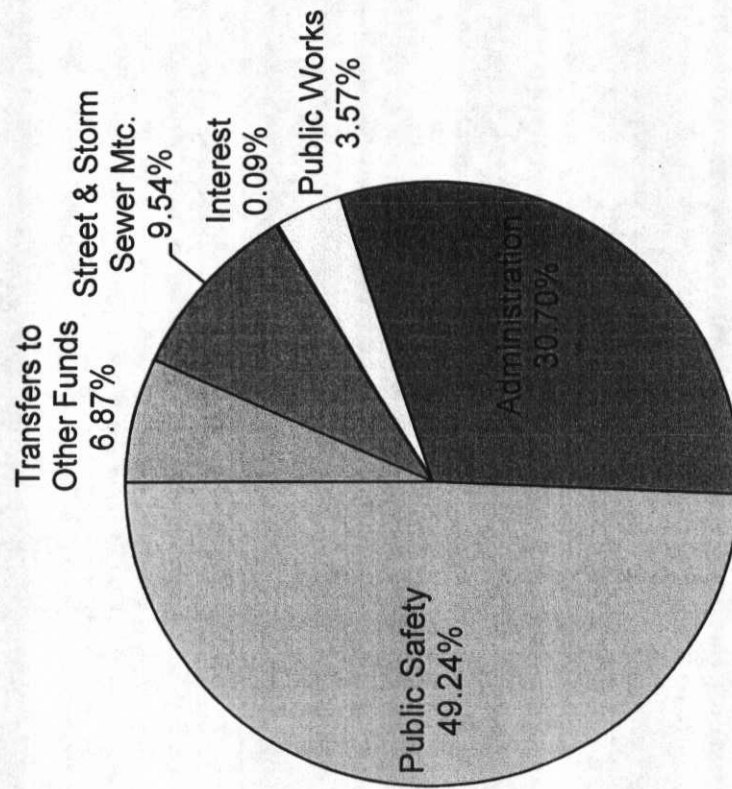


2005 General Fund Expenditures total \$22,737,000

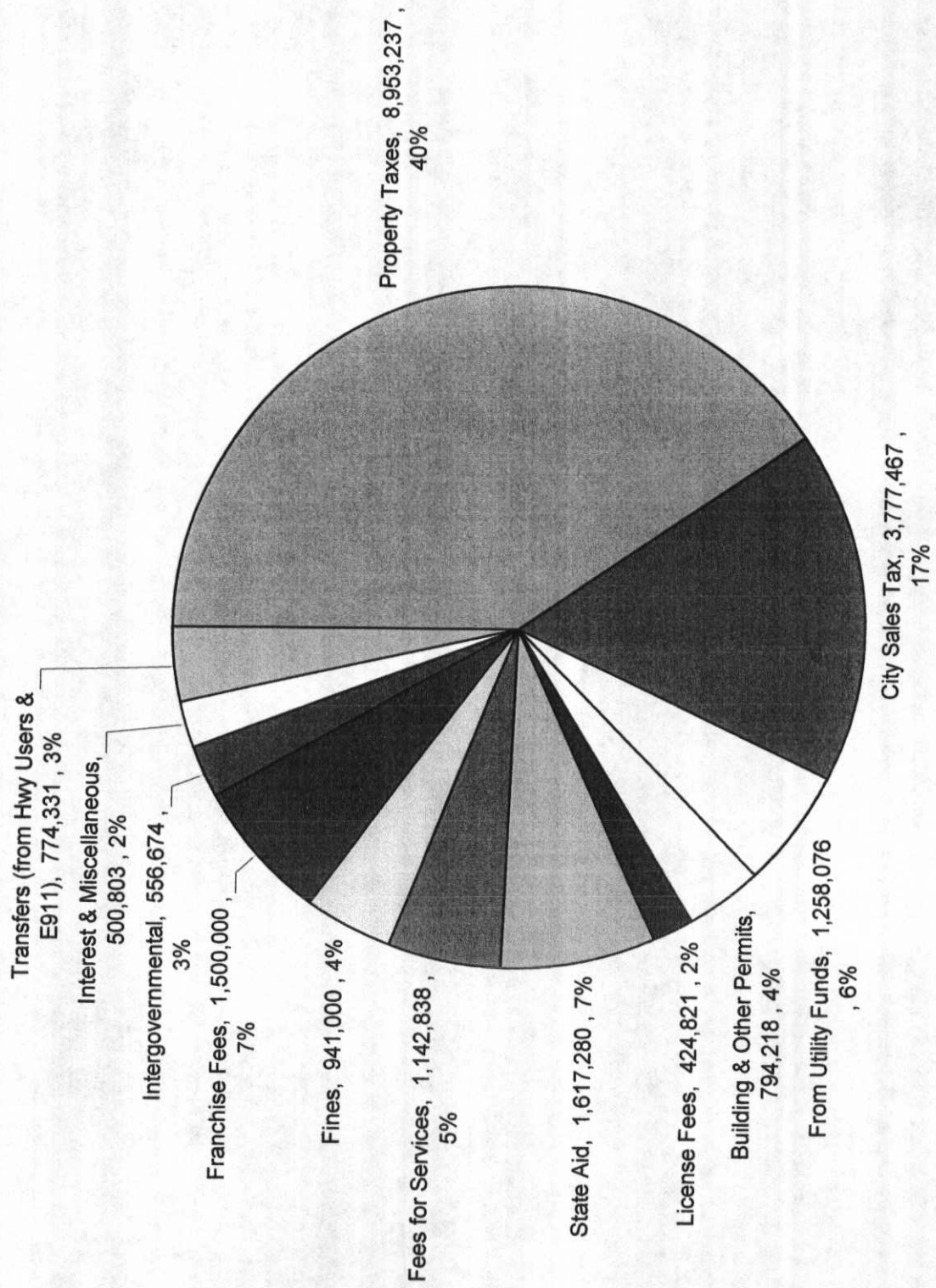
CITY OF MINOT, ND
2005 ACUTAL GENERAL FUND REVENUES



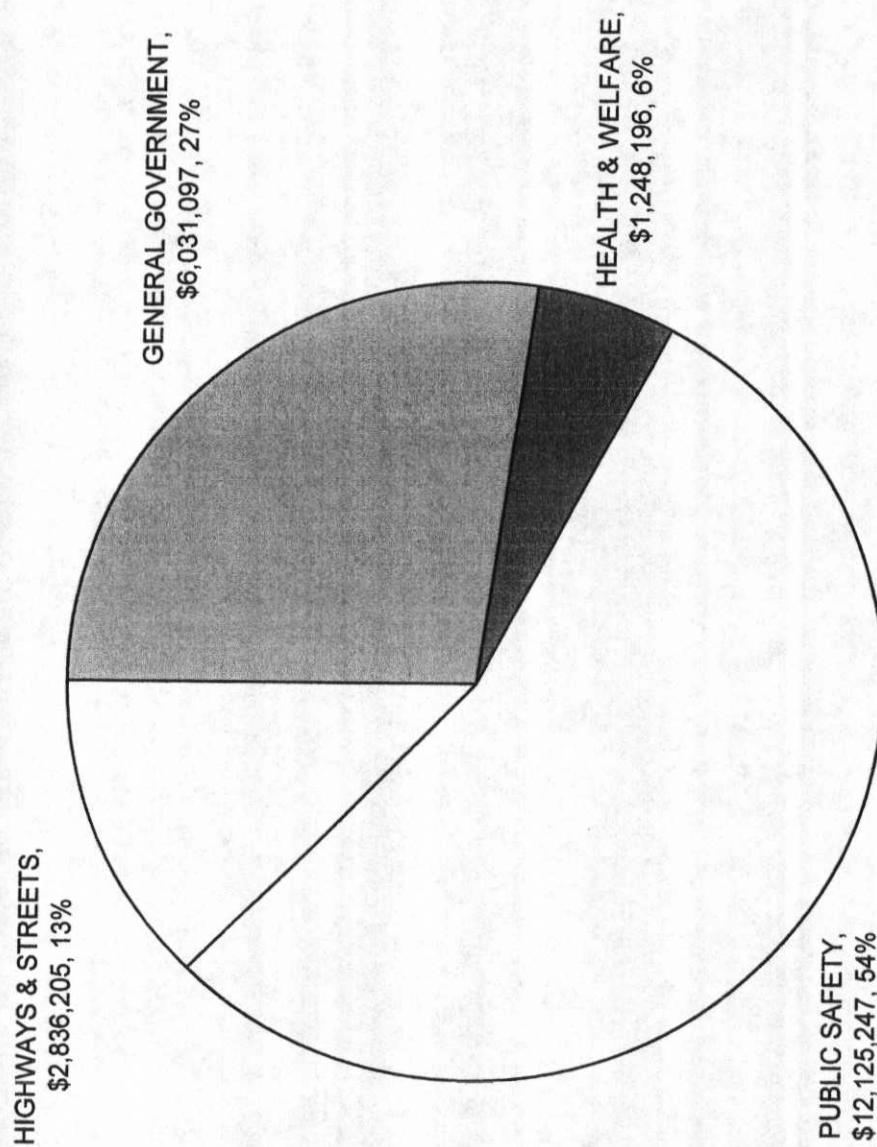

2005 ACUTAL GENERAL FUND EXPENDITURES BY FUNCTION



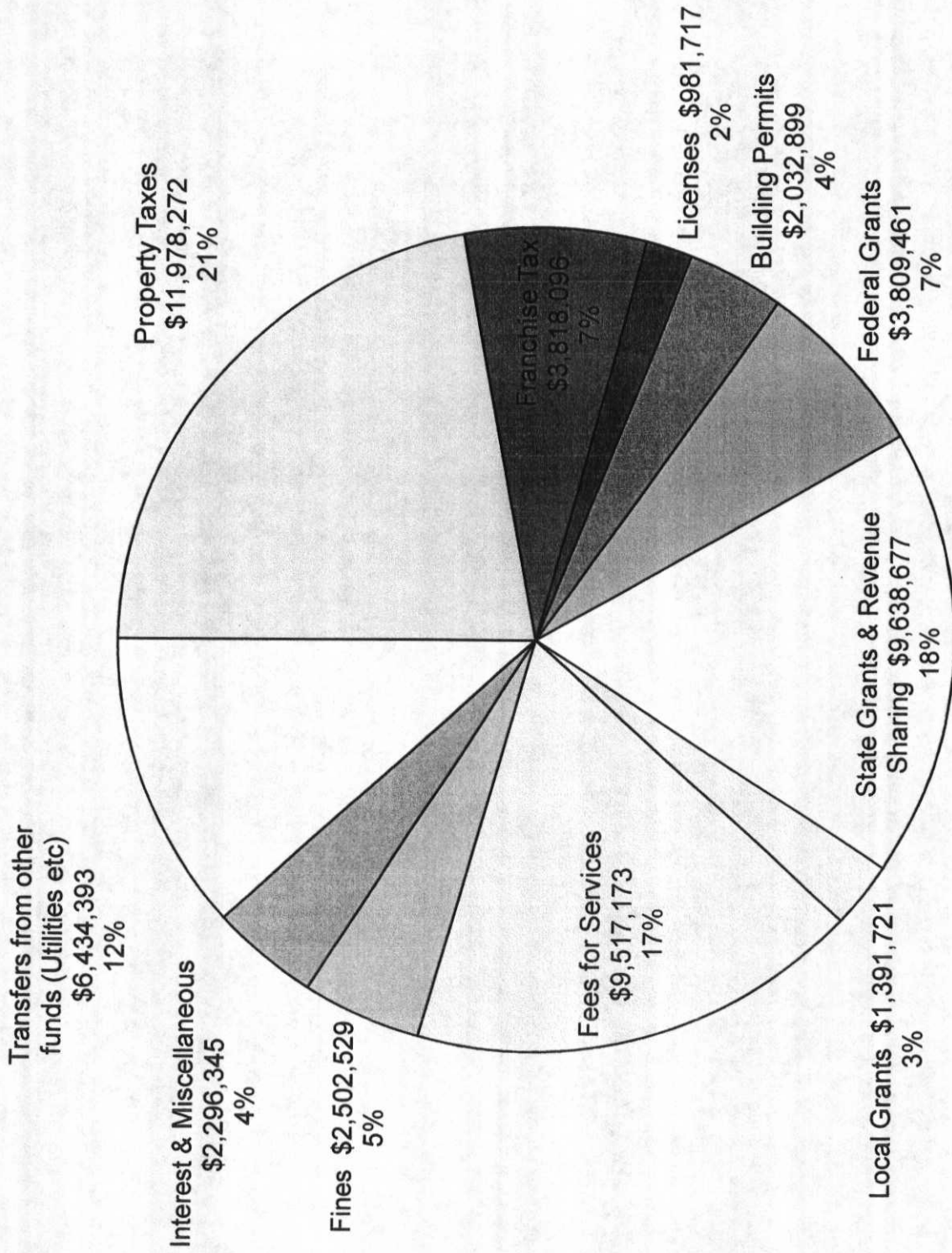
**City of Grand Forks, ND
2006 Budgeted General Fund Revenue**



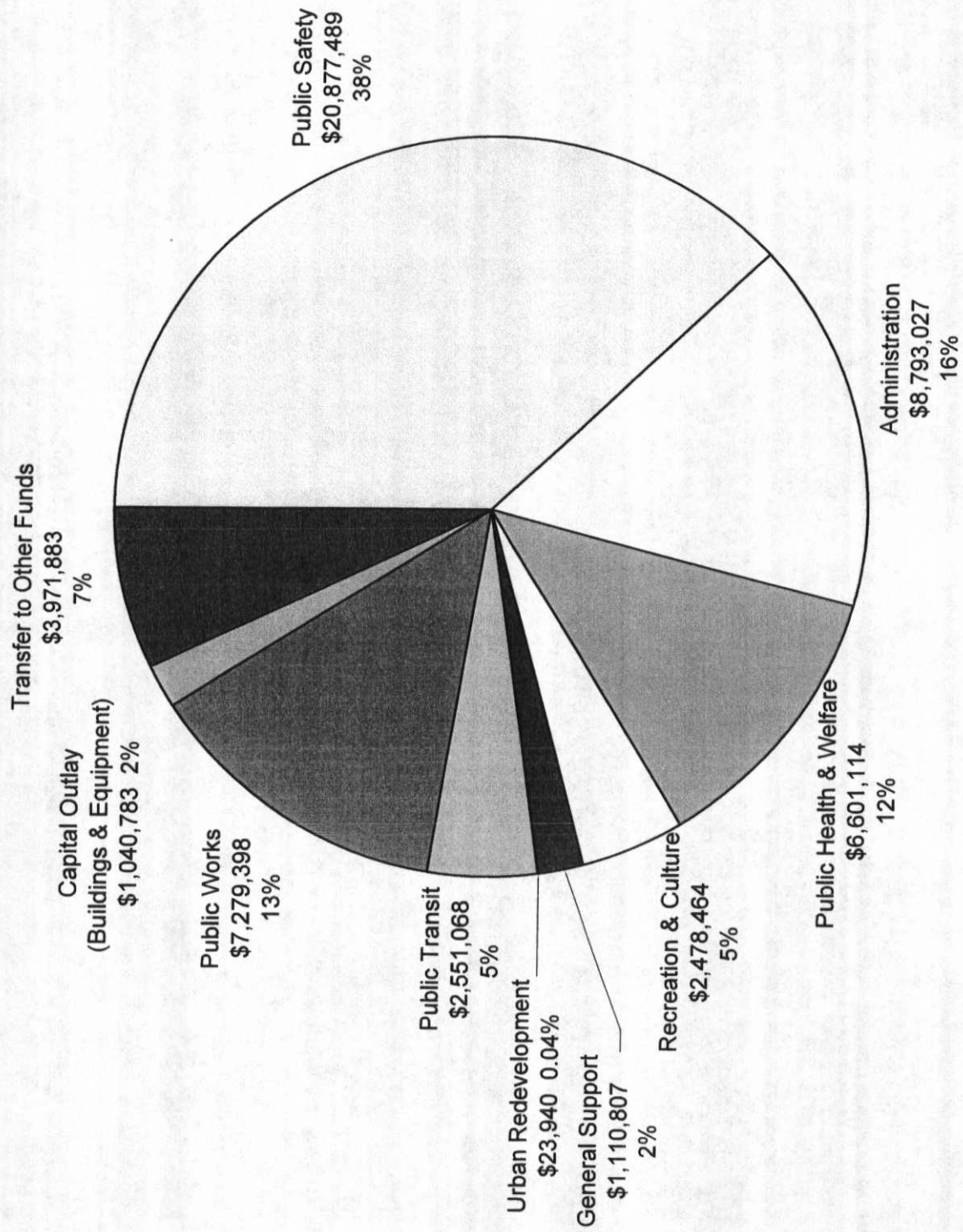
**City of Grand Forks, ND

Neutral testimony on SCR4031

Good morning Chairman Urlacher and Committee Members.

I am Larry Syverson a farmer from Mayville; I am the Chairman of Roseville Township of Traill County. I am also a District Director of the North Dakota Township Officers Association.

A couple of items in this resolution aroused my curiosity. First the whereas beginning on line 4 states that 21 percent of all workers are government employees. If I am not mistaken this percentage includes North Dakota's disproportionately high number of federal employees. If this is correct, including the number of federal employees in this statement is hardly germane to this study.

My second question about this resolution is; how many of these employees are working for little or no compensation? Would reducing the number of low pay employees really improve fiscal efficiency if any fully funded full time employees would have to be added?

There is nothing wrong with studying this situation; reducing taxes is a worthwhile goal, efficiency is too, so are local control, and a responsive government.
