- 1 A BILL for an Act to create and enact section 57-39.2-26.3 of the North Dakota Century Code,
- 2 relating to allocation of sales and use tax collections by retailers registered with the streamlined
- 3 sales tax central registration system to the North Dakota taxpayer relief fund; to amend and
- 4 reenact section 57-39.2-26 of the North Dakota Century Code, relating to allocation of sales
- 5 and use tax revenues; and to provide an effective date.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 57-39.2-26 of the North Dakota Century Code is
 amended and reenacted as follows:
- 9 **57-39.2-26.** Allocation of revenue. Except as provided by sections 57-39.2-26.1 and,
- 10 57-39.2-26.2, and 57-39.2-26.3, all moneys collected and received under this chapter must be
- 11 paid into the state treasury and must be credited by the state treasurer to the general fund.
- 12 Moneys deposited with the commissioner as security for the payment of tax, penalties, or costs
- due must be deposited and accounted for as provided in subsection 3 of section 57-39.2-12.
- **SECTION 2.** Section 57-39.2-26.3 of the North Dakota Century Code is created and
- 15 enacted as follows:
- 16 57-39.2-26.3. Allocation of streamlined sales tax collections to North Dakota
- 17 taxpayer relief fund. Notwithstanding any other provision of law, all net sales and use tax
- 18 <u>collections remitted by a retailer registered with the streamlined sales tax central registration</u>
- 19 system must be deposited by the state treasurer in the North Dakota taxpayer relief fund. The
- 20 state tax commissioner shall certify to the state treasurer the portion of sales and use tax net
- 21 revenues that must be deposited as required by this section. Revenues deposited as required
- 22 by this section may not be considered as part of net sales and use tax collections for state aid
- 23 distribution fund purposes under section 57-39.2-26.1. All moneys deposited in the North

- 1 Dakota taxpayer relief fund are available only for appropriation by the legislative assembly for
- 2 <u>tax relief purposes.</u>
- 3 **SECTION 3. EFFECTIVE DATE.** This Act is effective for taxable events occurring after
- 4 June 30, 2007.
