4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new section to chapter 39-04 of the North Dakota Century Code is created and enacted as follows:

Special number plates for intrastate commercial farm vehicles. Upon application and payment of the registration fee, the director shall issue without an additional charge special number plates or validation decals making them distinctly different from other numbered plates to any person registering a truck or a combination truck and trailer as an intrastate commercial farm vehicle under section 39-04-19. The director shall determine the form and size of these special number plates or validation decals and shall adopt rules governing the issuance of the special number plates or validation decals.

SECTION 2. A new subsection to section 39-04-19 of the North Dakota Century Code is created and enacted as follows:

Trucks or combinations of trucks and trailers weighing more than seventy-two thousand pounds but not more than one hundred five thousand five hundred pounds [more than 32658.65 kilograms but not more than 47854.00 kilograms] which are not used other than as intrastate commercial farm vehicles are entitled to registration under the following fee schedule and the provisions of this subsection. Under this subsection, intrastate commercial farm vehicles are trucks or combinations of trucks and trailers weighing more than seventy-two thousand pounds but not more than one hundred five thousand five hundred pounds [more than 32658.65 kilograms but not more than 47854.00 kilograms] owned or leased

1	for at least one year by a bona fide resident farmer who uses the vehicles
2	exclusively for transporting the farmer's own property or another farmer's
3	agricultural goods on a farm or between a farm and the usual in-state local trading
4	place. In addition to the penalty under section 39-04-41, any person violating this
5	subsection shall license for the entire license period the intrastate commercial farm
6	vehicle at the commercial vehicle rate.
