24	this Act is not subject to the provisions of section 54-44.1-11 and any unexpended funds from		
25	this appropriation are available during the biennium beginning July 1, 2007, and ending		
26	June 30, 2009, for the purpose of providing state matching funds for public assistance and		
27	disaster hazard mitigation.		
28	SECTION 3. EMERGENCY. This Act is declared to be an emerg	ency measure.
