- 1 A BILL for an Act to create and enact chapter 43-29.1 of the North Dakota Century Code,
- 2 relating to a loan repayment program for veterinarians; and to provide a continuing
- 3 appropriation.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** Chapter 43-29.1 of the North Dakota Century Code is created and 6 enacted as follows:
- 7 <u>43-29.1-01. Loan repayment program Veterinarians Maximum amount of funds.</u>
- 8 Each year the state health council, in consultation with the state veterinarian, shall select from a
- 9 pool of applicants no more than three veterinarians who shall provide food animal veterinary
- 10 medicine services to communities in this state. The veterinarians are eligible to receive up to
- 11 eighty thousand dollars in loan repayment funds. If the state health council accepts any gifts,
- 12 grants, or donations under this chapter, the council may select additional veterinarians for
- 13 participation in the loan repayment program under this chapter.
- 14 <u>43-29.1-02. Loan repayment program Veterinarians Powers of state health</u>
- 15 **council.** The state health council may:
  - Determine the eligibility and qualifications of an applicant for loan repayment funds under this chapter.
- 18 <u>2. Identify communities that are in need of a veterinarian and establish a priority</u>
   19 ranking for participation in the program by the selected communities.
- 20 3. Create and distribute a loan repayment application.
- 23 outstanding education loans incurred by the applicant.
- 24 5. Establish conditions regarding the use of the loan repayment funds.

1	<u>6.</u>	Enter a nonrenewable contract with the veterinarian and the selected community to
2		provide to the veterinarian funds for the repayment of education loans in exchange
3		for the veterinarian agreeing to actively practice in the selected community.
4	<u>7.</u>	Receive and use funds appropriated for the program.
5	<u>8.</u>	Enforce any contract under the program.
6	<u>9.</u>	Cancel a contract for reasonable cause.
7	<u>10.</u>	Participate in federal programs that support the repayment of education loans
8		incurred by veterinarians and agree to the conditions of the federal programs.
9	<u>11.</u>	Accept property from an entity.
10	<u>12.</u>	Cooperate with the state department of health to effectuate this chapter.
11	43-2	29.1-03. Veterinarian selection criteria - Eligibility for loan repayment.
12	<u>1.</u>	In establishing the criteria regarding a veterinarian's eligibility for loan repayment
13		funds under this chapter, the state health council shall include consideration of:
14		a. The veterinarian's training in food animal veterinary medicine, ability and
15		willingness of the veterinarian to engage in food animal veterinary medicine,
16		and the extent to which such services are needed in a selected community.
17		b. The veterinarian's commitment to serve in a community that is in need of a
18		veterinarian.
19		c. The compatibility of the veterinarian with a selected community.
20		d. The date by which the veterinarian would be available for service to the
21		selected community.
22		e. The veterinarian's competence and professional conduct.
23	<u>2.</u>	A veterinarian who is selected to receive loan repayment funds under this chapter:
24		a. May not have practiced veterinary medicine full time in this state during the
25		three years immediately preceding the application;
26		b. Must have graduated from an accredited college of veterinary medicine
27		during the year immediately preceding the application or within one year after
28		the date of the application; and
29		c. Must be licensed to practice veterinary medicine in this state.
30	<u>3.</u>	Veterinarians selected shall contract to provide full-time veterinary medicine
31		services for two, three, or four years in one or more selected communities.

2	<u>1.</u>	<u>In s</u>	In selecting a community with a defined need for the services of a veterinarian, the			
3		<u>hea</u>	health council shall consider:			
4		<u>a.</u>	The size of the community and give priority:			
5			(1) First to rural communities having a population under five thousand;			
6			(2) Second to communities having a population between five thousand and			
7			ten thousand; and			
8			(3) Third to communities having a population greater than ten thousand.			
9		<u>b.</u>	The number of veterinarians practicing in the community and the surrounding			
10			area.			
11		<u>C.</u>	The access by residents to veterinarians practicing in the community and the			
12			surrounding area.			
13		<u>d.</u>	The degree to which residents support the addition of a veterinarian within the			
14			community.			
15	<u>2.</u>	The	state health council shall give priority for participation to a community that			
16		<u>den</u>	nonstrates a need for a veterinarian.			
17	<u>3.</u>	<u>In e</u>	valuating communities for participation in this program, the state health council			
18		may	consult with public and private entities and visit the communities.			
19	<u>43-</u>	29.1-	05. Eligible loans. The state health council may provide for loan repayment			
20	funds to a veterinarian who has received an education loan. The council may not provide funds					
21	for the repayment of a loan that is in default at the time of the application. The amount of the					
22	repayment must be related to the veterinarian's outstanding education loans.					
23	43-29.1-06. Release from contract obligation.					
24	<u>1.</u>	The	state health council shall release a veterinarian from the veterinarian's loan			
25		repa	ayment contract without penalty if:			
26		<u>a.</u>	The veterinarian has completed the service requirements of the contract;			
27		<u>b.</u>	The veterinarian is unable to complete the service requirement of the contract			
28			because of a permanent physical disability;			
29		<u>C.</u>	The veterinarian demonstrates to the state health council extreme hardship or			
30			shows other good cause justifying the release; or			
31		d.	The veterinarian dies.			

 A decision by the state health council not to release a veterinarian from the veterinarian's loan repayment contract without penalty is reviewable by district court.

43-29.1-07. Loan repayment. Upon completing one year of service, as required by the contract, the veterinarian is eligible to receive a loan payment in an amount equaling twenty percent of the applicant's original student loan. Upon completing a second year of service, as required by the contract, the veterinarian is eligible to receive a loan payment in an amount equaling twenty percent of the applicant's original student loan. Upon completing a third year of service, as required by the contract, the veterinarian is eligible to receive a loan payment in an amount equaling thirty percent of the applicant's original student loan. Upon completing a fourth year of service, as required by the contract, the veterinarian is eligible to receive a loan payment in an amount equaling thirty percent of the applicant's original student loan. All payments under this section must be made to the issuer of the student loan. No individual may receive more than eighty thousand dollars under this section. If an individual fails to complete an entire year of service, the amount repayable under this section for that year must be prorated.

43-29.1-08. Gifts, grants, and donations - Continuing appropriation. The state health council may accept any conditional or unconditional gifts, grants, or donations for the purpose of providing funds for the repayment of veterinarians' education loans. If an entity desires to provide funds to the state health council to allow an expansion of the program beyond the three veterinarians contemplated by this chapter, the entity shall commit to fund fully the expansion for a period of four years. The state health council may contract with a public or private entity and may expend any moneys available to the council to obtain matching funds for the purposes of this chapter. All moneys received as gifts, grants, or donations under this section are appropriated as a continuing appropriation to the state health council for the purpose of providing funds for the repayment of additional veterinarians' education loans.
