The followup information on North Dakota education and training system may use 16 personally identifiable information to prepare produce aggregate data compilations 17 that do not identify any individual and may not be disclosed to the public by the 18 occupational information coordinating committee. A request for disclosure of the 19 records under section 44-04-18 or section 6 of article XI of the Constitution of 20 North Dakota must be directed to the person or entity that has provided the 21 records to the occupational information coordinating committee statistics that may 22 be provided to a participating agency.
