

INFORMATION REGARDING PUBLIC SAFETY ANSWERING POINTS AND DIVISION OF STATE RADIO CONTRACT COUNTIES

BACKGROUND

At the Public Safety Committee's April 29-30, 2008, meeting, the committee requested the Legislative Council staff prepare information regarding public safety answering point (PSAP) revenue and expenditures, full-time equivalent (FTE) positions, call volumes, infrastructure, and radio coverage maps. In response to the committee's request, the Legislative Council staff surveyed each of the PSAPs and the counties that contract with the Department of Emergency Services Division of State Radio for 911 services. This memorandum provides a summary of PSAP revenue and expenditures, FTE positions, call volumes, infrastructure, and radio coverage maps and Division of State Radio contract counties' infrastructure as reported by the entities on the Legislative Council survey.

Bismarck/Burleigh	Generally, the differing radio systems cover different areas based upon the agency or jurisdictional responsibilities. The two countywide channels in use offer reasonable "talkout" mobile coverage with some degradation on "talkback." Portable coverage from a countywide perspective is lacking.
Cavalier County	The Pembina Gorge covers approximately one-fourth of the county and has almost no radio coverage. The coverage is poor in the northwest corner of the county for the 50-watt mobile radios in use by fire and emergency medical services jurisdictions.
