Annual Renaissance Zone Report September 6, 2007

The information in this document is for the time period July 2006 through June 2007.

Since July 2006 eight cities have joined the Renaissance Program they include:

- Kenmare
- Mayville
- Rolla
- Underwood
- Velva
- Westhope
- Williston
- Wishek

Enderlin* - Became the thirty sixth renaissance Zone July 1, 2007.

At the present time there are approximately eight cities inquiring on the requirements of becoming a renaissance zone; four of those cities Ashley, Cooperstown, New Rockford and Washburn are in the final stages of completing their development plan and they hope to become a renaissance zone by the end of the year.

For the period July 2006 through June 2007 there have been eighty five projects approved at the state and local level and sixty four projects completed. The accomplishments for the sixty-four projects include:

- 11 new businesses created.
- 28 business expansions
- 3 commercial buildings constructed
- 22 single family homes purchased or rehabilitated.
- 168 new jobs created
- 204 new residents

Each application submitted to the state contains estimated tax benefits for both state and local taxes. The information below is for both approved and completed projects.

- Financial Institution tax \$50,000
- State single family, business and investor income tax exemptions \$4,740,666
- Historical tax credits \$0
- Property tax exemption \$3,834,202

Since the program was started there have been 569 projects (thirty-three out of the thirty-six cities) sent in for approval and 383 have been completed. The impact to state and local taxes for the completed projects are as follows:

- Financial Institution tax \$810,000
- State single family, business and investor income tax exemptions \$10,439,850
- Historical tax credits \$8,005,110
- Property tax exemption \$7,864,070
