- 1 A BILL for an Act to create and enact chapter 4.1-12 of the North Dakota Century Code, relating
- 2 to the turkey assessment; to repeal chapter 4-13.1 of the North Dakota Century Code, relating
- 3 to the turkey assessment; to provide a penalty; and to provide a continuing appropriation.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** Chapter 4.1-12 of the North Dakota Century Code is created and enacted 6 as follows:
- 7 **4.1-12-01.** Definitions.
- 8 <u>1. "Commissioner" means the agriculture commissioner.</u>
- 9
 2. "Processor" means any person who purchases more than one thousand turkeys
 10
 each year for slaughter.
- 11 3. "Producer" means any person who does business within this state and raises
 12 turkeys for slaughter each year.

- 13 **4.1-12-02. Assessment Determination.**
- 14 <u>1. The assessment required by this chapter is determined by:</u>
- 15 <u>a.</u> Calculating the flock average live weight at the time of delivery to a processor;
 and
- 17 b. Calculating the actual number of turkeys in that flock after processing.
- 2. a. If the actual number of turkeys in a flock after processing had an average live
 weight of less than eighteen pounds, the assessment is equal to one cent per
 turkey.

1 If the actual number of turkeys in a flock after processing had an average live b. 2 weight of at least eighteen pounds but less than twenty-eight pounds, the 3 assessment is equal to one and one-half cents per turkey. 4 If the actual number of turkeys in a flock after processing had an average live C. 5 weight of at least twenty-eight pounds, the assessment is equal to one and 6 three-quarter cents per turkey. **SOURCE:** Section 4-13.1-03. NOTE: In accordance with a motion by the Agriculture Committee, this section now reflects the level of assessment currently imposed on turkeys. 7 4.1-12-03. Assessment - Collection - Remittance by processor. The processor 8 shall collect the assessment required by this chapter at the time the turkeys are delivered to a 9 processing plant, by deducting the amount required under section 4.1-12-02 from the price paid 10 to the producer. **SOURCE:** Section 4-13.1-04. 11 4.1-12-04. Invoice - Contents - Preparation by processor. At the time turkeys are 12 delivered to a processor, the processor shall prepare, sign, and date an invoice documenting: 13 The name and address of the producer; 1. 14 The name and address of the seller, if the producer is not the seller; 2. 15 3. The name and address of the processor: 16 4. The number of turkeys sold in that particular transaction: 17 5. The assessment collected on that particular transaction; and 18 6. The date. **SOURCE:** Section 4-13.1-06. 19 4.1-12-05. Submission of assessments - Civil penalty. 20 A processor shall submit all assessments collected under this chapter to the 21 commissioner within thirty days after the conclusion of each calendar quarter. 22 2. If a processor fails to submit the assessments as required by this section, the 23 commissioner may impose a penalty equal to five percent of the amount due, plus

NOTE: Current law requires the commissioner to impose a penalty on a delinquent assessment. As directed by the Agriculture Committee, this section authorizes the

interest at the rate of six percent per annum from the due date.

commissioner to impose a penalty but does not require that the commissioner do so. This change parallels the provisions in other commodity group chapters.

1 4.1-12-06. Out-of-state processors. The commissioner may contract with out-of-state

2 processors for the collection and remittance of the assessment required by section 4.1-12-02.

- 3 **4.1-12-07. Refund of assessment Form.** To receive a refund of any assessment
- 4 paid in accordance with this chapter, a producer shall obtain an application form from the
- 5 commissioner within sixty days from the date the producer's turkeys were delivered to a
- 6 processor. The producer shall return the completed form to the commissioner within ninety
- 7 days from the date the producer's turkeys were delivered to a processor.

NOTE: In accordance with a motion by the Agriculture Committee, the section now reflects the same number of days given to other commodity groups for requesting and submitting refund forms.

- 8 **4.1-12-08. Continuing appropriation.** The commissioner shall forward all moneys
- 9 received under this chapter to the state treasurer for deposit in a special fund known as the
- 10 "turkey fund". All moneys in the turkey fund are appropriated on a continuing basis to the
- 11 commissioner to carry out this chapter.

- 12 **4.1-12-09. Authorized expenditures.** The assessment required by this chapter may
- 13 be used to fund research, education programs, and market development efforts, as well as
- 14 participation in programs under the auspices of the national turkey federation.

- 15 <u>4.1-12-10. Powers of the commissioner.</u> The commissioner may:
- 16 <u>1. Expend moneys raised under this chapter for the purposes set forth in section</u>
- 4.1-12-09, provided the commissioner first consults with a committee appointed by
- 18 <u>the North Dakota turkey federation;</u>
- 19 <u>2.</u> Require a processor to prepare and submit additional information and documents if
 20 necessary for the enforcement and administration of this chapter; and
- 21 <u>3. Do all other things necessary and proper to enforce and administer this chapter.</u>

- 4.1-12-11. Biennial report Information regarding turkey assessments. When
- 2 compiling the biennial report required by section 54-06-04, the commissioner shall provide
- 3 <u>information regarding activities under this chapter, including the amount of assessments</u>
- 4 collected and the manner in which the moneys were expended.

- 5 **4.1-12-12. Penalty.** Any person who willfully violates this chapter is guilty of a class B
- 6 misdemeanor.

7 **SECTION 2. REPEAL.** Chapter 4-13.1 of the North Dakota Century Code is repealed.

CHAPTER NOTE: Sections 4-13.1-01 and 4-13.1-11 were not included in the chapter rewrite. Section 4-13.1-01 provides a title for the chapter and is therefore unnecessary. Section 4-13.1-11 duplicates enforcement authority given to the commissioner in proposed Section 4.1-12-10.
