- 1 A BILL for an Act to create and enact four new sections to chapter 54-06 of the North Dakota
- 2 Century Code, relating to state employee service awards, employer-paid tuition, and
- 3 employer-paid professional organization membership and service club dues.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1.** A new section to chapter 54-06 of the North Dakota Century Code is created and enacted as follows:

## State employee service awards.

- 1. Each state agency, department, or institution shall recognize certain service anniversaries of employees by implementing and administering a service award program. Service awards may be postponed or withheld if there are documented problems with an employee's performance.
- 2. An employee must have completed three, five, ten, fifteen, twenty, twenty-five, thirty, thirty-five, forty, forty-five, fifty, fifty-five, sixty, sixty-five, or seventy years of employment with the state to receive a service award. An employee who leaves employment with the state and subsequently returns to employment with the state again begins to accumulate time that must be added to the employee's previous service and applied to any future service award.
- 3. The types of service awards that an employee is entitled to receive are:
  - a. Following the completion of three years of service, a certificate or plaque, and
     an item not to exceed a value of twenty-five dollars.
  - <u>b.</u> Following the completion of five years of service and every five-year
     <u>increment thereafter</u>, a certificate or plaque, and an item not to exceed a
     value of ten dollars per year of service.

An item with a value not to exceed two hundred dollars. 7 A farewell party may be provided upon agreement of the employee and the C. 8 agency, department, or institution. 9 A retirement award may be withheld if there are documented problems with d. 10 the employee's performance. 11 A state agency, department, or institution may not provide cash to an employee as 5. 12 part of a service or retirement award program. However, a state agency, 13 department, or institution may provide a gift certificate. 14 An expenditure made under this section is deemed to be compensation for 6. 15 services provided to the state and is made for a public purpose and may not be 16 construed as a gift for purposes of section 18 of article X of the Constitution of 17 North Dakota. 18 **SECTION 2.** A new section to chapter 54-06 of the North Dakota Century Code is 19 created and enacted as follows: 20 **Employer-paid tuition.** Each state agency, department, or institution may adopt rules 21 or policies to provide training and educational opportunities to its employees to learn new 22 required skills or to enhance their current skills, to increase the opportunity for advancement 23 within the agency or state service, to increase proficiency and productivity, or to improve work 24 performance. The cost of training or education courses, including tuition and fees, may be paid. 25 within budgetary constraints, by the state agency, department, or institution or reimbursed to 26 the employee in accordance with rule or policy. Within sixty days after the close of each 27 biennial period, each state agency, department, or institution providing employer-paid training 28 or tuition under this section shall file with the office of management and budget a report 29 indicating the individual receiving the employer-paid training or tuition, the amount paid, and a

statement of the public purpose or public benefit of the employer-paid training or tuition. Within

- Legislative Assembly 1 submit to the legislative council a report that contains a summary of expenditures made 2 pursuant to this section during the biennium and describes the statements of the public purpose 3 or public benefit of the expenditures. An employee who receives employer-paid tuition under 4 this section who leaves employment with that employer within two years of receiving the tuition must repay all tuition received under this section. An expenditure for employer-paid training or 5 6 educational courses, including tuition and fees, under this section is deemed to be made for a 7 public purpose and may not be construed as a gift for purposes of section 18 of article X of the 8 Constitution of North Dakota. 9 **SECTION 3.** A new section to chapter 54-06 of the North Dakota Century Code is 10 created and enacted as follows: 11 **Employer-paid membership dues for professional organizations or service clubs.** 12 Each state agency, department, or institution may adopt rules or policies to provide for the 13 payment of membership dues for professional organizations or service clubs with a direct job 14 relation to the employee's work duties. The cost of membership dues may be paid, within 15 budgetary constraints, by the state agency, department, or institution or reimbursed to the 16 employee in accordance with rule or policy. Within sixty days after the close of each biennial 17 period, each state agency, department, or institution making an expenditure under this section 18 shall file with the office of management and budget a report detailing the expenditure, the 19 amount paid, and a statement of the public purpose or public benefit of the expenditure. Within 20 ninety days after the close of each biennial period, the office of management and budget shall 21 submit to the legislative council a report that contains a summary of expenditures made 22 pursuant to this section during the biennium and describes the statements of the public purpose
  - **SECTION 4.** A new section to chapter 54-06 of the North Dakota Century Code is created and enacted as follows:
