**MOTION**

**REP. MONSON MOVED** that a committee of two be appointed to escort the Honorable Byron Dorgan, United States Senator to the podium, which motion prevailed. Speaker Delzer appointed Rep. Dietrich and Rep. Kroeber to the escort committee.

**REMARKS OF SENATOR BYRON DORGAN**

Two days ago, I was in Albuquerque, New Mexico touring some National Laboratories in Los Alamos and Sandia. I want to share a few things I learned at the National Laboratories, just to describe what is happening in science and technology.

Ten years ago, they created something called a computer that performed a teraflop. A teraflop is an advanced computer that will perform one trillion functions in one second. This was done in 1997. It took 2400 square feet to house the computers that could do this and a half a megawatt to power it. Presently, ten years later, the National Laboratory has produced a computer that functions at a teraflop and it is the size of a dime and uses energy equivalent to a 60 watt light bulb. It's unbelievable how science is progressing.

I was at another laboratory that was studying termites. They are finding that termites, in their digestive system produce two things when they eat wood: methane and hydrogen. Scientists are studying the bacteria in the digestive systems of termites to determine how wood can be turned into hydrogen.

They have also produced engines so small that you cannot see them with the human eye. There are so many changes going on in technology and the sciences.

Here in North Dakota, we are working to be a part of that. It was 2002 that I called together the university presidents in North Dakota with the Governor and I suggested that we create something called the Red River Valley Research Corridor. From that time 2002, until now, I have added over \$300 million in Federal Funds to be involved in nanotechnology, micro technology, bio-science, deep brain research, hydrogen technology, and other things to give us a whole series of things that gives us opportunities we've never before had.

We've added \$750 million in added value in the last five years in several thousand jobs. This is just the start: the concept of a Red River Valley Research Corridor, using two significant engines of opportunity. There is no limit to what we can do here in the Northern Great Plains. Yes, we are an agriculture state, but we can be so much more.

The second piece of this is the issue of energy. I've also included some funding for the creation of an Energy Corridor and a coordinating office. There is no where in America where there is a greater diverse opportunity to provide different kinds of energy for a hungry world than North Dakota. We have all of the fossil fuels: coal, oil, natural gas. We have # 1 potential in all of the states in wind energy, we are involved in all the other forms of renewable energy: ethanol and bio-diesel. No one has greater opportunity than we do.

You know about the Bakken Shale deposits, we don't know how much recoverable oil is there. In a year to a year and a half, they geologists will know how much recoverable oil there is. If it is what some think it is - it will have a dramatic impact on North Dakota in the future.

We ought to create an Energy Corridor, which I have tried to do with some legislation I have introduced; a Research Corridor and Energy Corridor to capture beyond agriculture things that represent great opportunities for our state's future. Those are ideas that I think make a lot of sense for all of us.

I know you are interested in the energy issues: oil is important, coal is very important. We need to find ways to continue to use our lignite coal dealing with the issue of climate change and we will, I believe technology will allow us to have a zero emission coal fire generating plant - and that will happen in the not too many years in the distant future. That's the only way to unlock the opportunities.

The renewables are also important. Let me tell you the difference of what this country has done. In 1916, we put in place permanent robust incentives in our tax code for oil, and they have stayed there ever since. In 1992 we put in place some production tax credits for renewable energy, we've extended them short term five times, we let them expire three times. That's pathetic, that's not a commitment. Let's make the same kind of commitment that we made to fossil fuels. We can do much better.

I have a great experiment going in North Dakota that I funded through an earmark. We are using wind energy and a wind turbine to take energy from the wind, produce electricity, use electricity to separate hydrogen from water through the process of electrolysis and store the hydrogen for vehicle use. You are taking intermittent power from the air in a wind turbine and producing hydrogen for vehicle use. That is a really exciting opportunity, and it's just a start.

I want to mention one thing to you about renewable fuels. We use 145 billion gallons of fuel a year in this country. If we blend every single gallon with 10% ethanol, that's 14 billion gallons of ethanol. The President says let's go to 35 billion gallons, some say let's go higher. You can't have a market for that unless you are putting much higher blends in the gas tanks: E-85, 30-40-50% blend pumps. We have 15 thousand flex fuel vehicles in North Dakota that can run on E-85 and there are only 24 gasoline pumps where you can get E-85 in your tank. We need to figure out a way to connect all of this, find out a way to transport the ethanol we are going to produce to where it's needed. We need to find a way to do that or we are going to have a problem with production dropping off the shelf with respect to inventory that won't be cleared from the market.

There is a lot to be hopeful for. Energy is a big deal. I hope we can work together to create this Energy Corridor which I am working on and continue the Red River Valley Research Corridor to add two dimensions to our agriculture economy that can dramatically change our state's future.

One word about agriculture, this is the year in which we write the new farm bill. It has great impact for our state. The last opportunity to provide disaster relief is going to come in the next few weeks when the President sends us a \$100 billion emergency supplemental funding

request, mostly for Iraq. When he does that I am going to offer disaster aid once again to the Senate Appropriations process. I've done it twice before and succeeded twice before, gotten it through the Senate and then it's gotten blocked. I am going to do it again, it will probably be the last chance, but I think you know from all of your constituents and I certainly know due to the epicenter of drought in the south central part of North Dakota and South Dakota and we had people that lost everything, and the fact is that we ought to help them. We go all the way around the world and say let us help you if you have trouble, let's make sure we help people here at home first.

Let me make an additional point: water issues. We are all going to work a lot on water issues, 90% of the surface water in North Dakota is Missouri river water and we need to try to find ways to address it.

Let me finish by mentioning something that I should mention and that is Iraq. It casts a shadow over virtually everything else we do; it impacts virtually everything else that is happening. Our involvement in Iraq is an involvement for which none of us at this point have good answers. The fact is we are there; there are men and women who have answered their call, North Dakotans who have given the ultimate sacrifice. Families, soldiers-the fact is we honor their sacrifice, we honor their service. This is an unbelievably difficult set of circumstances.

Saddam Hussein has been executed. This is a man who butchered we think up to 400 thousand people. He's executed, he doesn't exist. The Iraqi people have voted for their own constitution, one they wrote. They voted for their new government, one they created. The question that remains with respect to Iraq is do they have the will to provide for their own security? The national intelligence estimate that came out several weeks ago now in unclassified form tells us that the strife that is occurring in Iraq is not about Al Qaeda and terrorism. The strife is against Shia and Sunni, Sunni against Shia, it is a Civil War. It does not make sense in the long term for this country to its soldiers in the middle and keep them in the middle of a Civil War. We must find a way to bring our soldiers home in a way that says to the Iraqi's "This is your country, not ours, this belongs to you not us. And what is left is for you to exhibit the will to take your country back."

General Abizaid came to congress two and a half months ago and he said in open testimony "I called all of my soldiers together and I asked them the question 'Do you need and do you want additional troops in Iraq?'" General Abizaid was the head of the entire command, he said "Everyone of my commanders said 'no', they said no because if we bring additional US Soldiers to Iraq it will send a signal to the Iraqis that they can do less because we will do more" It is exactly opposite of what is needed to be done.

Mr. Negroponte came to congress two and a half weeks ago to testify, he was then the head of intelligence, he has now moved to the state department. He said this in open testimony "The greatest terrorist threat to our country is Al Qaeda and its leadership and its network around the world. It exists in a secure hideaway in Pakistan." These are the people that boasted about murdering Americans on 9-11. It seems to me that if we have troops to serge 20-21 thousand people that we ought to serge them to find ways in Pakistan to eliminate the Al Qaeda leadership which we are told is the greatest terrorist threat to this country.

My hope and I know your prayer and my prayer is that we find a way to deal with these issues in a way that is honorable to bring our troops home.

Through it all, I know that you have great confidence in our future. You and I serve in public service, all of us run for elections, and we know how much fun it is to be out there on the campaign trail running for elections. We do that because we believe in the future of this state and this country.

Thomas Wolf said it in a book he wrote, "You Can't Go Home Again". He said that "The Americans are filled with an almost quenchless hope, an indestructible belief, a boundless optimism that something good is about to turn up, something good is about to happen. That is the peculiar quality of the American soul." And I'm sure that's the way you come to your desks here in the House in Bismarck North Dakota. It's the way I get up in the morning. It's to believe that something good is about to happen and we can help make it.
