**Bismarck, December 5, 2006**

The House convened at 9:00 a.m., with Speaker Delzer presiding.

The prayer was offered by Rev. Donna Dohrmann, Lutheran Church of the Cross, Bismarck.

The roll was called and all members were present except Representatives Dahl, DeKrey, and S. Kelsh.

A quorum was declared by the Speaker.

**SPEAKER DELZER ANNOUNCED** that the House would be at ease to receive the Senate for a Joint Session.

**MOTION**

**REP. MONSON MOVED** that a committee of two be appointed to escort the Honorable Lt. Governor Jack Dalrymple to the rostrum, which motion prevailed. The Speaker appointed Rep. Pietsch and Sen. Gary Lee to the escort committee.

**JOINT SESSION**

**SPEAKER DELZER INTRODUCED** the Honorable Lt. Governor Jack Dalrymple.

**LT. GOVERNOR DALRYMPLE CALLED** the Joint Session to order and called upon Sen. Stenehjem to give his report as chairman of the Legislative Council. Upon completion of his report, Sen. Stenehjem introduced John Olsrud, Director of the Legislative Council for his report. John Olsrud introduced Jim Smith, Legislative Budget Analyst and Auditor, for his fiscal report.

A presentation by Rep. Klemin, ND Commission on Uniform State Laws, regarding uniform state laws was given.

**MOTION**

**REP. MONSON MOVED** that the Joint Session be dissolved, which motion prevailed.

**REP. MONSON MOVED** that the House stand in recess until 1:15 p.m., which motion prevailed.

A presentation on sexual harassment issues by Mr. Lee Lundberg, Training and Development, Human Resource Management Services was given.
