POINT OF PERSONAL PRIVILEGE

What an exciting week for North Dakota, the community of Mayville and the students of Mayville State.

Mayville State alumni, Reps. Aarsvold, Boucher, Nottestad, Herbel, and I wish to congratulate the Mayville State Comet Men's Basketball Team, their Coach Craig Smith and his staff for their accomplishments this week in the National NAIA Men's Basketball tournament in Lake of the Ozarks, Missouri.

The Comet Men's Basketball Team takes home the 2nd place trophy for the National NAIA Division II Basketball Tournament. This is a major achievement. There are 155 teams in NAIA Division II Men's Basketball, from this 32 teams compete to earn a place in the national tournament, of that only two teams play for the championship game. Mayville State made it to the championship and it is a remarkable achievement.

The Mayville State Comet Men's Basketball Team is the first North Dakota University System men's basketball team to earn a championship berth in the NAIA National tournament.

In addition to this accomplishment, Head Coach Craig Smith received the NAIA Division II Men's Basketball Coach of the Year Award.

Three Mayville State players were named to the ten member NAIA Division II 2007 All Tournament Team. They are Monty Rogers, Ron Howard, and Matt Stenehjelm. Monty Rogers was named a NAIA Division II Basketball First Team All American.

Last, but certainly not least, Mayville State University won the Dr. James Naismith-Emil Liston Sportsmanship Award for 2007. This award is presented to recognize team conduct during the tournament as well as fan support and conduct.

 - e. A requirement that a dentist selected for a grant under this section must commit to practice in the community for a minimum of five years.

There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$100,000, or so much of the sum as may be necessary, to the state department of health for the purpose of providing grants under section 2 of this Act, for the biennium beginning July 1, 2007, and ending June 30, 2009."

The fund consists of the tobacco settlement dollars obtained by the state under sections IX (payments) and XI (calculation and disbursement of payments) of the master settlement agreement and consent agreement adopted by the east central judicial district court in its judgment entered December 28, 1998 [Civil No. 98-3778]. All moneys received by the state pursuant to the judgment and all moneys received by the state for enforcement of the judgment must be deposited in the fund. Interest earned on the fund must be credited to the fund and deposited in the fund. The principal and interest of the fund must be allocated as follows:
 - 4- a. Transfers to a community health trust fund to be administered by the state department of health. The state department of health may use funds as appropriated for community-based public health programs and other public health programs, including programs with emphasis on preventing or reducing tobacco usage in this state. Transfers under this ~~subsection~~ subdivision must equal ~~ten sixteen~~ percent of total annual transfers from the tobacco settlement trust fund.
 - 2- b. Transfers to the common schools trust fund to become a part of the principal of that fund. Transfers under this ~~subsection~~ subdivision must equal ~~forty-five~~ forty-two percent of total annual transfers from the tobacco settlement trust fund.
 - 3- c. Transfers to the water development trust fund to be used to address the long-term water development and management needs of the state. Transfers under this ~~subsection~~ subdivision must equal ~~forty-five~~ forty-two percent of the total annual transfers from the tobacco settlement trust fund.

2. Transfers to the funds under this section must be made within thirty days of receipt by the tobacco settlement trust fund."

SECTION 1. AMENDMENT. Section 28 of chapter 167 of the 2005 Session Laws is amended and reenacted as follows:

SECTION 28. CONTINGENCY. If any moneys appropriated for per student payments and transportation payments in the grants - state school aid line item in House Bill No. 1013, as approved by the fifty-ninth legislative assembly, remain after payment of all statutory obligations for per student and transportation payments during the biennium beginning July 1, 2005, and ending June 30, 2007, and after the superintendent of public instruction has fulfilled any directives contained in section 27 of this Act, the superintendent shall distribute the remaining moneys as follows:

1. The superintendent of public instruction shall use the first \$450,000, or so much of that amount as may be necessary, to provide additional payments to school districts serving English language learners in accordance with section 15.1-27-12.
2. The superintendent of public instruction shall use the next \$1,000,000, or so much of that amount as may be necessary, for the purpose of providing additional per student payments to school districts participating in eligible educational associations in accordance with section 32 of this Act.
3. The superintendent of public instruction shall use the next \$400,000, or so much of that amount as may be necessary, to purchase automated external defibrillators and place one in each public school in the state.

4. The superintendent of public instruction shall use the remainder of the moneys to provide additional per student payments on a prorated basis according to the latest available average daily membership of each school district.

SECTION 2. EMERGENCY. This Act is declared to be an emergency measure."
