1 A BILL for an Act to amend and reenact section 15.1-07-20 of the North Dakota Century Code,  
2 relating to requirements for drivers of school vehicles.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 15.1-07-20 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **15.1-07-20. ~~Schoolbus~~ School vehicle driver - Requirements.**

- 7 1. ~~To~~ Except as provided in subsection 2, to be eligible to drive a schoolbus or other  
8 school vehicle for which a commercial driver's license is not required, an individual  
9 must:
- 10 a. Hold a ~~valid~~ North Dakota driver's license;
  - 11 b. Be free from communicable diseases;
  - 12 c. Be in good physical health and have normal use of both hands, both feet, both  
13 eyes, and both ears;
  - 14 d. Be of sound mental health; and
  - 15 e. Pass any drug and alcohol screening tests required by the school board; ~~and~~
  - 16 f. ~~Be at least twenty-one years of age, unless the board of a school district~~  
17 ~~determines that an individual not meeting this requirement can safely and~~  
18 ~~adequately perform the required duties.~~
- 19 2. To be eligible to drive a school vehicle that is designed to seat ten to fifteen  
20 people, an individual must:
- 21 a. Hold a North Dakota driver's license;
  - 22 b. Meet the physical and medical requirements established for commercial  
23 vehicle drivers; and

- 1                   c. Complete any annual training required by the superintendent of public  
2                   instruction.
- 3           3. Each year, the board of a school district shall designate licensed health care  
4           professionals, as defined by department of transportation standards, to examine  
5           ~~schoolbus and~~ school vehicle drivers.
- 6    ~~3.~~ 4. Prior to commencing duties as the driver of a ~~schoolbus or other~~ school vehicle,  
7           whether employed by the school district or by another entity with whom the school  
8           board has contracted, and every two years thereafter, an individual shall present to  
9           the school board verification by a designated health care professional that the  
10          individual has been examined and meets the health, physical, and medical  
11          requirements of this section.
- 12    ~~4.~~ 5. ~~This section does not prohibit~~ The requirements of this section apply to teachers  
13          ~~or, administrators employed by, and other employees of the district from operating~~  
14          ~~vehicles for the purpose of transporting~~ who transport students to regular or  
15          ~~special events related to educational programs in which the students are enrolled~~  
16          or from any school-sponsored event or activity.
