5	BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:				
6	SEC	CTIOI	N 1. A new subsection to section 12.1-27.1-01 of the North Dakota Century		
7	Code is created and enacted as follows:				
8	As used in this chapter, "sexually expressive image" means a photograph or visual				
9	representation that exhibits a nude or partially denuded human figure, as defined in section				
10	12.1-27.1-03.1, or sexual conduct.				
11	SECTION 2. Section 12.1-27.1-03.3 of the North Dakota Century Code is created and				
12	enacted as follows:				
13	Creation, possession, or dissemination of sexually expressive images prohibited				
14	- Exception.				
15	<u>1.</u>	<u>A pe</u>	erson is guilty of a class A misdemeanor if, knowing of its character and		
16		con	tent, that person:		
17		<u>a.</u>	Without written consent from each individual in the image, surreptitiously		
18			creates or possesses a sexually expressive image knowing the sexually		
19			expressive image was surreptitiously created; or		
20		<u>b.</u>	Distributes or publishes, electronically or otherwise, a sexually expressive		
21			image with the intent to cause emotional harm or humiliation to any individual		

depicted in the sexually expressive image or after being given notice by an

individual or parent or guardian of the individual who is depicted in a sexually

1		expressive image that the individual, parent, or guardian does not consent to
2		the distribution or publication of the sexually expressive image.
3	<u>2.</u>	This section does not authorize any act prohibited by any other law. If the sexually
4		expressive image is of a minor and possession does not violate section
5		12.1-27.2-04.1, a parent or guardian of the minor may give permission for a person
6		to possess or distribute the sexually expressive image.
7	<u>3.</u>	This section does not apply to any book, photograph, video recording, motion
8		picture film, or other visual representation sold in the normal course of business
9		through wholesale or retail outlets that possess a valid sales tax permit or used by
10		an attorney, attorney's agent, or any other person obtaining evidence for a criminal
11		investigation or pending civil action, or by medical professional or a peace officer
12		acting within that individual's scope of employment.
13	SEC	CTION 3. REPEAL. Section 12.1-31-08 of the North Dakota Century Code is
14	repealed.
