4	officer and employee lodging and mileage reimbursement; to provide an effective date; and to

6	BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:				
7	SECTION 1. AMENDMENT. Subdivision d of subsection 2 of section 44-08-04 of the				
8	North Dakota Century Code is amended and reenacted as follows:				
9	d. Fourth quarter is from twelve midnight to six a.m. and the sum must be the				
10	actual lodging expenses not to exceed fifty-five sixty dollars plus any				
11	additional applicable state or local taxes. A political subdivision may				
12	reimburse an elective or appointive officer, employee, representative, or				
13	agent for actual lodging expenses.				
14	SECTION 2. AMENDMENT. Subsection 1 of section 54-03-20 of the North Dakota

The sum of seventy cents per mile [1.61 kilometers] for For 22 each mile [1.61 kilometers] actually and necessarily traveled in the 23 performance of official duty when the travel is by private airplane, the 24 individual is entitled to the sum of seventy cents per mile [1.61 kilometers]. 25 Mileage by private aircraft must be computed by actual air mileage when only 26 one state employee or official is traveling; if two or more state employees or

private airplane travel must be calculated as follows:

1 (1) If reimbursement is for one properly authorized and reimbursable 2 passenger, reimbursement must be paid on a per mile basis as 3 provided in this subsection. 4 (2) If reimbursement is claimed for a chartered private aircraft, 5 reimbursement may not exceed the cost of regular coach fare on a 6 commercial flight, if one is scheduled between the point of departure, 7 point of destination, and return, for each properly authorized and 8 reimbursable passenger on the charter flight; or, where there is no such 9 regularly scheduled commercial flight, the actual cost of the charter. 10 b. Except as provided in subdivision a, when travel is by rail or certificated air 11 taxi commercial operator or other common carrier, including regularly 12 scheduled flights by airlines, the individual is entitled to reimbursement for the 13 amount actually and necessarily expended therefor in the performance of 14 official duties. (Effective through June 30, 2009) Compensation of members and 24 leadership. 25 The members of the council and the members of any committee of the council are 26 entitled to be compensated for the time spent in attendance at sessions of the 27 council and of its committees at the rate of one hundred eight dollars per day and 28 must also be paid for expenses incurred in attending said meetings and in the

performance of their official duties in the amounts provided by law for other state

2. In addition to the compensation provided in subsection 1, the chairman of the council shall receive an additional five dollars for each day spent in attendance at sessions of the council and of its committees, and the chairman of each of the council's committees shall receive five dollars for each day spent in attendance at sessions of the council or of the committee which the person chairs.

(Effective after June 30, 2009) Compensation of members and leadership.

- 1. SECTION 9. AMENDMENT. Section 54-35-10 of the North Dakota Century Code is amended and reenacted as follows:

54-35-10. Compensation of members and leadership.

- The members of the council and the members of any committee of the council are entitled to be compensated for the time spent in attendance at sessions of the council and of its committees at the rate of one hundred forty-one forty-eight dollars per day and must also be paid for expenses incurred in attending said meetings and in the performance of their official duties in the amounts provided by law for other state officers.
- 2. In addition to the compensation provided in subsection 1, the chairman of the council shall receive an additional five dollars for each day spent in attendance at sessions of the council and of its committees, and the chairman of each of the council's committees shall receive five dollars for each day spent in attendance at sessions of the council or of the committee which the person chairs.

- 1 **SECTION 10. EFFECTIVE DATE.** Sections 1, 2, 5, and 8 of this Act become effective
- 2 July 1, 2009, and sections 3, 6, and 9 of this Act become effective on July 1, 2010.
- 3 **SECTION 11. EMERGENCY.** This Act is declared to be an emergency measure.
