BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. Committee on medical assistance - Membership - Duties -

Continuing appropriation.

- The legislative council shall appoint a medical assistance committee. Membership of the committee must include:
 - a. Three members of the house of representatives, two of whom must be selected by the leader representing the majority faction of the house of representatives and one of whom must be selected by the leader representing the minority faction of the house of representatives.
 - b. Three members of the senate, two of whom must be selected by the leader representing the majority faction of the senate and one of whom must be selected by the leader representing the minority faction of the senate.
 - c. Up to six members who represent medical assistance providers and the department of human services, who serve in an ex officio nonvoting capacity, and who are selected by the chairman of the committee with the concurrence of the other legislative members of the committee.
- The legislative council chairman shall designate the committee chairman and vice chairman from among the legislative members of the committee.
- 3. The committee shall operate according to the statutes and procedures governing the operation of other legislative council interim committees.

1 The committee shall study the state's medical assistance program, including 2 options for benefit, management, and reimbursement reform. The committee shall 3 engage consultant services to undertake an actuarially based analysis of the 4 medical assistance program and reform options to ensure the future long-term 5 sustainability of the program. The analysis must: 6 a. Gather data regarding the current categories of medical assistance 7 beneficiaries: 8 Evaluate the current financial expenditures for medical assistance by county b. 9 and by category of aid and within those categories by type of service; 10 Evaluate the current medical assistance reimbursement system; <u>C.</u> 11 Evaluate issues related to beneficiary access to care in the medical d. 12 assistance program and patient access in the state's health care system, 13 including the uninsured and underinsured; 14 Evaluate the current commercial insurance market in conjunction with federal e. 15 opportunities to increase coverage options; and 16 Evaluate options for reform, including the implementation of risk-sharing f. 17 arrangements, preventive services and case management, a high-risk pool, 18 and a premium assistance program, and the potential use of pilot projects for 19 evaluating the effectiveness of reform options. 20 5. The committee shall engage consultant services to study the progress in the 21 implementation of any medical assistance program management initiatives. 22 including statewide targeted case management services and improvement of 23 mental health treatment services. 24 6. The legislative council may accept gifts, grants, and donations from any source, 25 including federal or private sources, to assist the committee on medical assistance 26 in conducting its study and obtaining consultant services under this section. Any 27 gifts, grants, and donations received are appropriated to the legislative council on a 28 continuing basis for the purpose of conducting the study of the state's medical 29 assistance program and obtaining consultant services. 30 7. A state employee who is a member of the committee must receive that employee's

regular salary and is entitled to mileage and expenses, to be paid by the employing

1	agency. Members of the committee who are not members of the legislative
2	assembly or state employees are not entitled to compensation or reimbursement of
3	expenses for service on the committee.
4	SECTION 2. APPROPRIATION. There is appropriated out of any moneys in the
5	general fund in the state treasury, not otherwise appropriated, the sum of \$100,000, or so much
6	of the sum as may be necessary, and from special funds derived from federal funds or other
7	income, the sum of \$150,000, or so much of the sum as may be necessary, to the legislative
8	council for the purpose of obtaining actuarial and consultant services for the medical assistance
9	program analysis described in section 1 of this Act, for the biennium beginning July 1, 2009,
10	and ending June 30, 2011.
11	SECTION 3. EXPIRATION DATE. Section 1 of this Act is effective through
12	December 31, 2010, and after that date is ineffective.
