- 1 A BILL for an Act to create and enact a new section to chapter 15.1-09 of the North Dakota
- 2 Century Code, relating to the leasing of school buildings and facilities; to amend and reenact
- 3 section 15.1-09-33 of the North Dakota Century Code, relating to school board powers; and to
- 4 provide a penalty.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6	SEC	TION 1. AMENDMENT. Section 15.1-09-33 is amended:				
7	15.1	1-09-33. School board - Powers. The board of a school district may:				
8	1.	Establish a system of free public schools for all children of legal school age				
9		residing within the district.				
10	2.	Organize, establish, operate, and maintain elementary, middle, and high schools.				
11	3.	Have custody and control of all school district property and, in the case of the				
12		board of education of the city of Fargo, have custody and control of all public				
13		school property within the boundaries of the Fargo public school district and to				
14		manage and control all school matters.				
15	4.	Acquire real property and construct school buildings and other facilities.				
16	5.	Relocate or discontinue schools and liquidate the assets of the district as required				
17		by law; provided no site may be acquired or building constructed, or no school may				
18		be organized, established, operated, maintained, discontinued, or changed in				
19		location without the approval of the state board of public school education if outside				
20		the boundary of the district.				
21	6.	Purchase, sell, exchange, and improve real property.				
22	7.	a. Lease real property for a maximum of one year except in the case of for up to				
23		twenty years a career and technical education facility constructed in whole or

10		boarding care for special education students.

2			in the official newspaper of the district;
3		<u>C.</u>	Posts a copy of the contract on the school district web site and provides
4			written copies of the contract upon request;
5		<u>d.</u>	Files a copy of the contract with the superintendent of public instruction;
6		<u>e.</u>	Places the question of approving the contract on the ballot at the next annual
7			or special election and obtains the approval of at least sixty percent of the
8			qualified electors voting on the question.
9	<u>2.</u>	Upon receiving a petition by the board of a school district, the superintendent of	
10		pub	lic instruction may waive the application of this section to that board provided
11		<u>that</u>	board demonstrates to the satisfaction of the superintendent that an Act of
12		Goo	d or other exigency has occurred and the board must contract for a lease of a
13		buil	ding or facility to provide for the uninterrupted education of students. A waiver
14		und	er this section is applicable only to a contract that expires no later than June
15		<u>thirt</u>	ieth of the school year succeeding the year in which the waiver is granted.
16	<u>3.</u>	For	purposes of this section, a "facility" includes a sports or athletic complex.
17	<u>4.</u>	<u>A so</u>	chool board member who votes to approve any action that constitutes a
18		viola	ation of this section is guilty of a class B misdemeanor.
