1 A BILL for an Act to create and enact a new subsection to section 12.1-27.1-01 and section 2 12.1-27.1-03.3 of the North Dakota Century Code, relating to sexually expressive images; to 3 repeal section 12.1-31-08 of the North Dakota Century Code, relating to possession or 4 distribution of certain photographs or other visual representations; and to provide a penalty. 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA: 6 **SECTION 1.** A new subsection to section 12.1-27.1-01 of the North Dakota Century 7 Code is created and enacted as follows: 8 As used in this chapter, "sexually expressive image" means a photograph or visual representation that exhibits a nude or partially denuded human figure, as defined in section 9 10 12.1-27.1-03.1, or sexual conduct. 11 SECTION 2. Section 12.1-27.1-03.3 of the North Dakota Century Code is created and 12 enacted as follows: 13 Creation, possession, or dissemination of sexually expressive images prohibited 14 - Exception. 15 A person is guilty of a class A misdemeanor if, knowing of its character and 1. 16 content, that person: 17 Without written consent from each individual in the image, surreptitiously a. 18 creates or willfully possesses a sexually expressive image that was 19 surreptitiously created; or 20 Distributes or publishes, electronically or otherwise, a sexually expressive b. 21 image with the intent to cause emotional harm or humiliation to any individual

depicted in the sexually expressive image or after being given notice by an

individual or parent or guardian of the individual who is depicted in a sexually

1		expressive image that the individual, parent, or guardian does not consent to
2		the distribution or publication of the sexually expressive image.
3	<u>2.</u>	A person is guilty of a class B misdemeanor if, knowing of its character and
4		content, that person acquires and knowingly distributes any sexually expressive
5		image that was created without the consent of the subject of the image.
6	<u>3.</u>	This section does not authorize any act prohibited by any other law. If the sexually
7		expressive image is of a minor and possession does not violate section
8		12.1-27.2-04.1, a parent or guardian of the minor may give permission for a person
9		to possess or distribute the sexually expressive image.
10	<u>4.</u>	This section does not apply to any book, photograph, video recording, motion
11		picture film, or other visual representation sold in the normal course of business
12		through wholesale or retail outlets that possess a valid sales tax permit or used by
13		an attorney, attorney's agent, or any other person obtaining evidence for a criminal
14		investigation or pending civil action, or by a medical professional or a peace officer
15		acting within that individual's scope of employment.
16	SEC	CTION 3. REPEAL. Section 12.1-31-08 of the North Dakota Century Code is
17	repealed.
