- 1 A BILL for an Act to amend and reenact sections 15.1-14-11, 15.1-14-12, 15.1-14-21,
- 2 15.1-14-22, 15.1-14-31, and 15.1-14-32 of the North Dakota Century Code, relating to the
- 3 dismissal of school district superintendents, directors of special education districts, and
- 4 directors of area career and technology centers; and to repeal sections 15.1-14-09, 15.1-14-10,
- 5 15.1-14-19, 15.1-14-20, 15.1-14-29, and 15.1-14-30 of the North Dakota Century Code, relating
- 6 to the dismissal of school district superintendents, directors of special education districts, and
- 7 directors of area career and technology centers.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA: 8

9 **SECTION 1. AMENDMENT.** Section 15.1-14-11 of the North Dakota Century Code is

10 amended and reenacted as follows:

15.1-14-11. School district superintendent - Contract - Failure to provide notice of 12 nonrenewal renewal. The contract of a school district superintendent is deemed to be 13 renewed for a period of one year from its termination date if:

- 14 On or before April fifteenth Before May first, the board of a school district has not 1. 15 provided written notification to the superintendent regarding a contemplated 16 nonrenewal of the superintendent's contract as required by section 15.1-14-12; and
- 17 2. On or before June first, the superintendent has not provided to the board a written 18 resignation.
- 19 SECTION 2. AMENDMENT. Section 15.1-14-12 of the North Dakota Century Code is 20 amended and reenacted as follows:
- 21 15.1-14-12. School district superintendent - Employed for less than two years -

22 Notification of nonrenewal. If the board of a school district elects not to renew the contract of

- 23 a superintendent who has been employed by the board in that position for less than two years,
- 24 the board shall provide written notice of the nonrenewal to the superintendent before May first.

- At the request of the superintendent, the board shall meet with the superintendent to convey the
   reasons for the nonrenewal.
- 3 SECTION 3. AMENDMENT. Section 15.1-14-21 of the North Dakota Century Code is
  4 amended and reenacted as follows:

5 15.1-14-21. Multidistrict special education unit - Director - Contract - Failure to
 6 provide notice of nonrenewal renewal. The contract of a multidistrict special education unit
 7 director is deemed to be renewed for a period of one year from its termination date if:

- On or before April fifteenth Before May first, the board of the multidistrict special
   education unit has not provided written notification to the director regarding a
   contemplated nonrenewal of the director's contract as required by section
- 11 <u>15.1-14-22;</u> and
- On or before June first, the director has not provided to the board a written
   resignation.
- SECTION 4. AMENDMENT. Section 15.1-14-22 of the North Dakota Century Code is
   amended and reenacted as follows:
- 16 **15.1-14-22.** Multidistrict special education unit Director Employed for less than 17 two years - Notification of nonrenewal. If the board of a multidistrict special education unit 18 elects not to renew the contract of a director who has been employed by the board in that 19 position for less than two years, the board shall provide written notice of the nonrenewal to the 20 director before May first. At the request of the director, the board shall meet with the director to 21 convey the reasons for the nonrenewal.
- SECTION 5. AMENDMENT. Section 15.1-14-31 of the North Dakota Century Code is
   amended and reenacted as follows:

15.1-14-31. Area career and technology center - Director - Contract - Failure to
 provide notice of nonrenewal renewal. The contract of an area career and technology center
 director is deemed to be renewed for a period of one year from its termination date if:

- On or before April fifteenth Before May first, the board of the center has not
   provided written notification to the director regarding a contemplated nonrenewal of
   the director's contract as required by section 15.1-14-32; and
- 30 2. On or before June first, the director has not provided to the board a written31 resignation.

1	SECTION 6. AMENDMENT.	Section 15.1-14-32 of the North Dakota Century Code is
2	amended and reenacted as follows:	

15.1-14-32. Area career and technology center - Director - Employed for less than
two years - Notification of nonrenewal. If the board of an area career and technology center
elects not to renew the contract of a director who has been employed by the board in that
position for less than two years, the board shall provide written notice of the nonrenewal to the
director before May first. At the request of the director, the board shall meet with the director to
convey the reasons for the nonrenewal.
SECTION 7. REPEAL. Sections 15.1-14-09, 15.1-14-10, 15.1-14-19, 15.1-14-20,

10 15.1-14-29, and 15.1-14-30 of the North Dakota Century Code are repealed.
