- 1 A BILL for an Act to create and enact chapter 26.1-33.4 of the North Dakota Century Code,
- 2 relating to the national conference of insurance legislators Life Settlements Model Act; to
- 3 amend and reenact subsections 19 and 21 of section 10-04-02 of the North Dakota Century
- 4 Code, relating to the definition of the terms viatical or life settlement contract and security; to
- 5 repeal chapter 26.1-33.3 of the North Dakota Century Code, relating to viatical settlement
- 6 contracts; and to provide a penalty.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Subsections 19 and 21 of section 10-04-02 of the North Dakota Century Code are amended and reenacted as follows:

"Security" means any note; stock; treasury stock; bond; debenture; evidence of indebtedness; certificate of interest or participation in any profit-sharing agreement; certificate of interest or participation in an oil, gas, or mining title or lease or in payments out of production under such a title or lease; collateral trust certificate; preorganization certificate or subscription; transferable share; investment contract; viatical or life settlement contract or a fractionalized or pooled interest therein; program, contract, or other arrangement in which persons invest in a common enterprise the returns of which depend to any extent upon inducing other persons to participate or invest in the enterprise; investment of money or money's worth including goods furnished or services performed in the risk capital of a venture with the expectation of profit or some other form of benefit to the investor when the investor has no direct control over the investment or policy decisions of the venture; voting-trust certificate; certificate of deposit for a security; foreign currency commodity contract, as used in chapter 51-23; or beneficial interest in title to property, profits, or earnings; or, in general, any interest or instrument commonly

1 known as a "security"; or any certificate of interest or participation in, temporary or 2 interim certificate for, receipt for, guarantee of, or warrant or right to subscribe to or 3 purchase, any of the foregoing. 4 21. "Viatical or life settlement contract" means an agreement for the purchase, sale, 5 assignment, transfer, devise, or bequest of any portion of the death benefit or 6 ownership of a life insurance policy or certificate, for consideration that is less than 7 the expected death benefit of the life insurance policy or certificate. "Viatical or life 8 settlement contract" does not include: 9 The assignment, transfer, sale, devise, or bequest of a death benefit, life 10 insurance policy, or certificate of insurance by the viator owner to the viatical 11 settlement provider pursuant to chapter 26.1-33.3 26.1-33.4; 12 b. The assignment of a life insurance policy to a bank or depository institution; or 13 The exercise of accelerated benefits pursuant to the terms of a life insurance C. 14 policy issued in accordance with the insurance laws of this state. 15 SECTION 2. Chapter 26.1-33.4 of the North Dakota Century Code is created and 16 enacted as follows: 17 **26.1-33.4-01. Definitions.** As used in this chapter, unless the context requires 18 otherwise: 19 "Advertisement" means any written, electronic, or printed communication or any 1. 20 communication by means of recorded telephone messages or transmitted on 21 radio; television; the internet; or similar communications media, including filmstrips, 22 motion pictures, and videos; published, disseminated, circulated, or placed before 23 the public, directly or indirectly, for the purpose of creating an interest in or 24 inducing a person to purchase or sell, assign, devise, bequest, or transfer the 25 death benefit or ownership of a life insurance policy or an interest in a life 26 insurance policy pursuant to a life settlement contract. 27 <u>2.</u> "Broker" means an individual who, on behalf of an owner and for a fee, 28 commission, or other valuable consideration, offers or attempts to negotiate life 29 settlement contracts between an owner and providers. A broker represents only 30 the owner and owes a fiduciary duty to the owner to act according to the owner's

instructions, and in the best interest of the owner, notwithstanding the manner in

1 which the broker is compensated. The term does not include an attorney, certified 2 public accountant, or financial planner retained in the type of practice customarily 3 performed in that individual's professional capacity to represent the owner whose 4 compensation is not paid directly or indirectly by the provider or any other person, 5 except the owner. 6 "Business of life settlements" includes an activity involved in offering to enter, 3. 7 soliciting, negotiating, procuring, effectuating, monitoring, or tracking of life 8 settlement contracts. 9 "Chronically ill" means: 4. 10 Being unable to perform at least two activities of daily living, such as eating, <u>a.</u> 11 toileting, transferring, bathing, dressing, or continence; 12 <u>b.</u> Requiring substantial supervision to protect the individual from threats to 13 health and safety due to severe cognitive impairment; or 14 Having a level of disability similar to that described in subdivision a as C. 15 determined by the United States secretary of health and human services. 16 "Financing entity" means an underwriter, a placement agent, a lender, a purchaser 5. 17 of securities, a purchaser of a policy or certificate from a provider, a credit 18 enhancer, or any entity that has a direct ownership in a policy or certificate that is 19 the subject of a life settlement contract, but whose principal activity related to the 20 transaction is providing funds to effect the life settlement contract or purchase of 21 one or more polices, and who has an agreement in writing with one or more 22 providers to finance the acquisition of life settlements contracts. The term does 23 not include a nonaccredited investor or purchaser. 24 6. "Financing transaction" means a transaction in which a licensed provider obtains 25 financing from a financing entity, including any secured or unsecured financing, 26 any securitization transaction, or any securities offering which either is registered 27 or exempt from registration under federal and state securities law. 28 "Fraudulent life settlement act" includes: <u>7.</u> 29 Any act or omission committed by any person that, knowingly and with intent 30 to defraud, for the purpose of depriving another of property or for pecuniary

"Insured" means the individual covered under the policy being considered for sale 8 in a life settlement contract. 9 "Life expectancy" means the arithmetic mean of the number of months the insured 9. 10 under the life insurance policy to be settled can be expected to live as determined 11 by a life expectancy company considering medical records and appropriate 12 experiential data. 13 <u>10.</u> "Life insurance producer" means any person licensed in this state as a resident or 14 nonresident insurance producer that has received qualification or authority for life 15 insurance coverage or a life line of coverage pursuant to chapter 26.1-26. 16 <u>11.</u> "Life settlement contract" means a written agreement entered between a provider, 17 or any affiliate of the provider, and an owner establishing the terms under which 18 compensation or anything of value will be paid, which compensation or thing of 19 value is less than the expected death benefit of the insurance policy or certificate, 20 in return for the owner's present or future assignment, transfer, sale, devise, or 21 bequest of the death benefit or ownership of any portion of an insurance policy or 22 certificate of insurance for compensation; provided, however, that the minimum 23 value for a life settlement contract must be greater than a cash surrender value or 24 accelerated death benefit available at the time of an application for a life settlement 25 contract. The term includes the transfer for compensation or value of ownership or 26 beneficial interest in a trust or other entity that owns such policy if the trust or other 27 entity was formed or availed of for the principal purpose of acquiring one or more 28 life insurance contracts, which life insurance contract insures the life of an 29 individual residing in this state. 30 "Life settlement contract" also includes: a.

"Related provider trust" means a titling trust or other trust established by a licensed 20 provider or a financing entity for the sole purpose of holding the ownership or 21 beneficial interest in purchased policies in connection with a financing transaction. 22 In order to qualify as a related provider trust, the trust must have a written 23 agreement with the licensed provider under which the licensed provider is 24 responsible for ensuring compliance with all statutory and regulatory requirements 25 and under which the trust agrees to make all records and files relating to life 26 settlement transactions available to the insurance department as if those records 27 and files were maintained directly by the licensed provider. 28 <u>21.</u> "Settled policy" means a life insurance policy or certificate that has been acquired 29 by a provider pursuant to a life settlement contract. 30 22. "Special purpose entity" means an organization formed solely to provide either 31 directly or indirectly access to institutional capital markets for a financing entity or

- provider; or in connection with a transaction in which the securities in the special purpose entity are acquired by the owner or by a "qualified institutional buyer" as defined in rule 144 promulgated under the federal Securities Act of 1933, as amended [15 U.S.C. 77a et seq.]; or the securities pay a fixed rate of return commensurate with established a set-backed institutional capital markets.
 - 23. "Stranger-originated life insurance" is a practice or plan to initiate a life insurance policy for the benefit of a third-party investor that at the time of policy origination has no insurable interest in the insured. Stranger-originated life insurance practices include cases in which life insurance is purchased with resources or guarantees from or through a person that at the time of policy inception could not lawfully initiate the policy on its own, and where at the time of inception there is an arrangement or agreement, whether verbal or written, to directly or indirectly transfer the ownership of the policy or the policy benefits or both to a third party.

 Trusts that are created to give the appearance of insurable interest, and are used to initiate policies for investors, violate insurable interest laws and the prohibition against wagering on life. Stranger-originated life insurance arrangements do not include those practices set forth in subdivision b of subsection 11.
 - 24. "Terminally ill" means having an illness or sickness that can reasonably be expected to result in death in twenty-four months or less.

26.1-33.4-02. Licensing and bonding requirements.

- 1. A person, wherever located, may not act as a provider or broker with an owner or multiple owners who is a resident of this state without first having obtained a license from the commissioner. If there is more than one owner on a single policy and the owners are residents of different states, the life settlement contract must be governed by the law of the state in which the owner having the largest percentage ownership resides or, if the owners hold equal ownership, the state of residence of one owner agreed upon in writing by all owners.
- 2. Application for a provider or broker license must be made to the commissioner by the applicant on a form prescribed by the commissioner, and the application must be accompanied by a fee in an amount established by the commissioner; provided, however, that the license and renewal fees for a provider license must be

- reasonable and that the license and renewal fees for a broker license may not

 exceed those established for an insurance producer, as such fees are otherwise

 provided for in this title.
 - 3. A life insurance producer who has been duly licensed as a resident insurance producer with a life line of authority in this state or the producer's home state for at least one year and is licensed as a nonresident producer in this state is deemed to meet the licensing requirements of this section and must be permitted to operate as a broker.
 - 4. Not later than thirty days from the first day of operating as a broker, the life insurance producer shall notify the commissioner that the broker is acting as a broker on a form prescribed by the commissioner, and shall pay any applicable fee to be determined by the commissioner. Notification must include an acknowledgement by the life insurance producer that the broker will operate as a broker in accordance with this chapter.
 - 5. The insurer that issued the policy that is the subject of a life settlement contract may not be responsible for any act or omission of a broker, provider, or purchaser arising out of or in connection with the life settlement transaction, unless the insurer receives compensation for the placement of a life settlement contract from the provider, purchaser, or broker in connection with the life settlement contract.
 - 6. An individual licensed as an attorney, certified public accountant, or financial planner accredited by a nationally recognized accreditation agency, who is retained to represent the owner, whose compensation is not paid directly or indirectly by the provider or purchaser, may negotiate life settlement contracts on behalf of the owner without having to obtain a license as a broker.
 - 7. Licenses may be renewed annually on the anniversary date upon payment of the periodic renewal fee. As specified in subsection 2, the renewal fee for a provider may not exceed a reasonable fee. Failure to pay the fee within the terms prescribed results in the automatic revocation of the license requiring periodic renewal.
 - 8. The term of provider license must be equal to that of a domestic stock life insurance company and the term of a broker license must be equal to that of an

1 insurance producer license. Licenses requiring periodic renewal may be renewed 2 on their anniversary date upon payment of the periodic renewal fee as specified in 3 subsection 2. Failure to pay the fees before the expiration of the renewal date 4 results in expiration of the license. 5 The applicant shall provide such information as the commissioner may require on 9. 6 forms prepared by the commissioner. The commissioner, at any time, may require 7 the applicant to fully disclose the identity of the applicant's stockholders (except 8 stockholders owning fewer than ten percent of the shares of an applicant whose 9 shares are publicly traded), partners, officers, and employees, and the 10 commissioner may refuse to issue the license in the name of any person if not 11 satisfied that any officer, employee, stockholder, or partner thereof who may 12 materially influence the applicant's conduct meets the standards of this chapter. 13 <u>10.</u> A license issued to a partnership, corporation, or other entity authorizes all 14 members, officers, and designated employees to act as a licensee under the 15 license, if those individuals are named in the application and any supplements to 16 the application. 17 11. The annual statement also must include the names of the insurance companies whose policies have been settled and the brokers that have settled said policies.

- 4. Records of all consummated transactions and life settlement contracts must be maintained by the provider for three years after the death of the insured and must be available to the commissioner for inspection during reasonable business hours.

Upon determining that an examination should be conducted, the commissioner shall issue an examination warrant appointing one or more examiners to perform the examination and instructing the examiners as to the scope of the examination. In conducting the examination, the examiner shall use methods common to the examination of any life settlement licensee and should use those guidelines and procedures set forth in an examiners' handbook adopted by a national organization.

If the owner is the insured, a written statement from a licensed attending 13 physician that the owner is of sound mind and under no constraint or undue 14 influence to enter into a settlement contract; and A document in which the insured consents to the release of the insured's 15 b. 16 medical records to a provider, settlement broker, or insurance producer and, if 17 the policy was issued less than two years from the date of application for a 18 settlement contract, to the insurance company that issued the policy. 19 The insurer shall respond to a request for verification of coverage submitted by a 2. 20 provider, settlement broker, or life insurance producer not later than thirty calendar 21 days from the date the request is received. The request for verification of 22 coverage must be made on a form approved by the commissioner. The insurer 23 shall complete and issue the verification of coverage or indicate in which respects 24 it is unable to respond. In its response, the insurer shall indicate whether, based 25 on the medical evidence and documents provided, the insurer intends to pursue an 26 investigation at this time regarding the validity of the insurance contract. 27 3. Before or at the time of execution of the settlement contract, the provider shall 28 obtain a witnessed document in which the owner consents to the settlement 29 contract, represents that the owner has a full and complete understanding of the 30 settlement contract, that the owner has a full and complete understanding of the 31 benefits of the policy, acknowledges that the owner is entering into the settlement

- contract freely and voluntarily, and, for persons with a terminal or chronic illness or condition, acknowledges that the insured has a terminal or chronic illness and that the terminal or chronic illness or condition was diagnosed after the policy was issued.
 - 4. The insurer may not unreasonably delay effecting change of ownership or beneficiary with any life settlement contract lawfully entered in this state or with a resident of this state.
 - 5. If a settlement broker or life insurance producer performs any of these activities required of the provider, the provider is deemed to have fulfilled the requirements of this section.
 - If a broker performs the verification of coverage activities required of the provider,
 the provider is deemed to have fulfilled the requirements of subsection 1 of section
 26.1-33.4-08.
 - 7. Within twenty days after an owner executes the life settlement contract, the provider shall give written notice to the insurer that issued that insurance policy that the policy has become subject to a life settlement contract. The notice must be accompanied by the documents required by subdivision b of subsection 1 of section 26.1-33.4-09.
 - 8. All medical information solicited or obtained by any licensee must be subject to the applicable provision of state law relating to confidentiality of medical information if not otherwise provided in this chapter.
 - 9. All life settlement contracts entered in this state must provide the owner with a right to rescind the contract before the earlier of sixty calendar days after the date upon which the life settlement contract is executed by all parties or thirty calendar days after the life settlement proceeds have been sent to the escrow agent by or on behalf of the provider as provided in subsection 11. Rescission by the owner may be conditioned upon the owner giving notice and repaying to the provider within the rescission period all proceeds of the settlement and any premiums, loans, and loan interest paid by or on behalf of the provider in connection with or as a consequence of the life settlement. If the insured dies during the rescission period, the life settlement contract is deemed to have been rescinded, subject to

repayment to the provider or purchaser of all life settlement proceeds and any premiums, loans, and loan interest that have been paid by the provider or purchaser, within sixty calendar days of the death of the insured. In the event of any rescission, if the provider has paid commissions or other compensation to a broker in connection with the rescinded transaction, the broker shall refund all the commissions and compensation to the provider within five business days following receipt of written demand from the provider, which demand must be accompanied by either the owner's notice of rescission if rescinded at the election of the owner or notice of the death of the insured if rescinded by reason of the death of the insured within the applicable rescission period.

- Within three business days after receipt from the owner of documents to effect the transfer of the insurance policy, the provider shall pay the proceeds of the settlement to an escrow or trust account managed by a trustee or escrow agent in a state or federally chartered financial institution pending acknowledgment of the transfer by the issuer of the policy. The trustee or escrow agent must be required to transfer the proceeds due to the owner within three business days of the later to occur of the expiration of any then remaining rescission period or the escrow agent's receipt of the acknowledgment of the properly completed transfer of ownership, assignment, or designation of beneficiary from the insurance company.
- 11. Failure to tender the life settlement contract proceeds to the owner by the date disclosed to the owner renders the contract voidable by the owner for lack of consideration until the time the proceeds are tendered to and accepted by the owner. A failure to give written notice of the right of rescission tolls the right of rescission until sixty days after the written notice of the right of rescission has been given.
- 12. Any fee paid by a provider, party, individual, or an owner to a broker in exchange for services provided to the owner pertaining to a life settlement contract must be computed as a percentage of the offer obtained, not the face value of the policy.

 This section does not prohibit a broker from reducing such broker's fee below this percentage if the broker so chooses.

1 The broker shall disclose to the owner anything of value paid or given to a broker 13. 2 which relates to a life settlement contract. 3 It is a violation of this chapter for any person to enter a life settlement contract at 14. 4 any time before or at the time of the application for or issuance of a policy that is 5 the subject of a life settlement contract or within a five-year period commencing 6 with the date of issuance of the insurance policy or certificate unless the owner 7 certifies to the provider or the provider otherwise conclusively shows that one or 8 more of the following conditions have been met within the five-year period: 9 a. In the event of a willful violation of this chapter, the trial court may award statutory damages in addition to actual damages in an additional amount up to three times the actual damage award. The provisions of this chapter may not be waived by agreement. A choice of law provision may not be utilized to prevent the application of this chapter to any settlement in which a party to the settlement is a resident of this state. 26.1-33.4-15. Penalties. 1. It is a violation of this chapter for any person, provider, broker, or any other party

- related to the business of life settlements to commit a fraudulent life settlement act.
- For criminal liability purposes, a person that commits a fraudulent life settlement <u>2.</u> act is guilty of committing insurance fraud.
- <u>3.</u> The commissioner may levy a civil penalty not exceeding fifty thousand dollars per violation and the amount of the claim for each violation upon any person, including those persons and their employees licensed pursuant to this chapter, who is found to have committed a fraudulent life settlement act or violated any other provision of this chapter.
- The license of a person licensed under this chapter which commits a fraudulent life settlement act must be revoked.
- **26.1-33.4-16.** Unfair trade practices. A violation of this chapter is considered an unfair trade practice pursuant to state law and subject to the penalties provided by state law.
