- 1 A BILL for an Act to amend and reenact section 26.1-36-37.2 of the North Dakota Century
- 2 Code, relating to disclosure of accident and health insurance loss ratios.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. AMENDMENT.** Section 26.1-36-37.2 of the North Dakota Century Code 5 is amended and reenacted as follows:

- 6 26.1-36-37.2. Loss ratios Rules <u>- Disclosure</u>.
- For all policies providing hospital, surgical, medical, or major medical benefit, an
  insurance company, a nonprofit health service corporation, a fraternal benefit
  society, and any other entity providing a plan of health insurance or health benefit
  subject to state insurance regulation shall return benefits to group policyholders in
  the aggregate of not less than seventy percent of premium received and to
  individual policyholders in the aggregate of not less than fifty-five percent of
  premium received.
- 14<u>2.</u>The commissioner shall adopt rules to establish these minimum standards on the15basis of incurred claims experienced and earned premiums for the entire period for16which rates are computed to provide coverage in accordance with accepted17actuarial principles and practices. This The loss ratio limits under this section does18do not apply to any contract or plan of insurance that provides exclusively for19accident, disability income insurance, specified disease, hospital confinement20indemnity, or other limited benefit health insurance.
