4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the state water commission for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

18 SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO

- 19 SIXTY-SECOND LEGISLATIVE ASSEMBLY. The following amounts reflect the one-time
- 20 funding items approved by the sixtieth legislative assembly for the 2007-09 and are not a part
- 21 of the entity's base budget for the 2009-11 biennium:

SECTION 3. APPROPRIATION - FEDERAL FISCAL STIMULUS FUNDS -

ADDITIONAL FUNDING APPROVAL. There is appropriated out of any federal funds made available to the state under the federal American Recovery and Reinvestment Act of 2009, not otherwise appropriated, the sum of \$12,000,000, or so much of the sum as may be necessary, to the state water commission for the purpose of providing funding for the southwest pipeline project, for the period beginning with the effective date of this Act and ending June 30, 2011.

The state water commission may seek emergency commission and budget section approval under chapter 54-16 for authority to spend any additional federal funds received under the federal American Recovery and Reinvestment Act of 2009 in excess of the amounts appropriated in this section, for the period beginning with the effective date of this Act and ending June 30, 2011.

Any federal funds appropriated under this section are not a part of the agency's 2011-13 base budget. Any program expenditures made with these funds will not be replaced with state funds after the federal American Recovery and Reinvestment Act of 2009 funds are no longer available.

SECTION 4. SOVEREIGN LANDS ENFORCEMENT GRANT. The administrative and support services line item in section 1 of this Act includes \$200,000 from the general fund that the state water commission shall provide as a grant to the game and fish department for law enforcement activities on sovereign lands in the state, for the biennium beginning July 1, 2009, and ending June 30, 2011.

SECTION 5. ADDITIONAL INCOME - APPROPRIATION. In addition to the amounts included in the estimated income line item in section 1 of the Act, any additional amounts in the resources trust fund and water development trust fund that become available are appropriated to the state water commission for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2009, and ending June 30, 2011.

SECTION 6. GRANTS - WATER-RELATED PROJECTS - CARRYOVER

AUTHORITY. Section 54-44.1-11 does not apply to funding for grants or water-related projects included in the water and atmospheric resources line item in section 1 of this Act. However, this exclusion is only in effect for two years after June 30, 2011. Any unexpended funds appropriated from the resources trust fund after that period has expired must be transferred to

1 the resources trust fund and any unexpended funds appropriated from the water development 2 trust fund after that period has expired must be transferred to the water development trust fund. 3 SECTION 7. LEGISLATIVE INTENT - FARGO FLOOD CONTROL. It is the intent of 4 the sixty-first legislative assembly that a total of \$75,000,000 be committed by the state as the 5 state cost-share for Fargo flood control, of which \$45,000,000 is provided for the biennium beginning July 1, 2009, and ending June 30, 2011, in the water and atmospheric resources line 6 7 item in section 1 of this Act. 8 SECTION 8. FARGO FLOOD CONTROL EXPENDITURES - EXEMPTION. Funds 9 spent by the state water commission for Fargo flood control during the 2009-11 biennium may 10 be used only for land purchases and construction and may not be used for administration, 11 engineering, legal, planning, or other similar purposes. Any funds allocated by the state water 12 commission for Fargo flood control of up to \$45,000,000 for the 2009-11 biennium which are 13 not spent by June 30, 2011, are not subject to section 54-44.1-11 and must be continued into 14 the next or subsequent bienniums and may be expended only for Fargo flood control projects. 15 SECTION 9. LEGISLATIVE INTENT - STATE WATER COMMISSION PROJECTS. It 16 is the intent of the sixty-first legislative assembly that of the funds appropriated in the water and 17 atmospheric resources line item in section 1 of this Act, the state water commission provide 18 funding for the following projects, for the biennium beginning July 1, 2009, and ending June 30, 19 2011: 20 Digital elevation mapping project \$300,000 21 Enhancement of the local share of funding \$100,000 22 for the Renwick dam in Pembina County 23 \$500.000 Evaluate, in conjunction with state, local, 24 and federal officials and entities, 25 long-term flood control solutions in 26 the Red River valley 27 Michigan spillway in Nelson County \$500,000 28 SECTION 10. LEGISLATIVE INTENT - NELSON COUNTY WATER RESOURCE 29 **DISTRICT.** It is the intent of the sixty-first legislative assembly that the state water commission 30 assist the Nelson County water resource district by providing engineering and permitting 31 services, for the biennium beginning July 1, 2009, and ending June 30, 2011.

1 SECTION 11. BANK OF NORTH DAKOTA LOAN AUTHORIZATION -

- 2 **APPROPRIATION.** The state water commission may borrow the sum of \$22,000,000, or so
- 3 much of the sum as may be necessary, from the Bank of North Dakota, which is appropriated
- 4 for the purpose of emergency flood control and other critical water needs, for the biennium
- 5 beginning July 1, 2009, and ending June 30, 2011.
- 6 **SECTION 12. EMERGENCY.** Section 3 of this Act is declared to be an emergency
- 7 measure.
