- 1 A BILL for an Act authorizing the state of North Dakota acting through job service North Dakota
- 2 to sell certain properties.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. Sale of property by job service North Dakota.** The state of North
- 5 Dakota acting through job service North Dakota may sell and convey Lot Six (6), Block Two (2),
- 6 of Replat of Block One (1) of Westgate Village in the City of Fargo, Cass County, North Dakota.
- 7 Job service North Dakota may cause this property to be sold in the manner prescribed by
- 8 sections 54-01-05.1 and 54-01-05.2. The provisions of section 54-01-05.5 do not apply to the
- 9 sale and conveyance authorized by this Act. Net proceeds from the sale must be used as
- 10 <u>authorized and directed by law.</u>
- 11 **SECTION 2.** Sale of property by job service North Dakota. The state of North
- 12 Dakota acting through job service North Dakota may sell and convey a tract of land located in
- 13 the Southwest Quarter of the Southwest Quarter of Section Thirteen, Township One Hundred
- 14 Fifty-seven North, Range Fifty-three West, Fifth P.M., more accurately described as follows:
- 15 commencing at a point seventy-five feet North and one hundred thirty-nine and nine-tenths feet
- 16 East of the Southwest corner of said Section Thirteen; thence continuing South 90 degrees 00
- 17 minutes 00 seconds East, and parallel to the South line of Section Thirteen, one hundred fifty
- 18 <u>feet; thence North 0 degrees 05 minutes 36 seconds East, two hundred eighty-three feet;</u>
- 19 thence North 90 degrees 00 minutes 00 seconds West, one hundred fifty feet; thence South 0
- 20 degrees 05 minutes 36 seconds West, two hundred eighty-three feet, to the point of beginning;
- 21 now known as part of Lot 1, Block 1, State School First Addition, to the City of Grafton. Said
- 22 tract of land contains 0.97 acres more or less. Job service North Dakota may cause this
- 23 property to be sold in the manner prescribed by sections 54-01-05.1 and 54-01-05.2. The

- 1 provisions of section 54-01-05.5 do not apply to the sale and conveyance authorized by this
- 2 Act. Net proceeds from the sale must be used as authorized and directed by law.
